Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

(1) Description of Plan

The following description of the SolomonEdwardsGroup, LLC 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of SolomonEdwardsGroup, LLC, and Subsidiaries (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. To participate in the Plan, all employees must be 21 years old. Temporary and non-temporary employees must complete 3 consecutive months of service to participate in the plan and be eligible to receive matching contributions. Excluded employees include union employees, leased employees, and non-resident aliens. Matching contributions will begin the first day of the next quarter (first, fourth, seventh, and tenth months) after meeting the eligibility requirements. The trustee of the Plan is responsible for plan oversight, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Participants may contribute up to 100% of their eligible compensation, as defined in the Plan, subject to the maximum amount allowable under the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make discretionary matching contributions to each participant's account as specified by the Plan. Contributions are subject to certain limitations. For the year ended December 31, 2024, the Company made a discretionary matching contribution of 25% of the first 6% of eligible compensation that a participant contributed to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching portion of the participants' accounts is based on years of service. A participant is 33% vested after one year of service, 67% vested after two years of service, and 100% vested after three years. The Company's contributions become fully vested upon death, permanent disability, or attainment of early retirement age of 55.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance; the loan must bear a reasonable interest rate. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or partial payment in accordance with plan provisions.

Additionally, certain in-service distributions are allowed under the Plan, including the withdrawal of all or any portion of a participant's elective deferral account and vested Company match account in the event of a hardship, as defined. Such a withdrawal may not exceed the amount required to meet the immediate financial need created by the hardship and is only available after the participant has obtained all available distributions, other than hardship distributions, and non-taxable loans available under the Plan. A participant is suspended from making any deferrals under the Plan for six months after the receipt of a hardship distribution.

Forfeited Accounts

Company contributions which do not vest prior to participant withdrawals are forfeited to the Plan and may be used to reduce employer discretionary matching contributions or to pay certain administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts total \$36,627 and \$1,009, respectively. During 2024, employer matching contributions to the Plan were reduced by \$2,743 from forfeited nonvested accounts.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value except for the benefit responsive insurance contract with is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment adviser and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recognized on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to employee contributions. The Plan distributed the year end excess contributions to the applicable participants prior to the subsequent September 15 deadline.

Payment of Benefits

Benefits are recorded when paid.

Expenses

All Plan expenses are paid from the Plan assets. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, employees of Steele Consulting, LLC became eligible to participate in the Plan. On March 14, 2025, assets of approximately \$7.3 million related to these participants were transferred into the Plan.

(3) Financial Information Certified by a Qualified Institution

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at fair value and contract value and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from the information certified as complete and accurate by Lincoln Financial Group Trust Company, Inc. (Lincoln), a qualified institution.

(4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codifications* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open end investments that are registered with the Securities and Exchange Commission. Registered investment companies are required to publish their daily net asset value (NAV) and to transact at that price. Registered investment companies held by the Plan are deemed to be actively traded.

There were no significant transfers among investment levels during the years ended December 31, 2024 and 2023.

(5) Related Party Transactions and Party-In-Interest Transactions

Lincoln provided certain plan recordkeeping and administrative services. Lincoln is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

The Plan is party to a plan expense agreement with Lincoln that provides for a Revenue Credit Program. The amounts in the Revenue Credit Program Account can be used to pay administrative expenses of the Plan or allocated to participant accounts.

The balance in the Revenue Credit Program Account at December 31, 2024 and 2023 is \$36 and \$14, respectively. These amounts are reported with investments at December 31, 2024 and 2023, as the funds are invested in the Plan's guaranteed interest account. During 2024, \$64,367 of other income was earned by the Plan related to this agreement and was used to pay administrative expenses. These transactions qualify as exempt party-in-interest transactions.

(6) Investment Contract with Insurance Company

The Plan has a fully benefit-responsive guaranteed investment contract with Lincoln National Life Insurance Company (Lincoln Life). Lincoln Life maintains the contributions in a general account. The account is credited with participant contributions plus earnings and charged for participant withdrawals and administrative expenses. The issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than the guaranteed minimum interest rate.

The annual crediting interest rate and average yield for the guaranteed interest account for the term of the contract is 1.0%

(7) Termination of Plan

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

(8) Tax Status

The Plan uses a prototype plan document sponsored by Lincoln Financial Group. Lincoln received an opinion letter from the IRS dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. The Plan document has been restated subsequent to the last determination letter. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(9) Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits.

(10) Nonexempt Transactions

During December 31, 2024, the Plan had uncorrected delinquent participant contributions totaling \$192. These employee contributions were withheld from participants' pays but were not remitted to the Plan's trust within the timeframe required by the DOL under plan asset rules. The delinquent employee contributions were remitted to the Plan's trust; however, the related lost earnings had not yet been remitted to the Plan as of December 31, 2024.
