Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of American Bank Employee Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the American Bank Employee Savings Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description or Plan Document for a more complete description of the Plan's provisions.

General and Eligibility: The Plan is a defined contribution employee savings plan that covers all employees of American Bank, N.A. (the Employer or Plan Sponsor), other than those working in a classification of employees covered by a collective bargaining agreement and nonresident aliens, who are age 18 or older. On November 1, 2020, the Plan was amended to exclude temporary and seasonal employees until they reach one year of service. An employee can enter the Plan on the first day of the month following sixty days of employment with the Plan Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions: Participant contributions to the Plan are made by employees within limitations stipulated in the Internal Revenue Code (IRC). Employees are automatically enrolled upon becoming eligible to participate in the Plan at a deferral rate of 3% of their pretax annual compensation as defined in the Plan document. Employees were permitted to change their contribution deferral rate at the beginning of each quarter or discontinue deferrals at any time. In February 2024, the Plan was amended to allow employees to change their contribution deferral rate at the beginning of each month. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Employer may make discretionary matching contributions and discretionary profit-sharing contributions to employees at the option of the Plan Sponsor's Board of Directors. These contributions are subject to certain IRS limitations. To be eligible for employer contributions, a participant must be employed at the end of the Plan year or have worked over 500 hours during the Plan year. The Plan also requires sixty days of service to be eligible for the employer matching contributions. For the year ended December 31, 2024, participants received discretionary employer matching contributions of 100% up to 4% of employee compensation contributed. There were no employer profit sharing contributions made to the Plan for the year ended December 31, 2024.

Rollovers: Participants may contribute amounts representing distributions from other qualified plans after approval from the Plan sponsor. Participants are fully vested in these amounts.

Participant Accounts: Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, the Employer's matching contributions, as well as allocations of any profit-sharing contributions and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant Investment Options: Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment options at any time directly through Newport Group, Inc., which is a party-in-interest to the Plan.

Notes Receivable from Participants: Participants may borrow up to 50% of their vested accounts in the form of a note with a minimum amount of \$1,000 and a maximum amount of \$50,000. Notes are secured by the balance in the participant's account and bear interest at prevailing market rates at the time the funds are borrowed. The term of the loans cannot exceed five years, except for loans to purchase a principal residence. At December 31, 2024, the interest rate on outstanding notes was between 4.25% and 9.50%. Principal and interest are paid ratably through payroll deductions and as of December 31, 2024, the notes receivable outstanding are due in various amounts through November 2048. A participant may only have one note outstanding at a time.

Vesting: Participants are immediately vested in their elective deferrals plus actual earnings thereon. Participants become 20% vested for discretionary employer matching and profit-sharing contributions and earnings thereon after one year of credited service and vest an additional 20% for each year of service thereafter until they are fully vested after completion of five years of service. A participant is entitled to 100% of his or her account balance upon death, disability, or the later of the date the participant attains age 65 or the fifth anniversary of participation in the plan.

Payment of Benefits: Upon termination of service, each participant can receive their vested account balance in one lump-sum payment or substantially equal installment payments. If a participant's vested balance is \$5,000 or less, the participant will receive a single distribution of their entire vested account balance. The Plan provides for the automatic rollover of vested participant balances above \$1, but less than \$5,000 into an individual retirement account if the participant does not elect to have the distribution paid directly to an eligible retirement plan in a direct rollover or to receive the distributions directly. Hardship withdrawals are also allowed, subject to the provisions specified in the Plan agreement. Active participants may also take distributions from the Plan upon attainment of age 59 ½.

Forfeitures: The nonvested portion of discretionary employer contributions can be used to offset plan administrative expenses or offset future employer contributions. During 2024, \$33,835 of unvested balances from terminated participants were added to the Plan's forfeiture account, and \$50,261 of forfeited employer contributions was used to offset employer contributions and Plan expenses. The remaining balances of forfeitures available to offset future employer contributions as December 31, 2024 and 2023 were \$6,248 and \$22,674, respectively.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (US GAAP).

Use of Estimates: The preparation of financial statements in conformity with US GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions: Participant contributions are recognized in the year withheld. Employer matching and profit-sharing contributions are recognized upon authorization and in the year the underlying compensation is recognized under the Plan. All participant and employer contributions are participant-directed. Participant contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction in contributions.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes net unrealized market appreciation or depreciation of investments and net realized gains and losses on the sale of investments during the period.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest is recorded on the accrual basis. Related fees are recorded as administrative expense and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023 as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. If a participant ceases to make loan payments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits: Benefits are recorded when paid.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the net appreciation (depreciation) reported by the Plan on the statement of changes in net assets available for benefits.

Risks and Uncertainties: The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, liquidity, credit risks, global pandemic and international conflicts. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE 3 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Newport Trust Company (the trustee of the Plan).

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability. In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy. Transfers between hierarchy measurement levels are recognized by the Plan as of the end of the reporting period.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments:

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trust Funds: The fair values of participation units held in collective trusts are based on the net asset values per unit (NAV) as reported by the fund managers. The NAV is used as a practical expedient to measure fair value. The collective trusts provide for daily redemptions by the Plan at reported NAV with no advance notice requirement. For Plan closure or transfer, the collective trusts provide no redemption restrictions or advance notification provisions to participants in the Plan.

*Investments measured at fair value using net asset value per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the hierarchy tables for such investments are intended to permit reconciliation of the fair value hierarchy to the investments at fair value line item presented in the statements of net assets available for benefits.

Changes in Fair Value: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may retire the transfer of investments from one fair value level to another. For the year ended December 31, 2024, there were no transfers in or out of level 3.

The following table sets forth an additional disclosure of the Plan’s investment in a collective investment trust, whose fair value is estimated using NAV per share (or its equivalent) as of December 31, 2024.

NOTE 5 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Plan Sponsor contributions.

NOTE 6 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in compliance with the Internal Revenue Code. US GAAP requires plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor (DOL) regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Newport Trust Company is the Plan’s trustee and recordkeeper and, therefore, the Plan’s payment of trustee and recordkeeping fees qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Employer. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Employer.

NOTE 9 – SUBSEQUENT EVENTS

Effective February 1, 2025, the Plan transferred its provider for recordkeeping, trustee, and custodian services to Charles Schwab Trust Bank. This transfer did not have an impact on the Plan's financial statements as of and for the year ended December 31, 2024.

On July 18, 2025, Prosperity Bancshares, Inc., the parent company of Prosperity Bank, and American Bank Holding Corporation, the parent company of the Plan Sponsor, announced the signing of a definitive merger agreement pursuant to which Prosperity Bank will acquire the Plan Sponsor. The merger, which has been unanimously approved by the Boards of Directors of both companies, is expected to close in the fourth quarter of 2025 or the first quarter of 2026. Management has determined this event did not have an impact on the Plan's financial statements as of and for the year ended December 31, 2024.
