Basis for Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year from the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 – DESCRIPTION OF THE PLAN

General: The following brief description of the TestEquity 401(k) Savings Plan (the Plan) is provided for general information purposes only. The Plan is sponsored by TestEquity LLC (the Company). Participants should refer to the Plan document for more complete information. The Company's corporate offices are in Texas.

The Plan was effective January 1, 1988, restated effective January 1, 2022, and is a defined contribution plan available to all employees of the Company who have attained age 18, except nonresident aliens. There is no service requirement for Plan eligibility, and eligible employees may enter the Plan immediately on the employment commencement date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The purpose of the Plan is to encourage the Company's employees to save and invest, systematically, a portion of their current compensation so that they and their families may have a source of additional income upon their retirement, or in the event of death.

Plan Merger: On December 4, 2024, the Plan Sponsor approved the merger of the Plan into Lawson Products, Inc. and Certain Affiliates Retirement Plan effective January 1, 2025. The Lawson Products, Inc. and Certain Affiliates Retirement Plan was renamed the "Distribution Solutions Group Retirement Plan" effective January 1, 2025 (the "DSG Plan"). The Company adopted the DSG Plan as a participating employer effective January 1, 2025. Additionally, effective December 31, 2024, the Plan is frozen such that no additional employees shall become eligible to participate in the Plan after such date and no contributions shall be made to the Plan for any period after that date. Participants were notified in advance of the plan freeze, the upcoming merger into the DSG Plan, and the associated blackout period. During the blackout period, participants retained full access to view their account balances in accordance with the terms of the Plan. All transactions, including contributions, distributions, and investment elections, were temporarily suspended during the blackout period. Full account activity resumed under the DSG Plan once the asset transfer finalized and the blackout period has concluded.

In anticipation of the plan merger, \$27,814,275 of Plan investments were valued and liquidated on December 31, 2024 and assets were held by a broker as of December 31, 2024. These assets are reflected as due from broker as of December 31, 2024 and were remitted to the DSG Plan on January 2, 2025. One investment for \$435,975 was transferred in kind prior to the effective date and is reflected on the statement of net assets available for benefits as assets held at Lawson Products, Inc. and Certain Affiliates Retirement Plan prior to merger.

Contributions: Participants may contribute up to 75% of their annual pre-tax compensation, as defined by the Plan. In addition, participants may contribute designated Roth (after tax) contributions. All contributions are subject to limitations on annual additions imposed by the Internal Revenue Code (the Code), as defined in the Plan document. Eligible participants may make rollover contributions to the Plan.

Participants who are eligible to make salary deferral contributions under the Plan and who have attained age 50 before the close of the Plan year may make catch-up contributions in accordance with, and subject to, the limitations imposed by the Code.

The Company shall make matching contributions to the Plan. The Company makes safe harbor matching contributions equal to one dollar for each dollar that each participant contributes up to 3% of compensation, and an additional contribution equal to fifty cents for each dollar that each participant has elected to defer in excess of 3% of compensation, not to exceed 5% of compensation. This safe harbor matching contribution is 100% vested. For purposes of calculating the safe harbor matching contribution, participant compensation and deferrals are determined on a payroll period basis. For the year ended December 31, 2024, the Company made matching contributions of \$923,929.

Participant Accounts: Each participant's account is credited with the participant's contributions and allocations of: (a) the Company's contributions; and (b) Plan earnings in accordance with the Plan document. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants with an hour of service on or after August 1, 2020, are immediately vested in their voluntary and matching contributions plus actual earnings thereon. Individuals terminated prior to August 1, 2020, were immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contributions, plus actual earnings thereon for individuals terminated prior to August 1, 2020, is as follows:

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Payment of Benefits: Participants withdrawing during the year for reasons of service, disability, retirement, death, or termination are entitled to their vested account balances. Benefits are distributed in the form of rollovers or lump-sum payments. If withdrawing participants are not entitled to their entire account balances, the amounts not received are forfeited.

Certain in-service withdrawals are allowed. A participant may also elect to withdraw all or a portion of his/her vested account balance while employed after reaching age 59 ½. A participant may receive a hardship distribution from salary reduction contributions if the distribution is: (1) on account of uninsured medical expenses incurred by the participant, his/her spouse, or dependents; (2) to purchase (excluding mortgage payments) a principal residence of the participant; (3) for the payment of post- secondary tuition expenses; (4) needed to prevent eviction of the participant from his/her principal residence or foreclosure upon the mortgage of the participant's principal residence; (5) payments for burial or funeral expenses for the participant's parent, spouse, children, or dependents; and (6) for payments to repair a principal residence that would qualify for a casualty loss deduction under the Code.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balances. Loan terms range up to five years, or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with market rates for similar loans. All loans are covered by demand notes and are repayable through payroll deductions.

Defaulted loans are accounted for as deemed distributions which are considered distributions for tax purposes. These deemed distributions are not treated as a distribution in the period of default and will remain as a note receivable until offset or paid under the Company's loan policy. As of December 31, 2024 and 2023, deemed distributions included in notes receivable from participants was \$102,446 and \$100,556, respectively.

Forfeitures: Forfeited balances of terminated participants' non-vested accounts are first used to pay the Plan's administrative expenses and then used to reduce the Company's payment of matching contributions. As of December 31, 2024 and 2023, there were approximately \$126,000 and \$144,000 in unused forfeitures, respectively.

Administrative Expenses: Employees of the Company perform certain administrative functions with no compensation from the Plan. Certain Plan expenses incidental to the administration of the Plan, including fees of the trustee and custodian, may be paid by the Plan. Plan expenses not paid by the Plan are paid by the Company and are not reflected in the accompanying financial statements.

The Plan entered an agreement with Empower Trust Company, LLC ("Empower Trust"), formerly known as Great-West Trust Company, LLC and its affiliates, whereby Empower Trust is required to make annual contributions to the Plan Expense Account ("PEA") in an amount equal to \$23,000 plus a percentage of the Plan's assets. The net appreciation of investments is inclusive of these contributions. The funds in the PEA may be used to pay Plan administrative expenses during the year.

Plan Termination: Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates: The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

Investments Valuation and Income Recognition: The Plan's investments, other than fully benefit responsive investment contracts, are reported at fair value as further described in Note 4 and 5. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Contributions: Contributions from the Company and participants are accrued as they become obligations of the Company, as determined by the plan administrator, and in the period in which they are deducted, in accordance with salary deferral agreements. Refunds of excess participant deferral contributions may be required to satisfy the relevant nondiscrimination provisions of the Plan. Such refunds are accrued as a liability and reduction in contributions in the Plan year in which the excess deferrals were made to the Plan.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments held at December 31, 2024 and 2023 and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC ("Empower Trust") and Empower Annuity Insurance Company of America ("Empower Annuity") (the trustee and custodian of the Plan). Notes receivable from participants held at December 31, 2023 were included in Empower Trust's certification. Other assets as of December 31, 2024 such as receivables, due from broker, notes receivable from participants and assets held by Lawson Products, Inc. Retirement Plan prior to merge of December 31, 2024 were not covered by the certification.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy. The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

As of December 31, 2024, in anticipation of the plan merger described in Note 1, with the exception of one mutual fund held by Lawson Products, Inc. Retirement Plan, all investments measured at fair value were liquidated and funds were held by the Plan's broker. As a result, no investments were held by the Plan at fair value as of year-end. The assets held at Lawson Products, Inc. Retirement Plan prior to merger as of December 31, 2024 are valued at fair value and include one mutual fund which is valued as described above (level 1).

NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds a traditional guaranteed investment contract through a group annuity contract supported by the general assets of Empower Annuity Insurance Company of America ("Empower Annuity"), formerly known as Great-West Life & Annuity Insurance Company. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value of \$2,020,449 and \$3,627,142 at December 31, 2024 and 2023, respectively. Contract value is the relevant measure for a fully benefit-responsive investment contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The interest crediting rate is updated quarterly based upon contract provisions, and it may not be less than 0%.

The Plan's investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by the Company, and certain other Company-initiated events that result in distributions exceeding a set amount. The contract limits the circumstances under which the issuer may terminate the contract. Examples of circumstances which would allow the issuer to terminate the contract include the Plan's loss of its qualified status, uncured material breaches of responsibilities, or material and adverse changes to the provisions of the Plan. The Plan merger discussed in Note 1 that is effective January 1, 2025 is not expected to cause distributions from the contract to be payable at an amount below contract value. The contract includes a put option, which was initiated by the plan sponsor, that allows the plan sponsor to withdraw all contract balances at book value (principal plus credited interest) upon termination, subject to the insurer's right to defer payment for up to 12 months following written notice.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or relatives of such persons.

The Plan invests in a group annuity contract managed by Empower Annuity Insurance Company (“Empower Annuity”). Transactions in such investments, as well as loans made to participants, qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. The Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA, which are exempt from the prohibited transaction rules.

NOTE 7 – TAX STATUS

Effective January 1, 2022, the Plan adopted a Non-Standardized Pre-Approved Profit Sharing/Money Purchase Plan with Cash or Deferred Arrangement (CODA), in which the Internal Revenue Service (IRS) issued an opinion letter dated June 30, 2020, stating that the Plan, as then designed, was in compliance with the applicable requirements of the Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Management evaluated subsequent events for the Plan through October 15, 2025, the date the financial statements were available to be issued, and noted there was no impact on the Plan's net assets available for benefits or its changes in net assets available for benefits.

Effective January 1, 2025, the Plan merged into the DSG Plan as further disclosed in Note 1. Participants of the Plan became participants of the DSG Plan effective January 1, 2025.
