INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Spectrum Laboratory Products, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. DESCRIPTION OF PLAN

The following brief description of Spectrum Laboratory Products, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by Spectrum Laboratory Products, Inc. (the Company) under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. All employees who have completed three months of service are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each year, participants may contribute a certain amount of their annual compensation as defined in the Plan. Employees are automatically enrolled into the Plan at a rate of 5% of compensation. Participants who have attained age 50 before the Plan year-end are also eligible to make additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company may make matching contributions related to participant contributions to the Plan. In addition, the Company may make profit sharing contributions to participants who have completed one year of service, and qualified nonelective employer contributions, if needed. Employer matching contributions are 100% of participants' deferral contributions up to 5% of total compensation. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and the related Company matching contribution, and allocations of (a) any additional Company contribution, (b) forfeitures of terminated participants' nonvested accounts, if available, and (c) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant-Directed Investments

Upon enrollment in the Plan, a participant can direct the investment of his or her account balance to the investment funds offered under John Hancock Trust Company, LLC, the Trustee, which have various investment objectives and risks.

Vesting

Participants are immediately vested in their contributions and employer match plus actual earnings thereon. Vesting in the non-elective contributions is based on years of service. A Participant is 100% vested after four years of credited service. Participants are fully vested upon: completion of years of credited service, attaining age 65, total and permanent disability, or death while employed by the Company.

Notes Receivable from Participants

The Plan allows participants to borrow from their fully vested accounts. The minimum loan is \$1,000 and the maximum loan is 50% of the participant's vested account balance up to \$50,000. A loan normally has a maximum term of 5 years unless funds are used to purchase a principal residence whereby the maximum loan term is 20 years. The loans are secured by the balance in the participant's account and bear interest at an interest rate commensurate with the prevailing interest rate charged on similar loans at the time the loan is processed. At December 31, 2024, participant loans have interest rates that range between 4.25% to 9.50%. Principal and interest are normally paid ratably through payroll deductions.

Forfeited Accounts

At December 31, 2024 and 2023, there were no forfeited nonvested account balances. Forfeited nonvested accounts, will be used to reduce future employer contributions.

Payment of Benefits

On termination of employment, a participant may elect to receive a lump-sum distribution equal to the value of the participants' vested account balance. The Plan also allows in-service withdrawals under certain conditions.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in the employer contributions portion of their accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING PRINCIPLES

Basis of Accounting

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America, using the accrual method of accounting.

2. SUMMARY OF SIGNIFICANT ACCOUNTING PRINCIPLES (Continued)

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for disclosures regarding fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Management fees and operating expenses charged to the Plan for investments in the mutual funds and stable value common/collective trust funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants

Notes receivable from participants related to participant loans are stated at the unpaid principal balance. Interest income associated with the notes receivable are recorded when interest payments are received, usually every two months. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company, at its option, and are excluded from these financial statements. Fees related to specific participant transactions, such as for participant loans, are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

3. FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE OR CUSTODIAN

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, which include investments and notes receivable from participants at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, dividends and capital gains, and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock Trust Company, LLC (John Hancock), the Trustee of the Plan, in accordance with Section 2520.103-5(c) of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

4. INVESTMENTS AND FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy with the related inputs to the valuation methodology are described as follows:

Level 1 - Quoted prices (unadjusted) in active markets for identical assets that the Plan has the ability to access.

Level 2 - Significant other observable (directly or indirectly) inputs, including quoted prices for similar assets in active markets or in inactive markets and other market observable inputs such as interest rate, credit risks, etc.

Level 3 - Significant unobservable inputs, including the Plan's own assumptions in determining the fair value of investments.

Following is a description of the valuation methodologies used for the Plan's investment assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable value common/collective trust: The Plan's stable value fund is a common/collective trust which invests in fully benefit-responsive investment contracts and is valued at the net asset value of the units of the common/collective trust. The net asset value (NAV) is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value. Participant transactions (purchases and sales) may occur daily. The stable value common/collective trust fund has no unfunded commitments and has a daily redemption frequency; however, transfers into a competing fund are restricted for 90 days due to an equity wash provision.

Stable value common/collective trust (continued): Were the Plan to initiate a full redemption of the common/collective trust fund, normally the funds are received within 60 days, but the provider reserves the right to temporarily delay withdrawal from the trust in order to ensure that security liquidations will be carried out in an orderly business manner.

5. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by John Hancock, Trustee. Investment management fees are paid to the Trustee and are included in net appreciation in fair value of investments. The Plan paid fees to the Trustee related to recordkeeping services and to outside investment advisors, which totaled \$83,510 in 2024. In addition, the Plan sponsor has negotiated a credit from John Hancock to offset certain fees which have been reflected as other income and totaled \$3,136 in 2024.

The above transactions, including the notes receivable from participants, qualify as allowable party-in-interest transactions for which there are statutory exemptions.

6. TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the trustees believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan takes an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. DELINQUENT PARTICIPANT CONTRIBUTIONS

During 2023, plan management identified one payperiod including participant contributions and loan repayments that was not remitted to the Plan on a timely manner due to a payroll system failure. This payperiod was remitted to the Plan in 2024. The Company will calculate and remit the associated lost earnings on the delinquent contributions in 2025. These delinquent participant contributions have been reported in the supplemental Schedule of Delinquent Participant Contributions for the Year Ended December 31, 2023.

9. SUBSEQUENT EVENTS

In preparing these financial statements, the Plan administrator has evaluated subsequent events and transactions for potential recognition or disclosure through October 9, 2025, the date the financial statements were available to be issued.
