NOTE 1 - DESCRIPTION OF THE PLAN

Southeastern Archaeological Research, Inc. 401(K) Plan (the "Plan") is a defined contribution plan adopted by Southeastern Archaeological Research, Inc. (the Plan Sponsor). The plan was originally established by the Company effective January 1, 2004, and was most recently restated effective January 1, 2022. The plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The summary of significant provisions of the Plan presented below provides general information. Participants should refer to the terms of the plan document for a more complete description of the Plan's provisions.

Administration: The Plan is administered by the 401(k) Investment Committee which is composed of employees of the Company.

Eligibility: Employees of the Company who have attained the age of 21 and completed three months of service are eligible to participate in the Plan. The entry date is the first day of the next plan year quarter following the date eligibility requirements are satisfied.

Contributions: Each year, participants may contribute up to the maximum amount of annual compensation allowed by law, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan.

For certain eligible employees the Plan takes advantage of certain rules that provide alternative methods to pass the nondiscrimination tests required of 401(k) plans. Pursuant to these rules, the Sponsor has elected to provide a safe harbor contribution equal to 100% of a participants' salary deferrals that do not exceed 3% of their compensation. The Company made a Safe Harbor nonelective contribution of 3% of a participant's eligible compensation totaling \$358,369.

The Company may also make discretionary matching contributions. At the Company's discretion, matching contributions may be made on behalf of each participant equal to a percentage of the elective deferrals made by the participant. Additionally, the Company may make a discretionary nonelective contribution. the Company may make annual discretionary matching and/or profit sharing contributions. For 2024, the Company made discretionary matching contributions of 50% up to 4% of compensation of the amount that a participant contributed to the Plan totaling \$168,793. In addition, the Company made profit sharing contributions totaling \$120,116. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant Accounts: Each participant's account is credited with the participant's contributions, an allocation of the Company's contributions, Plan earnings and losses and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Vesting: Participants are immediately vested in their contributions and the Company Safe Harbor nonelective contribution plus actual earnings thereon. Vesting in the Company's remaining contribution portion of their accounts is based on years of continuous service. A participant becomes 20% vested after two years of service and increases ratably until fully vested after six years. Participants are vested immediately in their elective deferrals, including catch-up and after-tax contributions, qualified nonelective contributions, and rollover contributions, plus actual earnings or losses thereon. Matching and profit sharing contributions and earnings are 100% vested after six years of service following a graded scale. Participants become fully vested in all accounts in the event of death, disability, or attainment of normal retirement age while actively employed.

Payment of Benefits: Participants may receive a distribution of the vested portion of some or all of their accounts in the Plan upon termination of employment, normal retirement, disability, or death. If the vested account does not exceed \$5,000, then the vested account balance is distributed to the participant in a single lump-sum payment. If the vested account balance exceeds \$5,000, the participant must consent to any distribution before it is made and elect to receive the distribution in a single lump-sum payment or partial withdrawals.

Participants may also receive a distribution from the Plan from certain accounts prior to termination of employment provided they have attained age 59½. A hardship distribution may also be made to satisfy certain immediate and heavy financial needs that a participant has.

Forfeited Accounts: Forfeitures are retained in the Plan and may be used to pay administrative expenses, or used to reduce future employer contributions payable under the Plan. During 2024, forfeitures of \$13,626 were used to reduce employer contributions.

Subsequent Events: The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments other than the fully benefit responsive investment contract are reported at fair value as further described in Notes 4 and 5. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest and other income are recorded on an accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the Plan year.

Benefits Paid to Participants: Benefit payments to participants are recorded when paid.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit, and global event risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 3 - CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritized the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- *Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- *Level 2* - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in active markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability as a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- *Level 3* - Inputs in the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the closing price reported on the active market on which the individual securities are traded.

Collective Trust Fund: The Plan invests in multiple types of the Putnam Retirement Advantage Trusts, a series of collective investment trusts (CITs) managed by Putnam Fiduciary Trust Company, LLC. These include vintages with target years from 2025 through 2065.

NOTE 4 - FAIR VALUE MEASUREMENTS (Continued)

The fair values of participation units held in each CIT are measured based on the net asset value (NAV) per unit, as reported daily by the fund manager. These NAVs reflect the fair value of the underlying portfolio holdings. The Plan is permitted to redeem daily at NAV, with no advance notice requirement or withdrawal restrictions under normal market conditions.

Each follows a target-date glide path, with an asset allocation that automatically adjusts over time to become more conservative as the target retirement date approaches. The glide path is managed using Putnam's proprietary strategic asset allocation models and is designed to balance capital appreciation, income generation, and risk mitigation over a participant's working life and into retirement.

NOTE 5 – GUARANTEED INTEREST FUND

The Plan holds a fully benefit-responsive guaranteed investment contract, Fixed Account, with Empower Annuity Insurance Company of America (EAICA). EAICA maintains the contributions in a general account. The account is credited with earnings or losses on the underlying investments and charged for participant withdrawals and administrative expenses. EAICA is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0.10%. The crediting rate is reviewed on a quarterly basis for resetting. The investment contract does not permit the Insurance Company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive traditional investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by EAICA, represents contributions made under the contract, plus earnings less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on EAICA's ability to meet its financial obligations. EAICA's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events may limit the ability of the Plan to transact at contract value with EAICA. Such events include, but may not be limited to, spin-off, sale, merger, full or partial termination including distribution of assets performed by a qualified termination administrator, terminating participating employer in a multiple employer plan, or a layoff of at least 20% of work force in any twelve month period. The Company believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with EAICA and that also would limit the ability of the Plan to transact at contract value with the participants. In addition, certain events allow EAICA to terminate the contract with the Plan and settle at an amount different from contract value. Examples of circumstances which would allow EAICA to terminate the contract include the Plan's loss of its qualified status, uncured material breaches of responsibilities, or material and adverse changes to the provisions of the Plan. The Company believes that any events allowing EAICA to terminate the contract and settle at an amount different from contract value are not probable of occurring.

NOTE 6 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor's regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Empower Trust Company, LLC and EAICA are service providers of the Plan, and, therefore, these transactions and the Plan's payment of fees to the service providers qualify as party-in-interest transactions.

NOTE 7 - TAX STATUS

On June 30, 2020, the Internal Revenue Service (IRS) stated the volume submitter profit sharing plan with CODA adopted by the Plan, as then designed, qualified under Internal Revenue Code (IRC) section 401. Although the Plan has been amended from the original pre-approved document, the Company believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no other audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examination for years prior to 2021.

NOTE 8 - PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.
