### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Spee Dee Delivery Service, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Spee Dee Delivery Service, Inc. ## Spee Dee Delivery Service, Inc. Retirement Plan Notes to Financial Statements

### NOTE 1 - DESCRIPTION OF PLAN

The following description of the Spee Dee Delivery Service, Inc. Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General and Eligibility**

The Plan is a defined contribution plan, under section 401(k) of the internal revenue code (IRC), covering all employees of Spee Dee Delivery Service, Inc. (the "Company") who have at least one year with at least 1,000 hours of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Board of Trustees (or equivalent) is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Board of Trustees.

#### **Contributions**

Participants may, after meeting eligibility requirements, contribute up to 100% of their compensation, as defined in the Plan. Contributions are subject to certain limitations as determined by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may contribute for each participant, a matching contribution equal to a percentage of the elective contributions made by the participants but not more than 1% of the participant's total eligible compensation. Participants must meet the age and service requirements and be employed on the last day of the Plan year to be eligible for a matching contribution. The Company has the discretion to allocate the Company match to the employer stock fund of which a majority is comprised of common stock in the Company and the remainder in cash. Since 2015, the Company has elected to allocate the match in the form of cash, to be invested according to the participant's respective investment elections. The Company may also contribute nonforfeitable, qualified, and nonelective contributions in an amount to be determined by the Company.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution, an allocation of Company contributions, and Plan earnings or losses. Allocations are based on participant earnings or losses, or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Diversification**

Diversification is offered to participants close to retirement so they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least 55 with at least ten years of participation in the Plan may elect to diversify a portion of their account into one or more of the investment options. Diversification is offered to each eligible participant over a six year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%.

## Spee Dee Delivery Service, Inc. Retirement Plan Notes to Financial Statements

### NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

#### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after 3 years of credited service.

#### **Forfeitures**

Forfeitures resulting from a terminated participant's failure to be fully vested in Company contributions are allocated as an employer nonelective, as if the participant forfeiture were an additional nonelective contribution. Forfeited nonvested accounts totaled \$644 and \$5,236 as of December 31, 2024 and 2023, respectively. There were no forfeitures allocated to participant accounts in 2024 or 2023.

#### **Payment of Benefits**

Participants may receive distributions from the Plan upon death, retirement, or termination of service. Upon termination of service a participant may elect a lump sum amount equal to the value of his or her account, periodic installments not to extend beyond the life expectancy of the participant or their designated beneficiary, or a combination of the two. Employer stock that is liquidated is valued at the most recent appraised value as of the end of the quarter in which the employee separated employment. The trustee transfers participants out of the Employer Stock Fund as of the first day of the quarter following separation of employment. The Plan allows for in-service withdrawals on rollover contributions at any time. The Plan allows for in-service withdrawals on Company contributions any time after a participant reaches 55 years of age. The Plan allows for in-services withdrawals on participant contributions any time after a participant reaches 59½ years of age. Hardship distributions are available subject to certain restrictions as defined in the plan document.

#### **Notes Receivable from Participants**

Any participant in the Plan who is an active employee with a minimum vested balance of \$2,000 may apply for a loan from the Plan. Loans are allowed for the following reasons: the purchase, construction, or improvement of a residence or other real estate; the purchase of a vehicle; tuition, and other education expenses; medical and dental expenses; funeral of a family member, or other miscellaneous reasons. Proceeds for a loan cannot be taken from participant balances invested in Company stock, but may be taken from all other investment balances up to 50% of the participant's vested balance. The maximum aggregate dollar amount of loans outstanding to any participant may not exceed \$50,000 in aggregate. The minimum principal amount for any loan is \$1,000. All loans must be repaid in 5 years unless the loan qualifies as a 15 year home loan.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Accounting**

The financial statements of the Plan are presented on the accrual basis of accounting.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reflected at fair value in the accompanying financial statements. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants valued as of the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisor, custodian, and trustees.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) represents the Plan's gains or losses on investments bought and sold as well as held during the year.

#### **Contributions**

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

#### **Funding Policy**

The Company remits its contribution to the Plan on an annual basis. Payment is made as soon as the amount is determined, which is generally in March following the year ended December 31.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Plan Expenses**

Administrative expenses, primarily audit fees, legal fees, and asset management record keeping expenses are paid by the Company, Spee Dee Delivery Service, Inc. and are excluded from these financial statements. Fees related to administration of notes receivable from participants and benefit payments are charged directly to the participants' accounts and are included in administrative fees. Investment related expenses are included in net appreciation of fair value of investments.

#### **Subsequent Events**

The Plan has evaluated subsequent events through October 15, 2025, the date which the financial statements were available to be issued.

### NOTE 3 - CERTIFICATIONS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including cash, investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America, the custodian, and Empower Trust Company, LLC, the trustee, of the Plan, and Reliance Trust Co., the custodian of the Plan through June 2024.

### NOTE 4 - FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are as follows:

Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies: valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 4 - FAIR VALUE MEASUREMENT (CONTINUED)**

Federated Capital Preservation Fund Collective Trust: valued at net asset value (NAV) of units of the collective investment trust at year-end. The NAV, as determined by the issuer of the trust, is based on the fair value of the underlying investments held by the fund less its liabilities, divided by the number of units outstanding. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Employer Stock: valued based on independent appraisal to arrive at enterprise value indications utilizing the income and market approaches, with emphasis on the discounted cash flow method.

**NOTE 5 - NONPARTICIPANT DIRECTED INVESTMENTS**

Nonparticipant directed investment allocations include any employer matching contributions which were funded through issuances of employer stock (noncash), allocated to participants and held in the employer stock fund. All contributions invested in the employer stock fund must remain invested in that fund until the participant terminates employment with the Company, unless a portion of their balance has been diversified under plan diversification rules. When a participant separates from employment their employer stock will be liquidated at the most recent appraised value as of the end of the quarter in which they separated. This portion of their account will be reinvested in other investment funds used by the Plan. Initially, the amounts will be reinvested according to an investment policy established by the Company, but participants are able to change the investments at the beginning of any quarter.

### **NOTE 6 - TAX STATUS**

The IRS has determined and informed the Company by a letter dated June 4, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **NOTE 7 - PARTY IN INTEREST AND RELATED PARTY TRANSACTIONS**

Certain Plan investments are shares of stock in the Company. These transactions qualify as party in interest transactions. The Employer Stock Fund is substantially comprised of common stock in the Company.

### **NOTE 8 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### **NOTE 9 - RECONCILIATION TO FORM 5500**

There were no reconciling items for 2024 and 2023 between the financial statements and Schedule H of Form 5500.

### **NOTE 10 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that change in the values of investment securities will occur in the near-term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **NOTE 11 - PROHIBITED TRANSACTIONS**

The Company failed to remit timely, certain employee deferrals to the Plan, aggregating \$160,960. The respective deferrals and computed lost earnings were remitted to the Plan in 2024 and 2025.
