1. PLAN DESCRIPTION

The following description of Kearney & Company Added Benefits Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined benefit health and welfare plan covering all full-time employees working thirty hours per week using a look-back measurement method based on Internal Revenue Service's final regulations under the Affordable Care Act. Full-time employees may also elect coverage for other individuals eligible for coverage, such as spouses and dependents up to age 26. Senior Executive position retirees with at least ten years of service, and their spouses and dependent children, are eligible to continue medical, dental, and vision coverage. The Plan provides coverage to qualified beneficiaries under the Consolidated Omnibus Budget Reconciliation Act (COBRA) following plan requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan provides medical coverage under six separate medical plan options through CareFirst Administrators (CFA). Coverage for dental, vision, short-term disability, long-term disability, life, and accidental death and dismemberment benefits are provided through Guardian.

Benefits

The Plan provides medical, dental, vision, short-term disability, long-term disability, life, and accidental death and dismemberment benefits for covered employees and their beneficiaries and covered dependents. The Plan is not a fully insured plan. The benefits are provided through insurance policies or through Kearney & Company, P.C. (the Employer). The Employer is not an insurer of any fully insured benefits. The Employer is responsible for certain benefits up to a limit; however, the Plan has a stop-loss insurance policy. The applicable insurance company will make the payment of fully insured benefits. The Employer will make the payment of all medical benefits. Insurance premiums for employees and their families are paid by the Employer. Employees are required to contribute toward the dental and vision premium. Under certain circumstances, employee contributions may be made on a pre-tax basis. Benefit payments for the year ended December 31, 2024, totaled \$11,305,277 and were netted against prescription drug rebates of \$552,610 and stop loss recoveries of \$1,141,725.

Method of Accounting

The Plan presents its financial statements under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP). Accordingly, income is recorded in the year earned and expenses are recorded in the year incurred.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Use of Estimates

The preparation of financial statements in conformity with GAAP requires plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of benefit obligations at the date of the financial statements. Actual results may differ from those estimates.

Stop Loss

Premiums for stop-loss insurance are included in insurance premiums in the accompanying statement of changes in net assets available for benefits. Stop-loss insurance recoveries are netted against benefit payments. The total stop-loss recoveries received for the years ended December 31, 2024 and 2023, were \$1,141,725 and \$943,307, respectively.

Stop-Loss Receivable

Stop-loss amounts still unpaid as of December 31st are shown as a receivable on the statements of net assets available for benefits and are carried at the unpaid amounts. The total stop-loss receivable for the years ended December 31, 2024 and 2023, were \$122,319 and \$154,934, respectively.

Claims Fund Receivable

Claims amounts still unpaid as of December 31st are shown as a receivable on the statements of net assets available for benefits and are carried at the unpaid amounts.

Accrued Interest Receivable

Unpaid accumulated interest is shown as a receivable on the statements of net assets available for benefits and is carried at the unpaid balance.

Claims Payable

The Plan records claim payments when paid by the claims processor. Amounts due to claims processors that have not been reimbursed by the Plan are recorded as a payable to claims administrators in the statements of net assets available for benefits.

Advanced Deposits

Amounts due for administrative services that have yet to be reimbursed by the Plan are recorded as deferred revenue in the statements of net assets available for benefits.

Income Recognition

The Plan's contributions are recognized on the accrual basis. Interest and dividends on money market accounts are recorded on the ex-dividend date.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Administrative Expenses

Administrative and other expenses of the Plan are generally paid from plan assets. The Employer, however, may pay directly certain administrative expenses of the Plan. Costs paid directly by the Employer are not recorded in the statement of changes in net assets available for benefits.

3. BENEFIT OBLIGATIONS

The Plan's estimate of unpaid claim obligations is estimated by the third-party administrators utilizing actuarial methods which take into consideration prior claims experience and the expected time period from the date such claims are incurred to the date the related claims are submitted and paid.

As of December 31, 2024 and 2023, the estimated benefit claim obligation totaled \$836,732 and \$760,066, respectively. This estimate includes (1) unreported claims; (2) reported but unprocessed claims; (3) processed but unpaid claims. Claim settlement expense liabilities are not included. The method used applied a factor (the reserve factor) to a credit best estimate volume measurement of paid claims. The calculation was performed for medical and drug coverage. Due to the short nature of this reserve liability, time value of money was not used to discount future payments.

4. TAX STATUS

The accounting standard on accounting for uncertainty in income taxes addresses the determination of whether tax benefits claimed or expected to be claimed on a tax return should be recorded in the financial statements. Under that guidance, the Plan may recognize the tax benefit from an uncertain tax position only if it is more likely than not that the tax position will be sustained on examination by taxing authorities based on the technical merits of the position. For the Plan, a tax position is the Plan's tax-exempt status under the provisions of the Internal Revenue Code (IRC) and ERISA. The tax benefits recognized in the financial statements from such a position are measured based on the largest benefit that has a greater than 50% likelihood of being realized upon ultimate settlement. There were no unrecognized tax benefits related to uncertain tax positions identified or recorded as liabilities for the year ended December 31, 2024.

The Plan's policy would be to recognize interest and penalties, if any, on tax positions related to its unrecognized tax benefits in income tax expense in the financial statements. No interest and penalties were assessed or recorded during the year ended December 31, 2024. A trust was established under the Plan to hold the Plan's assets. The Plan has not obtained a determination letter from the Internal Revenue Service, but management is of the opinion that the Plan and related trust are operating in compliance with applicable sections of the Internal Revenue Code (IRC) and ERISA to qualify as exempt from federal income taxes.

5. PLAN TERMINATION

Although the Employer has not expressed any intent to do so, they have a right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, assets will be used to pay benefits under the terms of the Plan and coverage for all covered persons would end.

6. RELATED PARTY TRANSACTIONS

Kearney & Company, P.C. paid certain expenses on behalf on the Plan. These transactions qualify as party-in-interest transactions. Fees and commission paid for the year ended December 31, 2024, was \$431,554, which is included in the statement of changes in net assets available for benefits.

7. RISKS AND UNCERTAINTIES

Due to uncertainties inherent in the estimations and assumptions process for estimating unpaid claim obligations, it is at least reasonably possible that changes in these estimates and assumptions in the near-term could be material to the financial statements.

The Coronavirus Aid, Relief, and Economic Security Act (the CARES Act) was signed into law on March 27, 2020, and the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act), was signed into law December 29, 2019. Provisions for the CARES Act and the SECURE Act must be made in accordance with applicable law and IRS guidance. Under Notice 2022-33 and Notice 2022-45, the IRS has extended the deadline for retirement plans to adopt the amendments required by the SECURE Act and the CARES Act until December 31, 2025.

The spread of COVID-19 (coronavirus disease) has had a disruptive impact on the daily life and operations of individuals, businesses, and employee benefit plans around the world. There is uncertainty about financial and economic impacts in all sectors of the economy. The financial markets have experienced significant volatility, and this may continue for an extended period of time. In light of these circumstances, the Plan's management continues to assess how best to adapt to changed circumstances.

8. SUBSEQUENT EVENTS

The plan administrator has evaluated subsequent events through October 10, 2025, the date on which the financial statements were available to be issued.
