In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - DESCRIPTION OF THE PLAN

A. Formation of Plan

The Hanford Retiree Welfare Benefit Plan (the Plan) provides postretirement benefits for eligible participants of Hanford Site Contractors. The Plan was established on January 1, 2000, and is administered by the Board of Trustees (Trustees). Prior to January 1, 2000, the benefits offered through this Plan were administered by Fluor Hanford. All sponsoring employers are prime contractors or subcontractors for the Department of Energy (DOE) at the Hanford Site in Richland, Washington.

B. General

The following description is provided for general information purposes only. Participants should refer to the Plan documents for complete information regarding all of the Plan's definitions, benefits, eligibility, and other matters. The Plan is a postretirement health and welfare plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

In January 2021, the Plans daily operational and plan administrative activities were transitioned from Mission Support Alliance LLC (MSA) to Hanford Mission Integration Solutions LLC (HMIS).

C. Benefits

The Plan currently provides comprehensive medical coverage for Plan participants under age 65 and their dependents. The Plan provides postretirement life insurance for eligible participants both under and over age 65.

The Plan also provides retiree health reimbursement arrangement accounts, which are administered by Via Benefits to eligible Plan participants over age 65 enrolled in Medicare.

Health benefits are provided as either fully insured or claims based. Fully insured programs are administered by Kaiser Permanente Options Health Care. Claims based benefits are administered by UnitedHealthcare and Express Scripts, Inc. Annual open enrollments offer participants the opportunity to change their coverage elections.

D. Eligibility

Participants who have at least 10 years of pension vesting credit, are at least age 55 as of the last day worked prior to retirement, and pay the required contributions, are eligible for continuing medical and life insurance coverage if elected prior to termination of employment. Effective January 1, 2004, new hires are not eligible for postretirement medical and life insurance benefits.

E. Plan Sponsors

During the year ended December 31, 2021, MSA and its subcontractors were removed as a Plan Administrator and were replaced by HMIS. As of December 31, 2022, the Plan Sponsors include Northwind Solutions, LLC; Central Plateau Cleanup Co.; CH2M Hill Plateau Remediation Company Closeout office; Mission Support Alliance, LLC Closeout office; Washington River Protection Solutions, LLC; HMIS; Advanced Technologies & Laboratories; and Navarro Research & Engineering.

E. Plan Sponsors (Continued)

A Sponsor may withdraw from participation in the Plan by giving 30 days written notice of intent to the Trustees.

F. Payment of Benefits

Certain health benefit options provided to participants are self-funded by the Plan and are the responsibility of the Plan Sponsors. As such, the Plan pays these claims and these claims are reflected as health claims benefit expense on the statements of changes in net assets available for benefits.

Alternatively, certain health and life benefit options provided to participants are administered by outside insurance companies. The premiums paid for these options are paid by the Plan and are reflected as health and life premium payments, respectively, on the statements of changes in net assets available for benefits. Payment of the premiums transfers the risk of benefit payment to the insurance company.

G. Contributions

Participants contribute amounts as determined by the Plan. Plan Sponsor contributions are calculated by applying an annual rate to their base payroll. The rate is determined annually as necessary to adequately fund the Plan.

Participants eligible for postretirement medical benefits who reach age 65 are enrolled in a non-contributory health reimbursement arrangement (HRA) administered by Via Benefits. Under the HRA, the Plan Sponsors credit \$1,800 per eligible participant (or more if married) on the first day of the Plan year, to be reduced from time to time by the amount of eligible medical expenses for which the participant is reimbursed by the Plan. Amounts credited to participants under the HRA are reported as accounts payable on the statements of net assets available for benefits.

H. Other

The Trustees have the right under the Plan to modify the benefits provided to participants and to amend and/or modify the Plan subject to ERISA provisions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Estimates

The preparation of the Plan's financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ

from those estimates. Significant estimates include management's determination of the allocation of employer contributions, contributions and rebates receivable, and administrative expenses between the Plan and the Hanford Employee Welfare Benefit Plan (Active Plan). Allocations are based on overall costs incurred or specific costs such as claims or pharmacy benefits paid.

C. Risks and Uncertainties

The actuarial present value of Plan benefit obligations is based on certain assumptions pertaining to interest rates, retiree demographics, and medical cost trend rates, all of which are subject to change. Due to the changing nature of these assumptions, and the uncertainties inherent in the assumption process, it is at least reasonably possible that changes in these assumptions in the near term could have a material effect on the financial statements.

D. Cash

Pursuant to the contractor's agreement with the DOE, the Plan does not maintain investments in interest-bearing accounts. Therefore, Plan assets are maintained in a noninterest-bearing cash account. Sufficient cash proceeds are maintained within the account to fund the daily cash requirements of both the Plan and the Active Plan. The Plan maintains its cash in bank accounts in amounts that, at times, may exceed the federally insured limit of \$250,000 per bank. The Plan has not experienced any losses in such accounts.

The Plan funds certain claim payments via wire transfer to accounts used by benefit providers for such payments on a check-cleared basis. At December 31, 2024 and 2023, the Plan had not completed such wire transfers to cover outstanding checks resulting in drafts payable in these accounts. These amounts have been reflected as drafts payable on the statements of net assets available for benefits.

E. Contributions Receivable

Contributions receivable represent the net amount owed by Plan Sponsors to fund health care costs incurred through the end of the calendar year.

F. Accounts Payable

Accounts payable represent amounts payable to Plan participants for current and future health care claims that are reimbursable through their HRA. The balance of HRA owed by the Plan at December 31, 2024 and 2023 is \$14,242,000 and \$10,864,992, respectively.

G. Administrative Expenses

Administrative and professional fees relating to the direct management of the Plan's assets and benefit payments are paid by the Plan on behalf of the sponsoring companies.

H. Plan Termination

The Trustees or management of the Plan Sponsors have not expressed any intent to discontinue contributions. In the event such discontinuance results in the termination of the Plan, the net assets of the Plan would be available for the exclusive use of the participants, but the manner and timing of allocation is left to the discretion of the Trustees.

I. Claims Incurred but Not Reported

Obligations for medical claims incurred but not reported as of December 31, 2024 and 2023, are estimated by the insurers (see Note 5).

J. Subsequent Events

Management has evaluated subsequent events through October 14, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.

NOTE 3 - TAX STATUS

The Plan established under the Trust holds the Plan's assets and pays benefits in accordance with the Hanford Employee Welfare Trust Agreement. Although the Plan is a taxable entity under the Internal Revenue Code, the Plan administrator understands that the Plan had no taxable income during the years ended December 31, 2024 and 2023. Accordingly, no provision or liability for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - RELATED PARTY AND FUNDING OF BENEFIT OBLIGATIONS

The DOE requires that funding for postretirement benefits be provided on a pay-as-you-go basis, and the contractor sponsors of the Plan have adopted this policy. Therefore, the Plan Sponsors fund the Plan on a pay-as-you go basis and are subsequently reimbursed for the costs through their contract with the DOE. The DOE has recorded the accrued postretirement benefit costs as an unfunded liability as of September 30 of the Plan year, which is the end of the DOE's fiscal year. The liability is rolled forward to December 31 of the Plan year for financial reporting purposes. Prior to the change in plan sponsor, MSA, provided funding to the Plan through a letter of credit arrangement with the DOE on behalf of the Plan Sponsors to meet cash requirements. The Plan refunded MSA, for its contributions on behalf of other plan sponsors. As a participating employer, MSA, was also responsible for funding Plan contributions for its own employees.

The amount disclosed as the postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed to employees' service rendered to the date of December 31. Postretirement benefits include future benefits expected to be paid to or for active employees after retirement and currently retired employees and their beneficiaries and dependents. The postretirement benefit obligation represents the amount that is to be funded by contributions from the DOE or the Plan Sponsors at the time of payment of benefits.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, or withdrawal) between the valuation date and the expected date of payment. Although the standardized medical trend rates specified by the DOE are considered reasonable, the rates have been adjusted slightly to reflect the Plan's use of a net claims valuation method (versus the gross claims method requested). The adjustment reflects the leveraging and dampening effects that deductibles, co-payments, and maximum benefit provisions exert on the trend in gross claims. The leveraging factor assumed increases in the trend rates and is reflected as follows:

The health care cost-trend rate assumption has a significant effect on the amounts reported. If the assumed rates increased by one percentage point in each year, that would increase the obligations as of December 31, 2024 and 2023 by \$2,942,421 and \$3,040,376, respectively.

Since the prior valuation, the medical trend and discount rate were changed as required by the DOE and updates to the retirement and several demographic assumptions were made. The changes in these actuarial assumptions resulted in the liability increasing by \$15,286,282.
