We have performed an audit of the financial statements of Community Health Center of Central Missouri 403(b) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

**Note 1. Description of the Plan**

***General***

The following description of Community Health Center of Central Missouri 403(b) Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan covering all employees, who work more than 20 hours per week, of Community Health Center of Central Missouri (Organization) who have completed one day of service. The Plan is subject to the *Employee Retirement Income Security Act of 1974* (ERISA). Delaware Charter Guarantee and Trust Company, d/b/a Principal Trust Company (Principal Trust), serves as plan custodian.

***Contributions***

The Plan permitted eligible employees through a salary deferral election to have the Organization make annual contributions up to 100% of eligible compensation. Employee rollover and employee Roth contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Organization makes discretionary contributions equal to 3% of eligible compensation. To participate in employer discretionary contributions, an employee must complete 90 days of service.

Contributions are subject to certain limitations.

***Participant Investment Account Options***

Participants have the option of directing their contributions into any of the various investment accounts and may change the allocation daily.

***Participant Accounts***

Each participant's account is credited with the participant's contributions, the Organization's contributions, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Organization's discretionary contribution portion of their accounts plus earnings thereon is based on years of credited service. A participant is fully vested in the Organization's discretionary contributions after five years of credited service. The nonvested balance is forfeited upon termination of service.

***Payment of Benefits***

If a participant ceases to be an employee of the Organization and his vested account balance does not exceed \$1,000, the entire vested account balance will be payable to the participant or his beneficiaries in a single lump-sum payment. Balances greater than \$1,000 but not exceeding \$5,000 are to be rolled over to an individual retirement account as designated by the Plan, absent an election by the participant. Participant balances in excess of \$5,000 can remain in the Plan until such time the participant elects to receive a distribution in the form of a lump-sum amount or installments. Withdrawals for reasons other than termination of employment are permitted under circumstances provided by the Plan. Under the SECURE 2.0 Act, qualified participants are permitted to take qualified birth/adoption distributions (QBA) of up to \$5,000 from the Plan.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$20,010 and \$23,451, respectively. These accounts will be used to pay administrative expenses or reduce future employer contributions. During 2024 and 2023, forfeitures of \$0 were used to reduce the Organizations contributions. During 2024, administrative expenses of \$28,309 were paid from forfeited nonvested accounts.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Organization or the Plan, at the Organization's discretion.

The Plan has an agreement with Principal Life Insurance Company for a plan expense account to pay necessary and reasonable plan related expenses in accordance with the Department of Labor's guidance. The Organization is responsible for determining what expenses Principal Life Insurance Company will reimburse from the account. Amounts funded into this account by the Plan are treated as administrative expenses on the statement of changes in net assets available for benefits. Total additions to the account were \$17,745 during 2024. Administrative expenses of \$17,745 were paid from the account during 2024. The account's balance is not included in the investment balance on the statements of net assets available for benefits because the assets belong to Principal Life Insurance Company and an affiliate until such time as they are used to pay legitimate plan expenses within the terms of the account agreement.

**Note 3. Certification of Plan Custodian**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Trust, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the accompanying schedule of assets (held at year-end) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

**Note 5. Related Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain investments are issued by affiliates of Principal Trust. Principal Trust is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan paid \$29,888 of direct record keeping fees to Principal Life Insurance Company, an affiliate of Principal Trust during 2024.

The Organization provides certain accounting and administrative services at no cost to the Plan and directly pays any other fees related to the Plan’s operations.

**Note 6. Plan Termination**

Although it has not expressed an intention to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer profit sharing contribution accounts.

**Note 7. Tax Status**

The Plan operates under a non-standardized adoption agreement in connection with a pre-approved 403(b) plan document sponsored by Principal Life Insurance Company (Principal Life). Principal Life received an opinion letter dated March 31, 2017, stating the form of the Plan is acceptable under the appropriate section of the Internal Revenue Code (IRC). Therefore, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan Management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8. Nonexempt Transactions**

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. While the Organization remitted all employee contributions to the Plan, contributions of \$12,591 were not remitted within the required time period for the year ended December 31, 2024.

**Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially adversely affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 10. Subsequent Events**

Subsequent events have been evaluated through October 15, 2025, which is the date the financial statements were available to be issued.
