NOTE A - DESCRIPTION OF PLAN

The following description of the United Way of Metropolitan Chicago, Inc. Defined Contribution Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that was established on January 1, 2018, which covers all eligible regular employees of United Way of Metropolitan Chicago, Inc. (the Company). Employees do not need to satisfy an age requirement in order to participate in the Plan. Employees not classified as full-time may make pre-tax and Roth deferrals after completing one year of service. Additionally, these participants are eligible for the employer matching contribution after completing one year of service.

Full-time employees do not have to satisfy any service requirements in order to make pre-tax and Roth deferrals. Additionally, these participants do not have to satisfy any service requirements in order to become eligible for the employer matching contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Subject to certain Internal Revenue Service (IRS) limitations (\$23,000 in 2024), participants may contribute up to 100% of pretax compensation, as defined by the Plan. Participants may also make after-tax Roth deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Employee rollover contributions are considered 100% vested regardless of years of service.

The Company matches 100% a participant's eligible deferral election per pay period, by the employee for a maximum match percentage of 3% of the participant's eligible pay. Contributions are not to exceed the maximum amount deductible under the Internal Revenue Code of 1986 (IRC). Participants direct the investment of their contributions and the Company's contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, including rollover contributions, and the Company's contribution, if any, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are principally based on participant account balances.

Vesting

Participant contributions and the Company's matching contributions are considered 100% vested regardless of years of service.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest are paid through monthly payroll deductions. Interest rates range from 5.50% to 9.50% maturing in 2025 through 2033.

Payment of Benefits

The Plan provides for the distribution of participants' accounts upon normal retirement, disability, or death. Distributions will be made in the form of a single lump-sum payment or a single life annuity, upon consent by the participant, unless a distribution is required to be made sooner under the IRC.

Upon a participant's termination of employment with the Company prior to normal retirement, vested benefits will be paid in a lump sum or rolled over into an IRA on the participant's behalf, upon consent by the participant, unless the participant's balance is less than \$5,000 and the participant does not consent within 30 days of notification.

Normal retirement is the date on which a participant attains age 65.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). A description of those accounting policies of particular significance follows.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation /(depreciation) includes the Plan's gains and losses on the investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Investments

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for a discussion on fair value measurements.

The Plan invests in various investment securities that are exposed to several risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities may occur. The changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Administrative Expenses

Certain administrative expenses relating to the operations of the Plan, such as trustee, accounting, legal and other fees, are paid directly by the Plan. These may be allocated to participant accounts or offset by forfeitures, as permitted by the Plan.

NOTE C - INFORMATION CERTIFIED BY TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024.
- Investment (loss) income (other than other income) and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- The supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE D - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board (FASB) has issued guidance that defines fair value, establishes a framework for measuring fair value under current accounting pronouncements that require or permit fair value measurements, and enhances disclosures about fair value measurements. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the FASB guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value as December 31, 2024.

Interest-bearing cash – Investments with original maturities of three months or less when purchased, including certain short-term fixed-income securities and money market funds, are considered interest-bearing cash. The fair values are based on observable market prices and, therefore, have been categorized in Level 1 in the fair value hierarchy.

Mutual funds (registered investment companies) - Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are primarily open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and have been categorized as Level 1.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - PLAN TERMINATION

Although it has not expressed any such intent, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine, subject to the provisions under ERISA.

NOTE F - TAX STATUS

The IRS issued an opinion letter dated March 31, 2014, indicating that the Volume Submitter 401(k) Pre-Approved Profit-Sharing form adopted by the Plan, as then designed, was in compliance with applicable sections of the IRC. Although the Plan has been amended since the adoption of the Volume Submitter 401(k) Pre-Approved Profit-Sharing form, the Plan administrator believes that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires the Plan’s management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G - RELATED-PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Vanguard Fiduciary Trust Company. Vanguard is the record-keeper for the Plan. These transactions qualify as party-in-interest transactions that are exempt from the prohibited transactions rules of ERISA.

NOTE H - SUBSEQUENT EVENTS

The Company evaluated the Plan's December 31, 2024, financial statements for subsequent events through October 15, 2025, the date the financial statements were available to be issued, and no material events were noted.
