Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Ag Leader Technology, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Notes to Financial Statements

Note 1. Plan Description

The following description of Ag Leader Technology, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General and eligibility: The Plan is a defined contribution plan covering substantially all employees of Ag Leader Technology, Inc. (the Company). Employees who have completed three months of service and are age 21 or older are eligible to make salary deferral contributions to the Plan and receive the safe harbor match starting on the first day of the month immediately following the month eligibility requirements were met. The Board of Trustees is responsible for the oversight of the Plan. The Company determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees. The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA) and the applicable current Internal Revenue Code provisions.

Eligible employees are requested to complete an enrollment form which determines their savings rate and investment elections. Failure to complete this enrollment form results in the eligible employee being automatically enrolled with a 3% employee contribution effective the first Plan entry date after meeting eligibility requirements. For all eligible employees who are automatically enrolled in the Plan on or after January 1, 2019, an automatic increase of 1% will be applied at the anniversary date of the participant's automatic enrollment.

Contributions and investment options: Each year, participants may contribute a portion of their eligible compensation, subject to an annual limit, as defined by the Plan and federal regulations. Participants may also contribute amounts representing distributions from other qualified defined contribution plans. The Company provides a safe harbor matching contribution up to 100% of the first 6% of base compensation that a participant contributes to the Plan. The amount contributed by participants and the Company are deposited into a variety of Class A and Institutional class mutual funds, a common collective trust or a self-directed brokerage account. Participants may change their investment options at any time.

Participant accounts: Each participant's account is credited with the participant's contributions, the Company's matching contributions and an allocation of: (a) plan earnings and (b) administrative expenses. Allocations are based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting: Participants are immediately vested in their contributions and safe harbor matching contributions plus actual earnings thereon. One year of vesting service is earned for each service period in which a participant has 1,000 or more hours of service. A participant begins vesting in matching contributions after two years of service and vests at 20% annually thereafter, resulting in 100% vesting after six years of credited service.

Payment of benefits: Participants or their beneficiaries are eligible for benefits upon retirement, hardship, termination, death or disability. Participants with vested balances greater than \$5,000 may elect to receive benefits in a lump-sum payment or an annuity in addition to other options under the Plan. Participants with vested balances less than \$5,000 may roll over the amount into another qualified plan or receive a lump-sum distribution.

Note 1. Plan Description (Continued)

Notes receivable from participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Transactions are treated as a transfer to (from) the investment fund from (to) notes receivable. Terms may vary based on the reason for the note. The notes receivable are secured by the vested balance in the participant's account and bear interest based at prevailing interest rates. Principal and interest are paid ratably through payroll deductions. Notes receivable outstanding at December 31, 2024 mature through October 2029 and have interest rates ranging from 4.25% to 9.50%. Notes receivable outstanding at December 31, 2023 mature through September 2028 and had interest rates ranging from 4.25% to 9.50%.

Forfeited accounts: At December 31, 2024 and 2023, there was approximately \$12,000 and \$11,000, respectively, remaining in the forfeiture account to be used to offset future administrative expenses and employer contributions. During the year ended December 31, 2024, the Plan utilized approximately \$1,000 from the forfeiture account to pay for plan expenses.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Accounting estimates and assumptions: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Contributions: Contributions from plan participants and the related matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are treated as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of benefits: Benefit payments are recorded when paid.

Note 2. Significant Accounting Policies (Continued)

Risks and uncertainties: The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent events: The Plan has evaluated subsequent events for potential recognition and disclosure through October 15, 2025, which is the date the financial statements were available to be issued.

Note 3. Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable that are charged directly to the participant's account and certain record-keeping fees paid by the Plan. Certain administrative functions of the Plan are performed by officers and employees of the Company. No such officer or employee receives compensation from the Plan. Certain other administrative expenses are paid directly by the Plan. Investment-related expenses are included in net appreciation in fair value of investments.

Note 4. Information Certified and Provided by Bank of America, N.A., the Trustee

Note 5. Tax Status

The Plan adopted a nonstandardized form of a prototype plan sponsored by Bank of America, N.A. The prototype plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020, as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

The Plan follows the accounting guidance for uncertainty in income taxes. Management evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has taken no uncertain tax position that require adjustments to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, all participants will become 100% vested in their accounts.

Note 7. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. The Fair Value Measurements and Disclosures Topic of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) requires the use of valuation techniques that are consistent with the market approach, the income approach and/or the cost approach. Inputs to valuation techniques refer to the assumptions that market participants would use in pricing the asset or liability. Inputs may be observable, meaning those that reflect the assumptions market participants would use in pricing the asset or liability developed based on market data obtained from independent sources, or unobservable, meaning those that reflect the Plan's own assumptions about the assumptions market participants would use in pricing the asset or liability developed based on the best information available in the circumstances. In that regard, the Topic establishes a fair value hierarchy for valuation inputs that give the highest priority to quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The fair value hierarchy is as follows:

Level 1: Quoted market prices in active markets for identical assets or liabilities

Level 2: Observable market-based inputs or unobservable inputs that are corroborated by market data

Level 3: Unobservable inputs that are not corroborated by market data

Mutual funds and money market fund: Mutual funds and the Plan's money market fund are reported at fair value based on the quoted market price of the fund and are classified within Level 1 of the valuation hierarchy.

Self-directed funds: Self-directed investments are individual investments that consist of cash, money market funds, common stocks and mutual funds. Investments in cash and money market funds are reported at cost which approximates fair value. Investments in common stocks and mutual funds are based on quoted market prices. The fair value of the self-directed funds are classified within Level 1 and Level 2 of the valuation hierarchy.

Common collective trusts: Common collective trust funds are composed primarily of fully benefit-responsive investment contracts that are valued at the net asset value of units of the common collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur immediately. If the Plan initiates a full redemption of the common collective trust, no notice to the issuer is required.

The following table summarizes investments for which fair value is measured using the net asset value per share practical expedient as of December 31, 2024 and 2023. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

(a) This category consists of a stable value fund, which seeks current income by investing primarily in insurance contracts issued by insurance companies and investments from financial institutions which offer stability of principal. Investments in this category can be redeemed daily at the current net asset value per share based on the fair value of the underlying assets. Contributions to the fund are maintained in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fund's fair value was estimated using net asset value per share.
