## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of CivicPlus 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Other Matter—Supplemental Schedules Required by ERISA**

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. #### Note 1. Plan Description

The following description of CivicPlus 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering employees of CivicPlus LLC, Network Plus, SeeClickFix, Inc., Municode, which are under common control (collectively, the Companies). The Plan Administrator and Trustees are responsible for oversight of the Plan. The Plan Administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's and Trustees. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Eligibility:** Employees who are at least 18 years of age are eligible to contribute employee contributions and receive an employer safe harbor matching contribution after the first day of the calendar month, coincident with or next following the date they attain age 18. Employees meeting the eligibility requirements are automatically enrolled in the Plan with a 3% deferral rate on the first month following meeting eligibility requirements, unless they choose a different percentage or choose not to participate. Each year the participants who have been automatically enrolled have their contribution percentage increased by 1% until reaching a 5% contribution rate. Employees are eligible for employer discretionary matching and discretionary nonelective contributions after one year of service. An employee must complete 1,000 hours of service to receive credit for one year of service. Employees must also be employed at the end of the Plan year to receive the discretionary nonelective contribution.

**Contributions:** Participants may contribute up to 75% of pretax compensation, subject to the maximum allowed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants are also allowed to make Roth 401(k) contributions. During 2024, the Company made a safe harbor matching contribution equal to 100% of the deferral contributed by the participant, up to a maximum of 5% of the participant's compensation.

At the end of the Plan year, the Company may also make a discretionary matching and discretionary nonelective contributions, as defined in the Plan Agreement. The Company did not make a discretionary matching or discretionary nonelective contribution in 2024.

In addition, the Plan allows for rollover contributions from other qualified plans.

**Investment options:** Upon enrollment in the Plan, a participant may direct all contributions to selected investments as made available and determined by the Plan Administrator in 1% increments. Participants may change their investment options daily.

**Participant accounts:** Each participant's account is credited with the employee contributions, employer contributions and an allocation of Plan earnings. Allocations of Plan earnings are based on accounts of participants as defined by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their salary deferral contributions and the employer safe harbor contributions plus actual earnings thereon. The Plan provides vesting in the employer's discretionary matching and discretionary nonelective contributions of 20% after two years of service, 40% after three years of service, 60% after four years of service, 80% after five years of service, and 100% after six years of service. An employee who becomes disabled, dies or reaches age 65 will become 100% vested in the employer's contributions.

#### Note 1. Plan Description (Continued)

**Payment of benefits:** Benefits are distributed upon death, disability, retirement or termination of employment. The participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Distributions are made in a lump sum, substantially equal payments or partial withdrawal to the participant and designated beneficiaries. Mandatory distributions will be made following severance from employment when the participant's account balance is \$5,000 or less.

**In-service withdrawals:** Participants may withdraw from the Plan that portion of their account resulting from their deferral contributions in the event of undue financial hardship. Hardship withdrawals will be approved only if they conform to the Plan provisions and established IRS safe harbors. The Plan also provides for active participants who have reached the age 59½ to take a distribution from his or her deferral contribution account only.

**Forfeitures:** Forfeitures represent the nonvested portion of participant account balances related to employer discretionary matching contributions upon termination. Forfeited amounts may be used to pay Plan expenses or reduce future employer contributions. Forfeited nonvested accounts totaled \$617 and \$114,718 as of December 31, 2024 and 2023, respectively. During 2024, \$116,546 of forfeitures were used to offset employer contributions.

**Notes receivable from participants:** Notes receivable from participants are not allowed by the Plan, unless specifically approved due to a merged in participant balance.

#### Note 2. Summary of Significant Accounting Policies

**Basis of presentation:** The accompanying financial statements are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of the financial statements in accordance with accounting principles generally accepted in the United States (U.S. GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Plan investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrator determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and such changes could materially affect participant account balances and the amounts reported in the 2024 statement of net assets available for benefits.

**Payment of benefits:** Benefit payments to participants are recorded when paid.

#### Note 2. Summary of Significant Accounting Policies (Continued)

**Expenses:** Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses include fees related to certain record-keeping fees paid by the Plan. Investment-related expenses are included in net appreciation of fair value of investments.

**Contributions:** Contributions from Plan participants and the safe harbor matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation. Employer discretionary matching and discretionary nonelective contributions are recorded in the year in which the employees' underlying service occurred.

**Allowance for credit losses:** The measurement of expected credit losses under the current expected credit loss (CECL) methodology is applicable to financial assets measured at amortized cost, which include employer and participant contributions receivable. An allowance for credit losses under the CECL methodology is determined using the loss-rate approach and measured on a collective (pool) basis when similar risk characteristics exist. Where financial instruments do not share risk characteristics, they are evaluated on an individual basis. The CECL allowance is based on relevant available information, from internal and external sources, related to past events, current conditions and reasonable supportable forecasts. Management recorded no allowance for credit losses as of December 31, 2024 and 2023, as all amounts were determined to be fully collectable.

#### Note 3. Information Certified by Hand Benefits & Trust Company (Custodian)

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds:** Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Interest-bearing cash:** Interest-bearing cash is valued at carrying value, which is fair value.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of Level 3.

#### **Note 5. Tax Status**

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in conformity with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

On April 30, 2021, the Plan filed a Voluntary Correction Program application with the IRS regarding the terminology utilized in the Adoption Agreement. ICON Investment, L.L.C. and ICON Restaurants, L.L.C. (Related Employers) have historically been referred to as members of the controlled group. During May 2019, an investor acquired approximately 25% of the CivicPlus, Inc., which resulted in the common ownership of the CivicPlus, Inc. and the Related Employers to drop below the 80% controlled group threshold for single employer plan purposes. The Plan should have been amended to properly identify the Related Employers as noncontrolled group members. Management believes that this will have no impact on the tax-exempt status of the Plan.

#### **Note 6. Plan Termination**

Although it has not expressed intent to do so, the Companies have the right under the Plan to discontinue its contributions at any time and to terminate or amend the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### **Note 7. Related-Party and Party-in-Interest Transactions**

Benefit Plans Administrative Services LLC is the record keeper of the Plan and Hand Benefits & Trust Company is the custodian of the Plan. Fees paid to the Plan record keeper and custodian were \$224,179 for the year ended December 31, 2024. Therefore, these transactions qualify as party-in-interest transactions. The Companies also paid certain administrative expenses of the Plan.

#### **Note 8. Prohibited Transactions**

During the years ended December 31, 2023 and 2022, the Company inadvertently failed to timely deposit \$682,140 and \$256,342, respectively, of participant deferrals within the required time frame as stated by the DOL's regulations. Lost earnings related to this late deposit will be calculated and remitted into the Plan in 2025. The Company will file a Form 5330 and pay the applicable excise tax to the IRS in 2025. The lost earnings and excise tax payments will be made from the Company's assets and not from assets of the Plan.

#### **Note 9. Subsequent Events**

Management has evaluated subsequent events through the date financial statements were available for issue, which is October 14, 2025.
