**NOTE 1: Description of the Plan**

The following description of the CGI Communications, Inc 4019K) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established to provide retirement benefits for employees of CGI Communications, Inc (the Company). The Plan became effective on April 1, 1994 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Administration

The Company is the plan administrator. Ascensus Trust Company is the trustee of the Plan's assets and also provides record-keeping and other administrative services to the Plan. The Company pays certain administrative expenses of the Plan.

Eligibility

Employees who have attained 21 years of age are eligible to participate in the Plan after the completion of two months of employment with the Company for employee elective deferrals and employer matching contributions, and one year of service for employer profit sharing contributions.

Participant Contributions

Participants may make tax-deferred contributions to the Plan of up to 100% of their compensation, subject to statutory limitations and the Plan provisions. The Plan includes an automatic enrollment feature whereby all employees are automatically enrolled in the Plan with a deferral rate of 3% invested in a designated balanced fund, unless they choose not to participate or elect a different deferral percentage. In addition, participants may make rollover contributions to the Plan.

Employer Contributions

The Company may make discretionary matching contributions on behalf of participants that are employed on the last day of the plan year, regardless of hours worked. In 2024 and 2023, the discretionary matching contribution was calculated as 25% of the employee deferral contributions. The Plan also allows for the Company to make a discretionary profit-sharing match. No such profit-sharing match was made during the years ended December 31, 2024 and 2023.

Participant Accounts

Participants direct the investment of their accounts into various investment options offered by the Plan. Each participant's account is credited with the participant's contributions, employer contributions, and actual earnings thereon. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and actual earnings/losses thereon. Employer contributions and actual earnings/losses thereon vest 20% after each year of service and are fully vested after five years. In addition, participants accounts become fully vested in the event of death or total disability.

Forfeitures

Forfeitures of non-vested account balances are used to reduce employer contributions in the current year or succeeding plan years. At December 31, 2024 and 2023 forfeited non-vested accounts total \$4,564 and \$12,943 respectively.

Notes Receivable from Participants

Participants may borrow funds from \$1,000 up to \$50,000 or a portion of their vested account balance. Loans must be repaid within 4.5 years, unless the loan was used to purchase a primary residence. Amounts borrowed are secured by the vested balance in the participant's account and bear interest at the prime rate (7.25% at December 31, 2024) plus 2%. Principal and interest are paid through bi-weekly payroll deductions.

Distribution of Benefits

Upon disability, death, retirement, or separation of service from the Company, a participant may elect to receive a lump sum payment or to have the account rolled over to another qualifying investment. The Plan may also make involuntary lump-sum distributions to terminated participants with vested account balances of \$5,000 or less. In-service withdrawals from the Plan are permitted from vested accounts by participants that have attained the age of 59 1/2 or if the participant qualifies for a hardship withdrawal.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted under certain circumstances.

Plan Termination

Although it has not expressed any interest to do so, the Company has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of plan termination, all participant accounts would become fully vested.

Plan Amendments

There were no significant amendments to the Plan during the year ended December 31, 2024.

**NOTE 2: Summary of Significant Accounting Policies**

Basis of Presentation

The accompanying financial statements have been prepared in conformity with accounting principals generally accepted in the United State of America.

Notes receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Risks and Uncertainties

Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the accompanying financial statements.

Benefit Payments

Benefits are recorded when paid.

Plan Expenses

Brokerage commissions, transfer taxes, and other charges and expenses in connection with the purchase or sale of securities are charged against the trust fund and added to the cost of such securities or deducted from the sale proceeds, as the case may be. Participants are also charged loan fees and check processing fees in certain circumstances.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments in register investment companies are reported at fair value as reported by the custodian. Purchases and sales of securities are reflected on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Subsequent Events

Subsequent events have been evaluated through October 12, 2025, which is the date the financial statements were available to be issued.

**NOTE 5: Tax Status**

The Plan adopted a prototype plan document sponsored by Great West Trust Company. Great West Trust Company received an opinion letter from the Internal Revenue Service (IRS) dated March 31, 2014, which stated that the prototype plan satisfies the applicable provisions of the Internal Revenue Cod. The Plan itself has not received a determination letter from the IRS. However, the Plan's management and tax counsel believe that the Plan is currently designed and being operated in compliance with applicable requirements of the IRS. Therefore, no provision for income taxes has been included in the accompanying financial statements.

**NOTE 6: Party-In-Interest Transactions**

The Company is the Plan sponsor. As such, transactions between the Company and the Plan qualify as party-in-interest transactions. Transactions involving notes receivable from participants also qualify as party-in-interest transactions.
