**Note 1. Description of the Plan**

***General***

The following description of White River Soy Processing LLC 401(k) Profit Sharing Plan and Trust (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by White River Soy Processing LLC (Company) for the benefit of its employees who have at least two consecutive months of service. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). For the period January 1, 2024 to July 18, 2024, Walter Cronin and Gordon Glade, employees of the Company, were the trustees of the Plan. For the period July 19, 2024 to December 31, 2024, Gordon Glade was the trustee of the Plan. For the period January 1, 2024 to July 18, 2024 T. Rowe Price Trust Company served as Plan custodian. Beginning July 19, 2024 and thereafter, Mid Atlantic Trust Company served as Plan custodian.

***Contributions***

For the period January 1, 2024 to July 18, 2024, the Plan permitted eligible employees through a salary deferral election to have the Company make annual contributions of up to 100% of their eligible compensation. For the period July 19, 2024 to December 31, 2024, the Plan permitted eligible employees through a salary deferral election to have the Company make annual contributions of up to 92% of their eligible compensation. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Company makes safe-harbor matching contributions of 100% of employees' salary deferral amounts on the first 3% of employees' compensation and an additional 50% of employees' salary deferrals on the next 2% of employees' compensation. The Company can also make profit-sharing contributions which are discretionary as determined by the Company's Board of Directors. There were no discretionary contributions made during 2024. Contributions are subject to certain limitations.

***Participant Investment Account Options***

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer 5% of eligible compensation unless the participant made an affirmative election otherwise. The automatic deferral feature also provides for an annual increase in the percentage deferred and is ultimately capped at 6%.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Participants are also immediately vested in the Company's safe-harbor contributions and discretionary profit-sharing contributions plus earnings thereon.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 47.5% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined on the first day of each month, is set at 1% above the prime rate, as defined. Principal and interest is paid ratably through payroll deductions. Interest income on notes receivable from participants was not significant in 2024.

***Payment of Benefits***

Upon termination of service due to death, disability, retirement or for other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the vested interest in their account, installments within limits determined by the trustee, or purchase an annuity contract. If a participant's total vested interest is between \$1,000 and \$5,000 upon termination of service, the balance will be automatically rolled over to an individual retirement account (IRA) designated by the Company if the participant does not consent to a cash distribution and has not elected to have the balance rolled over into an IRA of the participant's choosing. If a participant's total vested interest is less than \$1,000 upon termination of service, the balance is subject to an involuntary cash-out distribution.

Subject to certain restrictions, in-service withdrawals from a participant's account may be permitted to participants who are over the age of 59 ½, have incurred a disability, or if the participant qualifies for a financial hardship, as described in the Plan document.

As of December 31, 2024, no plan assets were allocated to accounts of terminated or retired participants who elected to withdraw from the Plan but have not yet been paid.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Contributions***

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

***Notes Receivable from Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

For the period January 1, 2024 to July 18, 2024, T. Rowe Price, an affiliate of T. Rowe Price Retirement Plan Services, Inc. served as the Plan's recordkeeper. During this time, certain Plan investments were shares of mutual funds managed by T. Rowe Price. On November 12, 2024, these assets were liquidated and transferred as part of the transition described in Note 4.

The Plan paid \$2,605 and \$1,801 of recordkeeping fees to T. Rowe Price Retirement Plan Services, Inc. and Paychex, Inc., respectively, during the year ended December 31, 2024. The Company provides certain administrative services at no cost to the Plan.

**Note 4. Plan Amendments**

Effective July 19, 2024, the Plan was amended and restated and a new trustee, administrator, recordkeeper, and custodian of the Plan were appointed. The administrator and recordkeeper transitioned from Benefit Plans, Inc. and T. Rowe Price Retirement Plan Services, Inc., respectively, to Paychex, Inc. During the transition, investment options were changed and Plan assets held by the former custodian were transferred to the new custodian effective November 12, 2024. The name of the Plan was changed from White River Soy 401(k) Plan to White River Soy Processing LLC 401(k) Profit Sharing Plan and Trust. In addition, participant loans were added to the plan, and changes were made to the definition of eligible compensation and allowable contribution rates.

**Note 5. Disclosures About Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

**Level 1** Quoted prices in active markets for identical assets or liabilities

- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

***Recurring Measurements***

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**Note 7. Tax Status**

The Plan operated under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Benefit Plans, Inc. prior to July 19, 2024. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan was designed and operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Beginning July 19, 2024, the Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Paychex, Inc. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9. Nonexempt Transactions**

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. While the Company remitted all employee contributions to the Plan, contributions of \$5,299 were not remitted within the required time period for the year ended December 31, 2024.

**Note 10. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 11. Subsequent Events**

Effective January 1, 2025, the Plan was amended to adjust the maximum deferral rate associated with the annual automatic increase to 10%.

Effective October 1, 2025, the Plan was amended and restated and a new trustee, administrator, recordkeeper, and custodian of the Plan were appointed. Delaware Charter Guarantee & Trust Company became the Plan's trustee and custodian. Benefit Plans, Inc. became the Plan's administrator. Principal Financial Group became the Plan's recordkeeper. The plan was renamed to White River Nutrition 401(k) Profit Sharing Plan and Trust. In addition, the entry date is now defined as the date the eligibility requirements are met, new loans are no longer allowed, and annuity contract distributions are no longer allowed.

Subsequent events have been evaluated through October 15, 2025, which is the date the financial statements were available to be issued.
