Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audit of the accompanying financial statements of TB Consulting 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of TB Consulting 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that was established by TBConsulting, LLC (the Employer) effective January 1, 2015. Employees are immediately eligible to participate in the Plan. The Investment Committee is responsible for the oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Employees who elect to participate in the Plan may contribute up to 90 percent of their pretax annual compensation subject to certain limitations as prescribed by the Internal Revenue Code (IRC). Participants are automatically enrolled with a 6 percent deferral withheld from their compensation as an elective deferral contribution and must opt-out to decline participation in the Plan. Rollover contributions from other qualified plans are permitted. The Plan is a safe harbor plan with a required employer match contribution of 100 percent of salary deferrals that do not exceed 1 percent of compensation, plus 50 percent of salary deferrals between 1 percent and 6 percent. No discretionary profit sharing contributions were made by the Employer for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Employer's safe harbor matching contribution, and an allocation of the Plan's earnings (losses). Participant accounts are charged with an allocation of administrative expense that is paid by the Plan. Allocations are based on participant earnings (losses) or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of \$50,000, or 50 percent of their vested account balance. Loan terms range from 1 to 5 years, with an exception for purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at prime rate plus 2 percent as determined at the time of the loan. Principal and interest are paid ratably through payroll deductions.

NOTE 1 - DESCRIPTION OF THE PLAN (continued)

Withdrawals

The government places certain restrictions on withdrawals in order to retain the special tax-saving benefits associated with the Plan. The Plan allows withdrawals at retirement, disability, separation of service, upon death, or upon termination of the Plan by the Employers. Other withdrawals are available only in cases of immediate and heavy financial hardship, subject to the Plan provisions and Internal Revenue Service (IRS) regulations.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. The Employer makes safe harbor contributions which are 100% vested after two years of service. The Plan has provisions for discretionary match and discretionary profit sharing contributions which become 100% vested to the participant's account after three years of credited service. Participants become fully vested upon reaching normal retirement age, death, or disability.

Benefit Payments

Upon termination of service, a participant's vested account will be paid in the form of a lump sum distribution. Terminated participants with account balances that do not exceed \$5,000 must take their distribution in the form of a lump sum payment within a reasonable period of time upon termination. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

Forfeited Amounts

As of December 31, 2024, forfeited nonvested accounts included in Plan assets approximated \$7,000. These accounts are generally used to offset administrative expenses and then to reduce discretionary match or profit sharing contributions. For the year ended December 31, 2024, the Plan used approximately \$60,000 forfeited nonvested accounts to reduce expenses or Employer contributions.

Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Employer contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Investments and Valuation Techniques

The Plan's investments, other than common collective trusts (CCT), are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan invests in the various CuraFin Disciplined Risk CCT funds, which are diversified models across nine core asset classes that include exposures to US equities, international equities, and fixed income. The Plan's interest in the fund is valued at the Net Asset Value (NAV) practical expedient of the underlying investments reported by the issuer of the CCT at year-end. This practical expedient would not be used if it was determined to be probable that the Plan will sell the investments for an amount different from the reported NAV. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income from investments is recorded on the cash basis, which approximates the accrual method of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Expenses

Non-investment costs, primarily accounting and administrative expenses of the plan are paid for by the Employer, which is a party-in-interest. These expenses, which are not reflected in the accompanying financial statements, constitute exempt party-in-interest transactions. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expense in the accompanying statement of changes in net assets available for benefits. Investment advisory services and certain administrative fees are paid by the Plan or charged against Plan investment activities and are included in the statement of changes in net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE 3 - FAIR VALUE MEASUREMENTS

Fair value measurements establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active and inactive markets, inputs other than quoted prices that are observable for the asset or liability for substantially the full term of the financial instrument, and inputs that are derived from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

There has been no changes in methodologies used at December 31, 2024.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 - INFORMATION CERTIFIED BY TRUSTEE (unaudited)

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting Disclosure under ERISA. Accordingly, Voya Institutional Trust Company (the Trustee), the Trustee of the Plan, has certified to the completeness and accuracy of the investments and notes receivable from participants reflected on the accompanying financial statements. The following is a summary of the information prepared and certified by the Trustee and furnished to the plan administrator as of December 31, 2024, and for the year ended December 31, 2024:

- Investments as indicated on the Statement of Net Assets Available for Benefits and Note 3;
- Investment activity and information as indicated on the Statement of Changes in Net Assets Available for Benefits; and
- Supplemental Schedule of Assets (Held at End of Year).

NOTE 5 - RELATED-PARTY TRANSACTIONS

Certain Plan investments were managed by the Trustee. Nova 401(k) Associates provide third-party administration services to the Plan. These transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for the investment management services approximated \$27,000 for the year ended December 31, 2024.

NOTE 6 - TAX STATUS

The Plan was formed using a pre-approved format by the IRS for qualification under Section 401(a). This format last received approval by the IRS on June 30, 2020. The Plan has been amended since its original formation. However, the Employer believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, qualifies under Section 401(a) and the related trust as tax-exempt as of December 31, 2024. Thus, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
