NOTE A - DESCRIPTION OF PLAN

The following description of the Didion Milling, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan of Didion Milling, Inc. (the Company or the Employer) and was established effective September 1, 1982. The Plan covers substantially all employees of the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Two officers of the Company serve as the Trustees of the Plan. Transamerica Life Insurance Company (Transamerica Life) and Reliance Trust Company (Reliance Trust) served as custodians and Transamerica Life served as recordkeeper of the Plan through June 28, 2024, at which point Transamerica Trust Company (Transamerica Trust) and Transamerica Life became the custodians and Transamerica Life continued as the recordkeeper.

Eligibility

Employees are eligible to participate in the Plan on the first day of the month following the attainment of the eligibility criteria, which is defined as reaching the age of 18 and the completion of two months of service. Eligibility to receive safe harbor Company contributions is attained upon reaching the age of 18 and completion of six months of service.

Contributions

Participants can elect to contribute up to 100% of their eligible compensation as defined by the Plan, subject to certain limitations as defined within the Internal Revenue Code (IRC). These elective contributions are specifically allocated to the account of the individual participant. Participants may also make rollover contributions to the Plan. Safe harbor Company contributions are made by the Company equal to 100% of the participant's elective contributions that do not exceed 5%.

Participant Accounts

Each participant's account is credited with the participant's elective contributions and an allocation of the safe harbor Company contribution and plan investment income. Allocations are based on participant compensation or account balances, as defined in the Plan agreement. The Plan allows participants to invest their account balances between or among separate investment funds established by the Custodians within the trust. A participant may change the rate of elective contributions and catch-up contributions on any day. Participants are subject to loan origination and annual loan maintenance fees.

Vesting

Participants are immediately vested in their elective contributions, including rollover amounts, plus actual earnings thereon, as well as the safe harbor Company contributions.

Payment of Benefits

Any benefits provided by the Plan are paid from the net assets available for benefits. The benefit to which a plan participant is entitled is the benefit that can be provided by their vested participant's account balance. The method of distribution will be determined by an election made by the Plan participant. The participant can elect a lump-sum distribution or installment payments for a specified term as defined in the Plan agreement. In-service distributions are permitted from the following accounts: elective contributions,

including rollover amounts, contributions held in a participant's qualified non-elective contribution account, and safe harbor Company contributions.

Notes Receivable From Participants

The Plan allows loans to be taken out by plan participants. These loans are secured by participants' account balances. Each participant is allowed to have a maximum of one outstanding loan at any given time. The maximum loan that can be made to a participant is an amount equal to the lesser of \$50,000 or 50% of the participant's vested account balance. The term for repayment of the loan may not exceed five years, unless the loan qualifies as a primary residence loan. The repayment period for these loans may not exceed 30 years. Principal and interest is paid ratably through payroll deductions. The interest charged to the participant shall be at a rate equal to the federal prime rate in effect on the date the loan is made plus 1.00%. The interest rate on participant loans outstanding at December 31, 2024 and 2023 ranged from 4.5% to 9.5% and 4.25% to 9.5%, respectively.

NOTE B - SUMMARY OF ACCOUNTING POLICIES

The significant accounting policies which have been consistently applied in the preparation of the accompanying financial statements follow:

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investment Valuation and Income Recognition

Except for the Plan's group annuity contract (see Note D), the Plan's investments are held by the custodians and are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan agreement. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain Plan expenses (such as investment-related fees and record-keeping fees) are recorded as an offset to investment income. Certain expenses associated with specific participant activity (such as participant loan fees) are charged directly to the participant's account and are included in administrative expenses. Unless otherwise paid by the Plan, certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

NOTE C - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The accounting framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

In accordance with the framework, the Plan groups plan assets and liabilities measured at fair value into three levels based on the markets in which the assets and liabilities are traded and the reliability of the assumptions used to determine fair value. These levels are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily quoted net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds (CTFs) - CTFs are valued at the NAV of units of a bank collective trust. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The NAV is the basis for current transactions and the collective trust funds can be redeemed at NAV as of the measurement date. Therefore, these investments have a readily determinable fair value and Level 2

pricing as they are valued similarly to mutual funds. Additionally, the NAV is available to current investors via the recordkeeper's website. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. Redemption of CTFs are generally permitted daily and there are no unfunded commitments.

NOTE D - GROUP VARIABLE ANNUITY CONTRACT

The Plan holds a group variable annuity contract with Transamerica Life totaling \$776,687 and \$1,756,329 as of December 31, 2024 and 2023, respectively. Transamerica Life maintains the contributions in a general account, which is credited with earnings and charged for participant withdrawals and administrative expenses. The fund is fully benefit responsive.

The terms of the contract require all plan permitted participant-initiated transactions involving the investment to occur at contract value with no conditions, limits or restrictions. Contract value represents contributions made, plus earnings and transfers in, less participant withdrawals, administrative expenses and transfers out. Participants direct the withdrawal or transfer of all or a portion of their investment at contract value, which approximates fair value based on observation of recent participant investments and withdrawals at contract value; however, if an event should occur, such as a significant decline in the creditworthiness of Transamerica Life, the group variable annuity contract may no longer be considered fully benefit responsive. The Company does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The account is credited with earnings based on the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable for the six-month period. There is no stated minimum or maximum interest rate for the investment choice.

NOTE E - INCOME TAX STATUS

The Company is a participating employer in the TransAmerica Volume Submitter Profit Sharing Plan with cash or deferred arrangement approved by the Internal Revenue Service (IRS). The Volume Submitter Plan obtained its latest advisory letter on June 30, 2020, in which the IRS stated that the Volume Submitter Plan, as then designed, was qualified under Section 401(a) of the IRC. The Company has determined that the Plan is eligible and has chosen to rely on the current IRS advisory letter. The Plan has been amended since the date of the advisory letter. The Company believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC in all material respects.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all amounts credited to the participants' accounts shall become 100% vested and all unallocated amounts shall be allocated to the accounts of all participants.

NOTE G - PARTY-IN-INTEREST TRANSACTIONS

All transactions between the Plan, the Trustees, the Company and the participants are considered party-in-interest transactions. The Plan held \$27,037 and \$43,198 in notes receivable from participants as of December 31, 2024 and 2023, respectively.

A majority of the costs of administering the Plan are paid directly by the Company, and are excluded from these financial statements. These costs include administrative costs and audit fees and are insignificant to the total net assets of the Plan.

Certain plan investments are managed by Transamerica Life or affiliates thereof. Transamerica Life is the recordkeeper as defined by the Plan and, therefore, any transactions with Transamerica Life qualify as party-in-interest transactions.

NOTE J - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued. The Plan is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
