## Independent Auditors' Report

To Plan Administrator and Plan Participants

### *Opinion*

We have audited the financial statements of MassMutual Employee Welfare Benefits Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits (modified cash basis) of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits (modified cash basis) for the year ended December 31, 2024, in accordance with the modified cash basis of accounting described in Note 2.

### *Basis for Opinion*

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### *Emphasis of Matter – Basis of Accounting*

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than U.S. generally accepted accounting principles. Our opinion is not modified with respect to this matter.

### *Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## Notes to Financial Statements (Modified Cash Basis)

### 1. Description of Plan

The following is a brief description of the MassMutual Employee Welfare Benefits Plan (the Plan) provided for general information purposes only. The Plan document should be consulted for a more complete description of the Plan's provisions.

#### *a. General*

The Plan is subject to the provisions of ERISA, as amended.

#### *b. Benefits*

The Plan provides benefits including medical, dental, vision, healthcare flexible spending account (FSA), disability, life insurance and limited legal services to eligible employees and their covered dependents.

Eligible employees are individuals who are regularly scheduled to work at least 20 hours per week for Massachusetts Mutual Life Insurance Company (the Company) or a participating subsidiary (Participating Affiliate). Eligible employees may participate in the Plan on the first day of employment.

#### *c. Contributions*

The contributions required to provide benefits and coverage for eligible participants are made by:

- the Company and/or a Participating Affiliate;
- the participant; or
- a combination of the Company, Participating Affiliate, and the participant.

#### *d. Amendment or Termination of the Plan*

The Plan was amended effective January 1, 2024, to:

- Extend the election period for those who lose Medicaid or Children's Health Insurance Program (CHIP) coverage,
- remove the 30 hour minimum eligibility requirement for Ascend employees, and
- update the coverage option attachments.

The Plan was also amended effective June 1, 2024 to update the life insurance coverage provisions applicable to Glidepath Holdings Inc. employees.

The trust used to fund some benefit options under the Plan, the MassMutual Employee Health Benefits Trust (EHBT), was terminated effective December 31, 2024 by action of the Company's board of directors.

Although the Company has not expressed any intent to discontinue the Plan, the Company reserves the right to amend or terminate the Plan at any time subject to the requirements set forth in ERISA. In the event of termination of the Plan, all eligible claims incurred prior to termination would be considered for payment on an equivalent basis and the Company shall be required to fund any deficiency in net assets available for benefits.

### 2. Summary of Significant Accounting Policies

#### *a. Basis of Accounting*

The financial statements of the Plan are prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than U.S. generally accepted accounting principles (U.S. GAAP).

The modified cash basis of accounting is a cash receipts and disbursements method of accounting. Contributions, interest income, expenses, benefits paid, and payments to insurance carriers to provide benefits are recorded when received or paid. Although a modified cash basis of accounting represents a departure from U.S. GAAP, it is an allowable method of accounting for employee benefit plans filing under the reporting requirements of ERISA.

#### ***b. Use of Estimates***

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from these estimates.

#### ***c. Disclosure for Incurred but Not Reported Claims***

The disclosure for incurred but not reported claims (IBNR) is an estimated liability actuarially determined based on the average number of participants and their dependents, economic trends, past claims experience, and other related factors. The reserves are not discounted, as payments are expected to be made within a one-year period.

#### ***d. Cash and Cash Equivalents***

The cash account is held in the MassMutual EHBT. The EHBT was dissolved effective December 31, 2024, by action of the Company's Board of Directors. The cash account was closed. The remaining cash balance before dissolution of \$212 was used to prepay Cigna administrative expenses

As of December 31, 2024, all expenses of the Plan (other than benefits paid under insurance policies providing plan benefits) are paid from the Company's general assets.

#### ***e. Imprest Account***

The imprest account is a non-interest-bearing bank account used by the Plan's third-party administrator to make benefit payments. Prior to December 31, 2024, certain Company, Participating Affiliate and participant contributions were transferred from the EHBT to an imprest account established in the name of the Plan. Following the termination of the EHBT, the funds necessary to pay benefits are transferred directly from the Company's general assets to an imprest account.

### **3. Administration of Group Life and Disability Insurance Policies and Medical FSA (in thousands)**

The life insurance premiums which cover active employees and retired participants under age 65 are paid by the Company from its general assets, the general assets of Participating Affiliates, and amounts contributed by participants. The amounts reported in the Plan include only active participants. During 2024, the Company, Participating Affiliates, and participants paid insurance premiums of \$5,126.

Long-term disability premiums are paid by the Company and Participating Affiliates, as well as by participants. During 2024, the Company, Participating Affiliates, and participants paid insurance premiums of \$2,899.

Medical FSA contributions are made by participants. The Medical FSA contributions made during 2024 was \$1,077. The amount paid to participants during 2024 was \$1,027. In 2024, \$68 was forfeited by the participants.

### 5. Administrative Expenses

Administrative expenses consist of monthly fees paid or prepaid by the Plan or the Company for the processing of health, disability and life claims, coordination of benefits and financial reporting, and cost containment fees paid upon successful negotiation of discounts when an out-of-network provider is utilized.

### 6. Related Party Transactions (Parties-in-Interest)

MassMutual Trust Company, FSB (now MassMutual Private Wealth & Trust, FSB), a subsidiary of the Company and a Participating Affiliate, was the discretionary trustee of the EHBT. All trustee fees associated with the EHBT were paid from the general assets of the Company; the Plan and its participants did not pay any part of the trustee expenses.

The Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA. However, they are exempt from the prohibited transaction rules of ERISA.

#### **7. Trust and Tax Status**

The net assets available for benefits are held in the EHBT, which was established on December 9, 1987. The EHBT is exempt from federal income tax under Section 501(a) of the Internal Revenue Code (IRC) as a Section 501(c)(9) organization. Accordingly, the EHBT's corpus and net investment income are exempt from income taxes. The EHBT obtained a favorable tax determination letter, dated September 15, 1989, from the Internal Revenue Service (IRS). The Company believes that the EHBT, as amended, is qualified as Section 501(c)(9) organization and operated in compliance with the applicable provisions of the IRC.

To the extent the EHBT recognized any "unrelated trade or business" income as defined in Section 512 of the IRC, the EHBT is required to pay tax at trust income tax rates on any such income. This tax, if applicable, is paid by the Company on behalf of the EHBT. In 2024 and 2023, no unrelated trade or business income tax was due.

The EHBT was dissolved effective December 31, 2024.

The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

Plan management evaluates tax positions taken by the Plan and recognizes a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require disclosure in the financial statements.

#### **8. Risks and Uncertainties**

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

#### **9. Subsequent Events**

The Plan was amended effective January 1, 2025 to:

- incorporate outstanding amendments;
- eliminate references to the EHBT, which terminated on December 31, 2024, and update the Plan's provisions regarding payment of benefits accordingly;
- clarify certain enrollment provisions pertaining to Medicare and CHIP-driven changes in status;
- reflect The MassMutual Trust Company, FSB name change to MassMutual Private Wealth & Trust; and
- update the coverage schedules.

The Plan was also amended effective June 1, 2025 to add Artemis Real Estate Holdings, LLC as a Participating Affiliate and update the coverage option attachments

The Plan has evaluated events subsequent to December 31, 2024 and through October 14, 2025, the date the financial statements were available to be issued, noting there are no other subsequent events requiring adjustment or disclosure in the financial statements.
