The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America.

### Note 1. Description of the Plan

The following brief description of the Palmetto Goodwill Services Health and Welfare Plan (the "Plan") provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

#### General:

The Plan is a health and welfare plan covering substantially all employees of Palmetto Goodwill and Palmetto Goodwill Services (the "Plan Sponsor" or "Company") who meet the eligibility requirements described below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is established to provide health and other benefits to eligible employees of the Plan Sponsor. The Plan is administered through the Palmetto Goodwill Services Health and Welfare Plan Trust ("Trust"). The Trust is established to receive and hold funds contributed by the Plan Sponsor and participants. All of the Trust's assets are available for the payment of Plan benefits and are to be used for the sole and exclusive benefit of the Plan's participants. The Trust is intended to constitute a Voluntary Employee Beneficiary Association ("VEBA") within the meaning of Section 501(c)(9) of the Internal Revenue Code (the "Code"). Oversight of the Plan's activities is provided by the Company's Plan Administrator. The Company has contracted with Bank of America to serve as trustee (the "trustee") of the VEBA. The plan has contracted with GSA National ("GSA") to provide administrative services to the VEBA.

#### Plan amendment:

Effective January 1, 2024, the Plan was amended to make all benefits fully insured.

#### Eligibility:

All full-time employees working 30 hours or more per week on average and part-time employees that are not subject to a prevailing wage contract are eligible for health and other benefits in the Plan on the first day of the month following 60 days of continuous employment. Participants will receive coverage for any month in which they remain eligible for the Plan and for which the Plan's sponsor makes contributions to the Plan on their behalf. The participant's coverage will end at midnight on the last day of the month in which eligibility ceases.

#### Benefits and self-insured benefits:

The Plan provides health benefits (medical, dental, vision, prescription drug coverage), disability benefits, employee assistance benefits, life and accidental death, and dismemberment insurance for eligible employees and their eligible dependents. The Plan also provides for continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act ("COBRA"). As of January 1, 2024, all benefits are fully insured. During 2023, dental and short-term disability benefits for employees covered by the Service Contract Act ("SCA") were on a self-insured basis while all other benefits are fully insured. The claims for self-insured dental benefits were processed by Delta Dental and short-term disability was processed by Sunlife, the Plan's third-party claims processors, under administrative services only agreements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the trust or general assets of the Company. Premiums for medical, vision, disability are paid to insurance companies from the general assets of the Company, or for participants covered by the SCA, from assets of the VEBA trust.

### Note 1. Description of the Plan, Continued

#### Health reimbursement arrangement and Flexible Spending Account:

The Plan has a FSA for employees, and an HRA for employees covered under the SCA, which allow eligible participants to be reimbursed tax free for qualified medical expenses subject to a specified ceiling set by the Company annually subject to Internal Revenue Code limits. Participants are eligible to contribute through payroll deduction on behalf of dependents to be enrolled in the Plan.

#### Contributions:

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. For participants covered under the SCA, the Company contributes an amount based on hourly fringe rates set by the Department of Labor, multiplied by hours worked by Plan participants. Premiums for participation are withheld from the participant's paychecks. The Plan Sponsor directs the payment of contributions to the Trust to fund claims and expenses in excess of participant's contributions. Any deficiency of the Plan's net assets over benefit obligations is funded through Plan Sponsor contributions on a pay-as-you-go basis.

#### Trust:

The Plan Sponsor established the Palmetto Goodwill Services Trust for participants covered under the SCA. All activity related to these participants are covered in the trust account.

### Note 2. Summary of Significant Accounting Policies

#### Basis of accounting:

The financial statements of the Plan have been prepared on the accrual basis of accounting.

#### Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment provider. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

### Note 2. Summary of Significant Accounting Policies, Continued

#### Contributions receivable:

Plan sponsor and participant contributions due and not paid prior to year-end are recorded as contributions receivable.

#### Prepaid insurance premiums:

Some non-trust administrative expenses are paid prior to the year-end and are recorded as prepaid expenses. Prepaid administrative expenses totaled \$287,775 and \$0 as of December 31, 2024 and 2023, respectively.

#### Payable to Palmetto Goodwill 401(k) Plan:

Any excess funds are maintained on a per participant basis in a premium reserve account and are used to pay future benefit costs. Excess funds that are deemed to not be required to pay future benefit costs are remitted to the participant's 401(k) retirement plan. Payables to Palmetto Goodwill 401(k) Plan totaled \$170,535 and \$93,922 as of December 31, 2024 and 2023, respectively.

#### Payment of benefits:

Claim payments were recorded when paid by the third-party claims processor and were reported in the statement of changes in net assets available for benefits. Amounts due to claims processors that have yet to be reimbursed by the Plan, if any, were recorded as payable to claims administrators in the accompanying statements of net assets available for benefits.

#### Administrative expenses:

The Plan pays administrative expenses that consist of premium fees paid to third-party claims administrators and the trustee. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Plan Sponsor on behalf of the Plan.

#### Subsequent events:

Management of the Plan has evaluated subsequent events through October 15, 2025, which is the date these financial statements were available to be issued.

#### Recently issued accounting pronouncements:

Accounting standards that have been issued or proposed by the Financial Accounting Standards Board (FASB) or other standards-setting bodies are not expected to have a material impact on the Plan's net assets or changes in net assets.

### Note 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual fund: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded; therefore, Plan management has assessed these assets as Level 1 in the fair value hierarchy.

### Note 4. Related Party and Party-in-Interest Transactions

The Plan's investments are managed by Bank of America, N.A. Bank of America, N.A. is the trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan made direct payments to several insurance companies and various service providers for claims administration and processing. Certain administrative expenses related to administration of the Plan were paid by the Plan or by the Plan Sponsor. Administrative expenses paid by the Plan for these fees totaled \$129, 485 and \$161,042 as of December 31, 2024 and 2023, respectively.

### Note 5. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, and can discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. If such termination occurs, all balances in the Plan shall be maintained by the Plan Sponsor until such time as the assets of the Plan have been distributed in accordance with the principal purpose of the Plan.

### Note 6. Tax Status

The Plan and the Trust are required to operate in conformity with the Internal Revenue Code ("IRC") to maintain tax-exempt status of the Trust. The Trust obtained an exemption letter dated April 20, 2020, from the Internal Revenue Service ("IRS"), and the Plan Sponsor believes that the Trust, as amended, qualifies and operates in accordance with the applicable requirements of the Code. However, as a result of the Plan's funding policy, from time to time the Trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 and 2023 for unrelated business taxable income, and Plan management believes no liability for unrelated business taxable income has been incurred.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the 2024 statement of net assets available for benefits.
