Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Communications Group 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN AND SUMMARY OF ACCOUNTING POLICIES

The following description of The Communications Group 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan is a defined contribution profit-sharing plan covering all eligible employees of The Speech Pathology Group, Inc. (the “Company”), Autism Intervention Services, LLC, Comprehensive Autism Center, LLC and ABRITE, A Speech Pathology Corporation (“ABRITE”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and Section 401(a) of the Internal Revenue Code (“IRC”). The Company has contracted John Hancock Life Insurance Company (“John Hancock”) to act as the Plan custodian and with an independent third-party administrator to perform certain administrative duties. The Plan was adopted effective January 1, 1998, to provide benefits to eligible employees as defined in the Plan document. The following employees are not eligible to participate in the Plan: Collective Bargaining Employees and Non-Resident Aliens. All other employees of the Company who have attained the age of twenty-one are eligible to participate in the Plan. The Plan was last restated effective January 1, 2021, and amended effective June 30, 2024, to include ABRITE as a member of the controlled group and to update the definition of service credit for vesting purposes.

Basis of Accounting – The Plan’s financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates - The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from these estimates.

Plan Termination and Modification - The Company intends to continue the Plan indefinitely for the benefit of its employees. However, it reserves the right to terminate or modify the Plan at any time by resolution of its Board of Directors and subject to the provisions of ERISA. In the event the Plan is terminated in the future, participants would become fully vested in their accounts.

Participant Contributions - Each year, participants may contribute a minimum of 3% of their pre-tax annual compensation, as defined in the Plan, up to a maximum allowed by law. Participants who have attained the age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

Employer Contributions – The Company contributes matching contributions to the Plan each payroll period equal to 50% of the participant’s deferral, not to exceed 6% of the participant’s compensation. In addition, the Company may elect to make discretionary profit-sharing contributions to the Plan. Participants direct the investment of matching Company and profit-sharing contributions. Participants must be attained the age of twenty-one, complete a minimum of 1,000 hours of service during the Plan year and be employed on the last day of the Plan year to share in Company profit-sharing contributions.

For the year ended December 31, 2024, the Company made employer contributions totaling \$1,141,568 to the Plan, and did not make any profit-sharing contributions to the Plan.

Participant Accounts – A separate account is maintained for each participant. Each participant’s account is credited with the participant’s voluntary contributions, employer contributions and an allocation of Plan earnings, less withdrawals, distributions and administrative expenses, if any. Participants direct the investment of their contributions into the various investment options offered by the Plan. Investment income allocations are made daily based on participant account balances. The benefit to which a participant is entitled is limited to the benefit that may be provided from the participant’s vested account balance.

Investment Income – Realized gains or losses on investment transactions are recorded as the difference between the proceeds received and the fair value of the investment at the beginning of the Plan year, or cost if acquired during the Plan year. In accordance with the Plan’s policy of stating investments at fair value, net appreciation or depreciation consists of both realized and unrealized gains and losses and is included in the statement of changes in net assets in the period in which the market change occurs. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date.

Vesting – Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company’s matching and profit-sharing contributions, if any, plus actual earnings thereon, is based on years of service. Participants do not become vested in the Company’s matching or profit-sharing contributions until they have completed at least two years of service during which they have contributed at least 1,000 hours each year. Participants become fully vested in the Company’s matching and profit-sharing contributions ratably over a six-year period. Participants also become fully vested in all accounts upon retirement, death, disability or Plan termination.

Forfeited Accounts – Forfeited non-vested accounts may be used to first pay administrative expenses of the Plan and then reduce future employer contributions. As of December 31, 2024 and 2023, the Plan had unallocated forfeitures of \$304,323 and \$107,975, respectively. During 2024, forfeitures totaling \$94,879 were used to pay administrative expenses of the Plan.

Notes Receivable from Participants - The Plan provides a provision that allows a participant to borrow a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance. Such loans shall bear interest at fixed rates equal to the published prime rate, plus one percent. The term of the loans cannot exceed five years, except if the loan proceeds are used to finance the purchase of a primary residence, in which case the loan term may not exceed fifteen years. The loans are secured by the participant's vested account balance. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants are stated at their unpaid principal balances plus any accrued but unpaid interest. Any participant defaults are deemed taxable distributions to the participant.

Payment of Benefits – Benefits are recorded when paid. Participant account balances can be distributed prior to termination or retirement age for hardship claim, death or disability as defined in the Plan agreement. On termination of service due to death, disability or retirement, a participant will receive an amount equal to the value of the vested interest in their account. For termination of service due to other reasons, a participant may also receive the value of the vested interest in their account as a lump-sum distribution.

The normal retirement age under the Plan is age 65. Participants who have reached age 59 ½ may take an in-service distribution subject to the Plan's provisions.

Administrative Expenses – Certain expenses of maintaining the Plan are paid by directly by the Company and are excluded from the Plan's financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

Excess Contributions Payable – Represents excess salary deferral contributions to be refunded to participants whose contributions during the Plan years ending December 31, 2024 and 2023 exceeded the maximum allowable limit imposed by the Plan's provisions and ERISA. As of December 31, 2024 and 2023, excess salary deferral contributions payable totaled \$32,376 and \$7,417 respectively.

Subsequent Events - The Plan's management evaluates events or transactions occurring after the statement of net assets available for plan benefits date but before the financial statements are available to be issued for potential recognition or disclosure. The financial statements include all subsequent events considered necessary for a fair presentation.

2. FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

Pooled Separate Accounts: Valued at the net asset value (“NAV”) of units of an insurance company’s separate account. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

In accordance with ASC 820, since NAV is used as a practical expedient to estimate fair values, the Plan's investments are not classified using the aforementioned levels within the fair value hierarchy of U.S. GAAP as of December 31, 2024 and 2023.

The Plan's method of valuing investments may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

3. INCOME TAX STATUS

On June 30, 2020, the IRS stated that the prototype adopted by the Plan, as then designed, qualifies under the Internal Revenue Code 401(a). The Plan has not received a determination letter specific to the Plan itself; however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and believes that the Plan was qualified as of December 31, 2024 and 2023. Therefore, no provision for income taxes has been included in the Plan's financial statements.

4. CERTIFIED INFORMATION

In accordance with 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, John Hancock certified the fair values of assets held at December 31, 2024 and 2023, and investment activities for the year ended December 31, 2024, that were used in the preparation of the accompanying financial statements and ERISA-required supplemental schedules. The following information was obtained by management and agreed to or derived from information certified as complete and accurate and was not audited by independent certified accountants:

5. RISKS AND UNCERTAINTIES

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the risk associated with certain investment securities, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Financial instruments, which potentially subject the Plan to concentrations of credit risk, consist of pooled separate accounts offered by the Plan. As the portfolio is well diversified and issuers of the underlying securities are dispersed throughout many industries and geographies, the concentrations of credit risk are limited.

6. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by John Hancock, the Plan's custodian. Any purchases and sales of these investments are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

7. NONEXEMPT TRANSACTIONS

During 2022 and 2021, employee salary deferral contributions totaling \$280,101 and \$10,893, respectively, were not remitted to the Plan in a timely manner. The Plan Sponsor is aware of the untimely remittances and intends to correct this situation by remitting lost earnings to the accounts of the affected participants during 2025.

8. SUBSEQUENT EVENTS

In connection with the Plan amendment to add ABRITE to the controlled group effective June 30, 2024, participant account balances from ABRITE were transferred to the Plan beginning in January 2025.

Events or transactions occurring subsequent to year end through the date the financial statements were available to be issued, October 10, 2025, have been evaluated in the preparation of the accompanying financial statements.
