### **Note 1 - Description:**

The following description of the 401(k) Profit Sharing Plan for Employees of Almaden Country Day School (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan that was established September 1, 1997 and most recently amended and restated effective January 1, 2022. The Plan is sponsored and administered by Almaden Country Day School (the "School") (the "Employer") to provide benefits to eligible employees, as defined in the Plan document. The Plan is a 401(k)-plan invested in separate account funds and a general account fund. The Plan Administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code (IRC) and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Eligibility

All employees are eligible to make pre-tax compensation deferrals in the Plan on the first day following the date of employment. To be eligible to participate in the employer matching contributions a participant must have attained the age of 21.

#### Contributions

Eligible employees may contribute up to 100% of pretax annual compensation, as defined by the Plan, up to the maximum allowed under current income tax regulations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants are also allowed to make Roth deferral contributions and rollover contributions from other tax-qualified, employer-sponsored retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participants' directives and the Plan's provisions.

The Plan has an automatic deferral provision in which the Plan will automatically withhold 3% from the eligible compensation on a pre-tax basis. Participants may stop or change the automatic contribution feature before it commences.

The Plan also provides employer matching contributions using a discretionary formula. During 2024, the employer approved approximately \$290,000 matching contributions.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, the participant's qualified rollover contributions, allocations of employer contributions, Plan earnings or losses, and charged with an administrative expense. Allocations are based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are immediately vested in their contributions (including rollover contributions) plus actual earnings thereon. Vesting in the employer's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after 3 years of credited service.

### Participant Investment Options

Upon enrollment in the Plan, participants may direct their contributions and the School's contributions to any of the selected investment choices made available through the Mutual of America Group Annuity Contract. Participants may change their investment options at any time throughout the year via Mutual of America Life Insurance Company's (Custodian) direct access internet website.

### Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested interest in the participant's account. The Plan allows two loans per participant. The term of the loan shall not exceed five years except in the case of a loan for the purpose of purchasing the principal residence of the participant, in which case the term for repayment may be over a period no longer than ten years. Repayment of loan principal and interest must be made either by check or through payroll deductions. The interest rate is determined by the Plan Administrator based on the prime rate plus 1%. The loans are secured by the remaining balance in the participants' respective accounts. As of December 31, 2024, there are no outstanding loans under the Plan. There was one loan outstanding as of December 31, 2023.

### Payment of Benefits

Upon termination of service due to death, disability, termination of employment or retirement, a participant may elect to receive a lump-sum amount, installment payments or a combination of both equal to the value of the participant's vested interest in his or her account. Upon termination, a balance of less than \$1,000 will be paid in a lump-sum amount. The Plan allows for hardship withdrawals from all vested accounts. There were no participant requests to withdraw from the Plan as of December 31, 2024 or 2023 that had not been paid as of those dates.

### Forfeitures

Forfeitures are the nonvested portion of a participant's account that is lost upon termination of employment. At December 31, 2024 and 2023, the forfeited non-vested account balances totaled \$18,436 and \$12,810, respectively. The forfeited amounts may be used to reduce future employer contributions or pay certain plan expenses. During 2024, the Plan used forfeitures of \$8,901 to reduce employer matching contributions.

### Plan Custodian

Mutual of America Life Insurance Company serves as the Custodian and the record keeper for the Plan. All of the Plan's assets are held by the Custodian.

### **Note 2 – Summary of Significant Accounting Policies:**

#### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments of the Plan are held by the Custodian and invested based solely upon instructions received from participants. The Plan's investments are reported at fair value as of the last day of the Plan year. Fair value is the price that could be received to sell assets or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net appreciation (depreciation) in fair value of investments includes both the unrealized appreciation (depreciation) of investments and realized gains and losses on the sale of investments.

The market volatility of equity-based investments may substantially impact the value of such investments at any given time. It is likely that the value of the Plan's investments, both in total and in individual participant accounts, has fluctuated since December 31, 2024.

Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, such management fees and operating expenses are reflected as a reduction of net appreciation (depreciation) in fair value of investments.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

### Contributions

Contributions from Plan participants and the School are recorded in the year in which participant compensation is earned.

### Benefits to Participants

Benefits to participants are recorded when paid.

### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the School. Expenses that are paid by the School are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

### Subsequent Events

The Plan administrator evaluated subsequent events from December 31, 2024 through October 15, 2025, the date the financial statements were available to be issued, and has determined that there were no material subsequent events that required recognition or additional disclosure in the financial statements.

### **Note 3 – Certified Information:**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held as of December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America Life Insurance Company (the Custodian of the Plan).

### Note 4 - Fair Value Measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Separate account funds:* Separate account funds held with Mutual of America are valued at the Accumulation Unit value of each Investment Fund as reported by Mutual of America, based on the market value of the underlying mutual fund. The value of each Investment Fund's Accumulation Unit reflects the income, gains, and losses of the underlying mutual fund, before giving effect to any additions, withdrawals, or transfers. The Accumulation Unit Value is a net asset value (NAV) equivalent. Certain withdrawals under the contract are subject to a withdrawal charge.

*General account funds:* Valued at guaranteed principal balance and interest (redeemable value), which approximates fair value.

### **Note 5 - Related Party and Party-in-Interest Transactions:**

Certain Plan investments are managed by the Custodian or affiliates of the Custodian. Such arrangements, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Certain administrative functions are performed by officers or employees of the School. No such officer or employee receives compensation from the Plan. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the School.

### **Note 6 - Plan Termination:**

Although the School has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, all participants will become 100% vested in their entire account balance including the School's contributions.

### **Note 7 - Tax Status:**

The Plan has adopted a non-standardized defined contribution pre-approved plan sponsored by Mutual of America Financial Group (MOA). MOA has received a favorable opinion letter dated November 30, 2020 from the IRS as to the form of the plan being acceptable under Section 401 of the IRC. This opinion on the acceptability of the form of the plan is not a ruling or determination as to whether the Plan qualified under Code section 401(a). The Plan has been amended and restated since MOA received the opinion letter. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

### Note 8 - Risks and Uncertainties:

The Plan provides for various investment options in any combination of the investments offered by the Plan. Investment securities are exposed to various risks, such as interest rates, market fluctuations and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

Mutual of America Clear Passage 2030 Fund represented 15% and 17% of Plan assets at December 31, 2024 and 2023, respectively.

Mutual of America Clear Passage 2035 Fund represented 13% and 11% of Plan assets at December 31, 2024 and 2023, respectively.

### Note 9 - Prohibited Transactions:

During 2024, the School inadvertently failed to deposit approximately \$38,000 of participant contributions within the required timeframe as stated by the United States Department of Labor regulations. The School identified and corrected the matter during 2024. The amount of lost income was deemed immaterial to the financial statements as of December 31, 2024.
