## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants of the Upstream 401(k) Plan:

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of the Upstream 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). ## **Emphasis of Matter - Terminating Plan and Liquidation Basis of Accounting**

As further discussed in Note 1 to the financial statements, management of the Employer formally terminated the Plan on September 4, 2024 and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the ongoing basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audits of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. ### NOTES TO FINANCIAL STATEMENTS FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

---

#### 1. DESCRIPTION OF PLAN

The following description of the Upstream 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provision

General - The Plan is a defined contribution plan covering all employees of Pioneer APCO LLC, UpStream Pharmaceutical Care LLC, and UpStream Care Company (collectively, the “Employer”) who are age eighteen or older and are not classified as union employees, leased employees or non-resident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Retirement Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan’s investment offerings, and monitors investment performance.

Effective February 16, 2024, the name of the Plan was changed from the Pioneer APCO, LLC 401(k) Plan to the Upstream 401(k) Plan. In addition, effective February 16, 2024, the Plan was amended and restated, and a new custodian, administrator, and record keeper were appointed. Plan assets transferred to the new custodian were transferred into funds comparable to those offered by the previous custodians.

By action of management, the Employer adopted a resolution on September 4, 2024 to terminate the Plan effective September 30, 2024 and all participant accounts became 100% vested. Participants were permitted to choose amongst several options regarding the type of distribution, including lump sum payment or individual retirement account rollover.

Contributions - Each year, participants may contribute up to 100% of their annual eligible compensation, as defined in the plan document. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Employer makes safe harbor matching contributions to the Plan in an amount equal to 100% of the first 3% that a participant contributes to the Plan and 50% of the next 2% of compensation that a participant contributes to the Plan. Additional nonelective amounts may be contributed at the option of the Employer. For the years ended December 31, 2024 and 2023, the Employer did not make any discretionary nonelective contributions to the Plan. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

Participant Accounts - Each participant’s account is credited with the participant’s contributions and the Employer’s safe harbor matching contributions, as well as allocations of the Employer’s discretionary nonelective contributions and the Plan’s earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting - Participants are vested immediately in their contributions and the Employer’s safe harbor matching contributions, plus actual earnings thereon. Vesting in the Employer’s discretionary nonelective contributions plus actual earnings thereon is based on years of service. If a participant terminates employment prior to normal retirement age for any reason, other than death or permanent disability, the participant’s interest in the Employer’s discretionary nonelective contributions vests 20% after two years of service, increasing 20% each succeeding year until fully vested after six years of service.

Notes Receivable from Participants - Participants were permitted to borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant’s account. The loan interest rate, determined quarterly, was set at 1% above the prime rate, as defined in the plan document. Principal and interest were paid ratably through payroll deductions.

Payment of Benefits - On termination of service due to death, disability, retirement, or for some other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. The Plan permits in-service and hardship withdrawals under certain conditions.

Forfeited Accounts - As of December 31, 2024 and 2023, there were no forfeited nonvested accounts available for future use. During the year ended December 31, 2024, there were no forfeited nonvested accounts used to reduce the Employer's contributions. During the year ended December 31, 2023, forfeited nonvested accounts of approximately \$5,000 were used to either reduce the Employer's contributions or pay the Plan's administrative expenses.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - As of and for the year ended December 31, 2023, the financial statements have been prepared on the ongoing basis of accounting under the accrual method. Effective September 4, 2024, management of the Employer adopted a resolution to terminate the Plan. As a result, the Plan's financial statements for the year ended December 31, 2024 have been prepared on the liquidation basis of accounting in accordance with generally accepted accounting principles in the United States of America ("GAAP"). This basis of accounting is considered appropriate when, among other things, liquidation of the Plan is probable, and the net realization of assets are reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realized cash value and liabilities are stated at their anticipated settlement amounts.

Use of Accounting Estimates - The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

Investment Valuation and Income Recognition - Investments are reported at fair value, with the exception of the Plan's guaranteed investment contract. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. See Note 4 for disclosure of fair value measurements. The guaranteed investment contract is valued at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 5 for disclosure of the guaranteed investment contract. The Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, and Empower Annuity Insurance Company of America, Empower Trust Company and Fidelity Management Trust Company, the Custodians of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions - Contributions from participants are recorded as they are withheld from the participants' wages. Contributions from the Employer are recorded in the period in which the related participant contributions are due.

Notes Receivable from Participants - Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Prior to the Plan's termination, if a participant ceased to make loan repayments and management deemed the participant loan to be in default, the participant loan balance was reduced, and a benefit payment was recorded.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events - Management has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

### 3. INFORMATION CERTIFIED BY CUSTODIANS

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023 and for the years then ended, included in the financial statements and the ERISA-required supplemental schedules, that was prepared by, or derived from, information prepared by Empower Annuity Insurance Company of America and Empower Trust Company for the period from January 1, 2023 through February 15, 2024 and Fidelity Management Trust Company for the period from February 16, 2024 through December 31, 2024 and furnished to management. Management has obtained certifications from the Custodians that such information is complete and accurate as of and for the years ended December 31, 2024 and 2023.

### 4. FAIR VALUE MEASUREMENTS

GAAP provides the framework for measuring fair value by utilizing a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under GAAP are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Interest-bearing cash: Valued at the stated bank account balance at year end.

Collective trust funds: Valued at the net asset value ("NAV") of units of bank collective trusts. The NAV, as provided by the Empower Trust Company, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less their liabilities. This practical expedient is not used when it is determined to be probable that the funds will sell the investment for an amount different than the reported NAV.

Pooled separate accounts: Valued at the NAV of units of pooled separate accounts. The NAV, as provided by the Empower Annuity Insurance Company of America, is used as a practical expedient to estimate fair value. Pooled separate accounts are invested via group annuity contracts issued by Empower Annuity Insurance Company of America. Assets are represented by a "unit of account." The redemption value of those units is based on a per unit value whose value is the result of the accumulated values of underlying investments. The underlying investments are valued in accordance with the corresponding valuation method for the investments held. This practical expedient is not used when it is determined to be probable that the accounts will sell the investments for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management believes the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement as of the reporting date.

As of December 31, 2023, all investments held by the Plan are collective trust funds and pooled separate accounts, which are valued at the NAV of units held by the Plan at year-end. In accordance with GAAP, the requirement to categorize investments within the fair value hierarchy for which fair value is measured using the NAV per share as a practical expedient has been removed. Accordingly, as of December 31, 2023, no investments held by the Plan are required to be categorized within the fair value hierarchy.

The investment objectives of investments that do not directly file a Form 5500 with the Department of Labor by asset class are as follows:

Large Cap - The funds seek long-term growth of capital and income by investing primarily in common stocks of companies that appear to offer superior opportunities for capital growth and most which have a history of paying dividends.

International - The funds seek capital growth by investing in equity securities of companies located in emerging market countries. The funds emphasize investments in equities but may also invest in debt securities.

Mid/Small Cap - The funds seek long-term capital appreciation by investing in equity securities of medium-capitalization and small-capitalization companies. The principal type of equity security in which the fund invests is common stock.

Fixed Income - The funds seek to maximize current income; long-term capital appreciation is a secondary objective by investing in high yield debt and related securities.

Real Estate - The funds seek long-term capital appreciation by investing in readily marketable equity securities of companies whose principal activities include ownership, development, construction, or sale of residential, commercial or industrial real estate.

#### 5. GUARANTEED INVESTMENT CONTRACT

The Plan has a fixed annuity contract with Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America maintains the Plan's investment in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed and reset on a quarterly basis. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower Annuity Insurance Company of America, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Employer or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participant.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation and (4) a material amendment to the agreement without the consent of the issuer.

#### 6. RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain investments of the Plan are managed by the Custodians. These transactions qualify as exempt party-in-interest transactions.

As described in Note 1, the Plan permitted participants to borrow from their account balances. These transactions qualified as exempt party in interest transactions.

#### 8. TAX STATUS

On June 30, 2020, the IRS stated that the prototype plan adopted by the Plan, as then designed, qualifies under Internal Revenue Code ("IRC") Section 401(a). The Plan has not received a determination letter specific to the Plan itself; however, management and the Plan's tax counsel believe that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC and, therefore, that the Plan is qualified and the related trust is tax exempt.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. Management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits of any tax periods in progress.

#### 9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

10. PROHIBITED TRANSACTIONS

During the year ended December 31, 2023, the Employer made remittances of participant contributions totaling \$134,432 that were in excess of the time period described by the Department of Labor's Rules and Regulations. The delay in remitting the contributions was due to an administrative error. During the year ended December 31, 2024, management fully corrected these delinquent contributions.
