## Independent Auditors' Report

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than U.S. generally accepted accounting principles. Our opinion is not modified with respect to this matter.

### *Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.



### *Auditors' Responsibilities for the Audit of the Financial Statements*

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## Notes to Financial Statements, (Modified Cash Basis)

### **1. Description of Plan**

The following is a brief description of the MassMutual Agents' Welfare Benefits Plan (the Plan) provided for general information purposes only. The Plan document should be consulted for a more complete description of the Plan's provisions.

#### ***a. General***

The Plan is subject to the provisions of ERISA, as amended.

#### ***b. Benefits***

The Plan provides benefits including medical, dental, vision, healthcare flexible spending account (FSA), disability, life insurance and limited legal services benefits to eligible agents and their covered dependents.

Eligible agents are individuals with active career agent or general agent contracts endorsed by the Company (including sales managers) or general manager employed by Massachusetts Mutual Life Insurance Company (the Company). General agents and general managers are not eligible to participate in the FSA.

#### ***c. Contributions***

The contributions required to provide benefits and coverage for eligible participants are made by:

- the Company;
- the participant; or
- a combination of the Company and the participant.

#### ***d. Amendment or Termination of the Plan***

The Plan was amended effective January 1, 2024, to extend the election period for those who have a loss of Medicaid or Children's Health Insurance Program (CHIP) coverage and to update the coverage option attachments.

The trust used to fund some benefit options under the Plan, the MassMutual Agents Health Benefits Trust (AHBT), was terminated effective December 31, 2024 by action of the Company's board of directors.

Although the Company has not expressed any intent to discontinue the Plan, the Company reserves the right to amend or terminate the Plan at any time subject to the requirements set forth in ERISA. In the event of termination of the Plan, all eligible claims incurred prior to termination would be considered for payment on an equivalent basis and the Company shall be required to fund any deficiency in net assets available for benefits

### **2. Summary of Significant Accounting Policies**

#### ***a. Basis of Accounting***

The financial statements of the Plan are prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than U.S. generally accepted accounting principles (U.S. GAAP). The modified cash basis of accounting is a cash receipts and disbursements method of accounting. Contributions, benefits paid, interest income, expenses, and payments to insurance carriers to provide benefits are recorded when received or paid. Although a modified cash basis of accounting represents a departure from U.S. GAAP, it is an allowable method of accounting for employee benefit plans filing under the reporting requirements of ERISA.

#### *b. Use of Estimates*

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from these estimates.

#### *c. Disclosure for Incurred but Not Reported Claims*

The disclosure for incurred but not reported claims (IBNR) is an estimated liability actuarially determined based on the average number of participants and their dependents, economic trends, past claims experience, and other related factors. The reserves are not discounted as payments are expected to be made within a one-year period.

#### *d. Cash*

The cash account is held in the AHBT. The AHBT was dissolved effective December 31, 2024, by action of the Company's Board of Directors. The cash account was closed. The remaining cash balance before dissolution of \$129 was used to prepay Cigna administrative expenses.

As of December 31, 2024, all expenses of the Plan (other than benefits paid under insurance policies providing plan benefits) are paid from the Company's general assets.

#### *e. Imprest Account*

The imprest account is a non-interest-bearing bank account used by the Plan's third-party administrator to make benefit payments. Prior to December 31, 2024, certain Company and participant contributions were transferred from the AHBT to an imprest account established in the name of the Plan. Following the termination of the AHBT, the funds necessary to pay benefits are transferred directly from the Company's general assets to an imprest account.

### **3. Administration of Group Life and Disability Insurance Policies and Medical FSA (in thousands)**

Premiums for life insurance benefits provided under the Plan are paid by the Company from its general assets and amounts contributed by participants. During 2024, the Company and participants paid insurance premiums of \$3,741.

Disability premiums are paid by the Company and by participants. During 2024, the Company and participants paid insurance premiums of \$2,626.

Medical FSA contributions are made by participants. The Medical FSA contributions made during 2024 were \$477. The amount paid to participants during 2024 was \$414. In 2024, \$68 was forfeited by the participants.

### **4. Benefit Obligations**

The postemployment benefit obligations represent the actuarial present value of estimated postemployment benefits as of December 31, 2024 and 2023.

Postemployment benefits include estimates of future benefits expected to be paid for known long-term disabled participants. Full time agents under age 65 who become classified as long-term disabled may still be eligible (based on years of service) for postemployment benefits, including medical benefits, dental benefits, and life insurance. Benefits payable for disabled agents up to age 65 (who are not otherwise retired) are held in the postemployment obligation in the Plan.

In calculating the postemployment benefit obligations, the assumption for disability incidence rates is determined by using a weighted average of actual experience and the 1987 Group Long-Term Disability table. The period of actual experience covers the past five years for December 31, 2024 and 2023. The weighted average number of new disabilities assumed for the years ended December 31, 2024 and 2023 was three and five, respectively.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postemployment benefit obligations.

The Plan's excess of benefit obligations over net assets available for benefits at December 31, 2024 is expected to be funded through future contributions to the Plan.

#### 5. Fair Value Measurements

The Plan uses a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1      Observable inputs in the form of quoted market prices for identical investments in active markets.
- Level 2      Observable inputs other than Level 1 prices, such as quoted market prices for similar investments, quoted prices in markets that are not active or other inputs that are observable or can be derived from observable market data for substantially the full term of the investments.
- Level 3      One or more unobservable inputs that are supported by little or no market activity and are significant to the fair value of the investments. Level 3 investments include investments whose value is determined using internal models, as well as investments for which the determination of fair value requires significant management judgment or estimation.

An investment's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The investments at fair value as of December 31, 2023 were based on an observable daily market price, therefore are categorized as Level 1. The investments as of December 31, 2024 were zero.

#### **6. Administrative Expenses**

Administrative expenses consist of monthly fees paid or prepaid by the Plan or the Company for the processing of health, disability and life claims, coordination of benefits and financial reporting, and cost containment fees paid upon successful negotiation of discounts when an out-of-network provider is utilized.

#### **7. Related Party Transactions (Parties-in-Interest)**

MassMutual Trust Company, FSB (now MassMutual Private Wealth & Trust, FSB), a subsidiary of the Company, was the discretionary trustee of the AHBT. All trustee fees associated with the AHBT were paid from the general assets of the Company; the Plan and its participants did not pay any part of the trustee expenses.

The Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA. However, they are exempt from the prohibited transaction rules of ERISA.

#### **8. Trust and Tax Status**

The net assets available for benefits are held in the AHBT, which was established on July 11, 1984. The AHBT is exempt from federal income tax under Section 501(a) of the Internal Revenue Code (IRC) as a Section 501(c)(9) organization. Accordingly, the AHBT's corpus and net investment income are exempt from income taxes. The AHBT obtained a favorable tax determination letter, dated March 22, 1989, from the Internal Revenue Service (IRS). The Company believes that the AHBT, as amended, is qualified as Section 501(c)(9) organization and operated in compliance with the applicable provisions of the IRC.

To the extent the AHBT recognized any "unrelated trade or business" income as defined in Section 512 of the IRC; the AHBT is required to pay tax at trust income tax rates on any such income. This tax, if applicable, is paid by the Company on behalf of the AHBT. In 2024 and 2023, no unrelated trade or business income tax was due.

The AHBT was dissolved effective December 31, 2024.

The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

Plan management evaluates tax positions taken by the Plan and recognizes a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require disclosure in the financial statements.

#### **9. Risks and Uncertainties**

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

### 10. Subsequent Events

The Plan was amended effective January 1, 2025 to:

- eliminate references to the AHBT, which terminated on December 31, 2024, and update the Plan's provisions regarding payment of benefits accordingly;
- clarify certain enrollment provisions pertaining to Medicare and CHIP-driven changes in status;
- update certain cafeteria plan and flexible spending account eligibility provisions;
- reflect The MassMutual Trust Company, FSB name change to MassMutual Private Wealth & Trust; and
- update the coverage schedules.

The Plan has evaluated events subsequent to December 31, 2024 and through October 14, 2025, the date the financial statements were available to be issued, noting there are no other subsequent events requiring adjustment or disclosure in the financial statements.
