Responsibilities of Management for the 2024 Financial Statements


Management is responsible for the preparation and fair presentation of the 2024 financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Note 1 – Plan Description

The following description of the Fast Track EMS 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Fast Track EMS (the “Company”) covering substantially all employees who have completed three months of services and are 18 years of age or order. Participants are automatically enrolled at 1%. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 100% of eligible compensation, as defined by the Plan, as pretax or roth up to the maximum allowed by law. Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified plans. Participants may direct their contributions into various investments offered by the Plan. The Plan provides safe harbor matching contributions equal to 100% of the first 3% of eligible compensation deferred plus 50% of the next 2% of eligible compensation deferred. The Company may make a discretionary nonelective contribution. For the year ended December 31, 2024, no discretionary nonelective contribution was made. Contributions are subject to certain limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Company’s matching contributions, any additional contributions, allocations of Plan earnings and charged an allocation of administrative fees. Allocations are based on participant account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested pre-tax account balance. Terms can range from 1 to 5 years, unless the loan was taken for the purchase of a primary residence for which longer terms are available. The notes receivable are secured by the balance in the participants’ account and bear interest at the prime rate plus one percent. Interest rates on outstanding notes ranged from 8.75% to 9.50% at December 31, 2024. Principal and interest are paid ratably through payroll deductions.

Vesting

Participants are immediately invested in their contributions plus actual earnings thereon. Participants are also immediately vested in the Company’s safe harbor matching and discretionary nonelective contributions plus earnings thereon.

Benefit Payments

Upon attainment of normal retirement at age 65, termination of employment, or in the case of death or disability, a participant or their beneficiary will receive the vested portion of the amount credited to the participant's account. Employees age 59 ½ or older may receive in-service withdrawals from their deferral and employer funded accounts. Hardship withdrawals are also permitted, subject to provisions described in the Plan document. The participant may elect to receive a lump-sum distribution as defined in the Plan provisions. Vested balances of \$5,000 or less will be automatically distributed in accordance with the Plan provisions.

Forfeitures

All contributions are 100% vested.

Administrative Expenses

Administrative expenses incurred by the Plan may be paid by either the Plan or the Company. A portion of these fees and expenses were paid by the Plan for the year ended December 31, 2024 and some are netted with investment income.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan's Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Cash

The Plan includes interest-bearing cash consisting of funds in a holding account maintained by the Trustee. The amount of interest bearing cash was \$10,959 and \$8,790 at December 31, 2024 and December 31, 2023, respectively. The interest-bearing cash account is insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes from Participants

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Payment of Benefits

Benefits are recorded when distributed to participants.

Administrative Expenses

Plan fees and administrative expenses are paid by the Plan or Company on a discretionary basis.

Subsequent Events

Subsequent events have been evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its

investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 6 – Income Tax Status

The Plan is adopted under a non-standardized pre-approved profit sharing Plan sponsored by Guideline RK, LLC. The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated September 26, 2024, that the Plan is designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-

Upon attainment of normal retirement at age 65, termination of employment, or in the case of death or disability, a participant or their beneficiary will receive the vested portion of the amount credited to the participant's account. Employees age 59 ½ or older may receive in-service withdrawals from their deferral and employer funded accounts. Hardship withdrawals are also permitted, subject to provisions described in the Plan document. The participant may elect to receive a lump-sum distribution as defined in the Plan provisions. Vested balances of \$5,000 or less will be automatically distributed in accordance with the Plan provisions.

Forfeitures

All contributions are 100% vested.

Administrative Expenses

Administrative expenses incurred by the Plan may be paid by either the Plan or the Company. A portion of these fees and expenses were paid by the Plan for the year ended December 31, 2024 and some are netted with investment income.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan's Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Cash

The Plan includes interest-bearing cash consisting of funds in a holding account maintained by the Trustee. The amount of interest bearing cash was \$10,959 and \$8,790 at December 31, 2024 and December 31, 2023, respectively. The interest-bearing cash account is insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes from Participants

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Payment of Benefits

Benefits are recorded when distributed to participants.

Administrative Expenses

Plan fees and administrative expenses are paid by the Plan or Company on a discretionary basis.

Subsequent Events

Subsequent events have been evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its

investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The following tables sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

The fair values of mutual funds are based on quoted net asset values of the shares held by the Plan at year end.

Note 4 – Related-Party and Parties-in-Interest Transactions

Certain administrative functions are performed by employees of the Company. These employees are also Plan participants. No such employee receives compensation from the Plan. Administrative fees paid to Guideline were \$3,759 for the year ended December 31, 2024.

Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 6 – Income Tax Status

The Plan is adopted under a non-standardized pre-approved profit sharing Plan sponsored by Guideline RK, LLC. The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated September 26, 2024, that the Plan is designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-

likely-than-not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
