We have performed audits of the accompanying financial statements of Baker Manufacturing Company, LLC 401(k) Deferred Profit Sharing Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). Note 1—Plan description

The following description of the Baker Manufacturing Company, LLC 401(k) Deferred Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General – The Plan was established November 30, 1968, to provide future security for eligible employees of Baker Manufacturing Company, LLC (the "Company" or "Plan Sponsor") by accumulating funds and sharing in the Company profits. The Plan is a defined contribution plan covering all eligible employees of the Company and Campbell Manufacturing, LLC, a wholly subsidiary of the Company. The Plan was last restated March 1, 2022.

Eligibility – Employees of the Company become eligible to defer compensation into the Plan on the first day of the month coinciding with or next following the completion of two consecutive months of employment. The Plan includes a provision whereby all new employees are automatically enrolled in the Plan at a 3% deferral rate after they become eligible unless a different percentage is elected by the employee.

Employees of the Company become eligible to participate in the Plan's match and profit sharing on the first day of the month following the completion of 12 consecutive months of employment in which they are credited with 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Plan Administration – The Plan is administered by the Company's 401(k) Board of Trustees. The Board of Trustees has overall responsibility for the operation and administration of the Plan. The Board of Trustees determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Company's Board of Directors.

Contributions – A participant may contribute a percentage of pretax annual compensation, subject to certain limitations, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company can make a discretionary profit sharing contribution equal to a percentage of each participant's compensation. This percentage is determined annually by the Company. In addition, the Plan calls for a discretionary matching contribution equal to a percentage of the amount of the salary reduction the participant elects to defer. This percentage is also determined each year by the Company. For the year ended December 31, 2024, the discretionary matching contribution was 50% of participant deferral percentages up to a max of 6% of eligible compensation, as defined by the Plan document. All contributions are subject to certain limitations, including Internal Revenue Services ("IRS") limitations. There was no discretionary profit sharing contribution for the year ended December 31, 2024.

Participant Accounts – Each participant's account is credited with the participant's contributions, Company matching contributions, an allocation of the Company's profit sharing contribution, and Plan earnings, and is charged with benefit payments and an allocation of administration expenses that are paid by the Plan. Allocation of the profit sharing contribution is based on participant compensation for the Plan year, and Plan earnings are allocated based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are 100% vested in their entire account balance upon participation in the Plan.

Investment Options – Upon enrollment in the Plan, participants may direct all contributions into selected investment options as made available and determined by the Plan administrator. Participants have the option to transfer monies between funds and may change their investment options daily.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms shall not exceed five years unless the purpose of the note is to acquire a primary residence, in which case the note term shall not exceed 15 years. The notes are secured by the balance in the participant's account and bear interest at 1% over the Wall Street Journal prime rate. Principal and interest are paid ratably through payroll deductions or an ACH agreement. As of December 31, 2024, interest rates ranged from 4.25% to 9.50% and mature through November 2029.

Payment of Benefits – Upon death, disability, retirement, or termination of service for any reason, a participant with \$5,000 or less in vested benefits will receive the value of the vested interest in their account as a lump sum distribution. A participant with more than \$5,000 in vested benefits may elect to receive either a lump-sum equal to the vested value of the participant's account or equal installments over their life expectancy. In addition, in-service withdrawals from a participant's account are permitted upon reaching age 59½ years of age or to the extent needed for financial hardship as defined by the Plan.

Forfeitures – Amounts forfeited from a participant's account shall be used to restore forfeitures, reduce Company contributions, or to pay reasonable Plan expenses. There was no forfeiture balance as of December 31, 2024 and 2023.

Note 2—Summary of significant accounting policies

Basis of Accounting – The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results could vary from the estimates that were used.

Risks and Uncertainties – The Plan provides for various investment options. Investments are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Notes Receivable from Participants – Notes receivable from participants is measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan is reduced, and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Excess Contribution Payable – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as liability with a corresponding reduction to participant contributions. The Plan distributes the excess contributions to the applicable participants prior to March 15 of the subsequent year.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board of Trustees determines the Plan’s valuation using information provided by the qualified institution. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Unrealized gains and losses are recognized in the period in which they occur. Dividends are recognized in the period earned and realized gains or losses on securities are recorded in the period of sale. Net (depreciation) appreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits – Benefit payments are recorded when paid.

Administrative Expenses – Administrative expenses of maintaining the Plan can be paid either by the Company or by the Plan. Expenses paid directly by the Company are excluded from these Plan financial statements.

Note 3—Information prepared and certified by the Plan’s qualified institution (unaudited)

The Plan Sponsor has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, the “qualified institution,” has certified to the completeness and accuracy of the following data included in the accompanying financial statements:

- Non-interest bearing cash, investments at fair value, and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan’s independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 4—Fair value of financial investments

U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability and in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value. The standard describes three levels of inputs that may be used to measure fair value:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are description of the valuation methodologies used to measure the Plan's investments at fair value, including the general classification of such instruments pursuant to the valuation hierarchy:

Mutual Funds – These investments are public investment vehicles valued using net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

Common Collective Trust – Value based on NAV per unit of the collective investment trust fund. NAV, as provided by the qualified institution, is used as a practical expedient to estimate fair value. NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Note 5—Related party and party-in-interest transactions

Plan investments are managed by Steele Capital Management and affiliates, the investment advisor, as defined by the Plan. Therefore, transactions with Steele Capital Management and affiliates qualify as party-in-interest. Fees paid to Steele Capital Management and affiliates for investment management expenses were \$46,920 for the year ended December 31, 2024.

EPIC Retirement Plan Services (“EPIC”) provides recordkeeping services to the Plan and, therefore, qualifies as a party-in-interest. Fees paid to EPIC were \$31,882 for the year ended December 31, 2024.

Certain administrative functions are performed by officers or employees of the Company and its subsidiaries for which no compensation was received from the Plan.

Notes receivable from participants are also considered party-in-interest transactions because they are transacted with Plan participants.

Note 6—Plan termination

Although the Company intends to maintain the Plan indefinitely, The Company may amend or terminate the Plan at any time in its sole discretion, subject to provisions of ERISA. If the Plan is terminated, all amounts credited to participants’ accounts will become 100% vested.

Note 7—Tax status

The Plan adopted a prototype non-standardized profit sharing with a cash or deferred arrangement plan which received a favorable opinion letter from the IRS on June 30, 2020, which stated the prototype Plan is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan has not received a determination letter specific to the Plan itself, and the Plan has been amended since receiving the opinion letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to business income tax.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8—Prohibited transactions

During the year ended December 31, 2024, the Plan failed to remit in a timely manner certain participant contributions from its assets within the required time period as specified by DOL’s Regulation 2510.3012. Failure to segregate and remit contributions within the specified time period is a prohibited transaction according to the provisions of ERISA and the IRC. The Plan made the deposit after the required timeframe and will remit lost earnings and late remittances in 2025.

Note 9—Subsequent events

In accordance with U.S. GAAP related to subsequent events, the Plan has evaluated all events subsequent to the statements of net assets available for benefits date of December 31, 2024 through October 15, 2025, the date these financial statements were available to be issued.
