NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Carolina Freightways, Inc. 401(k) Plan (the Plan) provides only general information. For more complete information, participants should refer to the Plan instrument, a copy of which is on file in the office of the Plan sponsor.

General

The Plan is a defined contribution 401(k) profit sharing retirement plan covering all eligible employees from TransPro Holdings Group, Inc. (the Company) and its related affiliates. TransPro Holdings Group, Inc. is the Plan sponsor, with the following participating employers: Carolina Freightways, TransPro Logistics, TransPro Properties, TransPro Management, and TransPro Equipment. The Plan commenced on January 1, 2018, and it is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees of the Company and its related affiliates are eligible to participate in the Plan upon attaining the age of 21 and two months of service. Employees covered by a collective bargaining agreement, leased employees and non-resident aliens are excluded from participation. Upon attaining eligibility, employees can enter the Plan on the first day of the first month and seventh month of the Plan year.

Funding

Each year participants may contribute up to 100% of pretax annual compensation as defined in the Plan. According to Internal Revenue Service (IRS) rules, the maximum deferral of pretax earnings were \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023 respectively. Those participants who have attained age 50 before the end of the Plan year are eligible to make an additional \$7,500 in catch-up contributions in 2024 and 2023.

The employer may match this contribution with a discretionary amount established each Plan year. For 2024 and 2023, the employer matching was 100% of the first participant's contribution not to exceed 3% of eligible compensation and then 50% for what exceeded 3% but not to exceed 5% which is the maximum matching contribution rate. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with 1) participant contributions; 2) the employers' matching contribution; and 3) a ratable portion of investment gain or loss, net of Plan expenses. Each participant's account is charged with any distributions made to that participant.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions to be allocated among a selection of securities provided by the Plan (see Note 3).

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service as follows:

Less than two years	0%
Two years but less than three years	20%
Three years but less than four years	40%
Four years but less than five years	60%
Five years but less than six years	80%
Six or more years	100%

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant or beneficiary may withdraw from the account a lump-sum for the total value of the participant's vested interest in the participant's account. The Plan provides for mandatory distributions to participants no longer employed by the Plan sponsor with vested account balances of less than \$5,000. Participants may retire upon attaining age 65.

Forfeitures

Forfeitures may be used to restore other forfeitures, reduce future employer contributions, or re-allocate as contributions. There were no forfeitures for the Plan years ended December 31, 2024 and 2023.

Termination

Although there is no intent to do so, the Plan document provides for termination of the Plan subject to the provisions of the agreement and ERISA.

Notes Receivable from Participants

Participants may borrow from their accounts from \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. Loan terms should not exceed 5 years. The loans would be secured by the balance in the participant's account and as of December 31, 2024, and bore interest between 5.25% and 10.50%. Loans are only available to Plan participants who are active employees of the Plan sponsor or participating employers. Principal and interest would be paid ratably through weekly payroll deductions. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants, if any, are recorded as a distribution based upon the terms of the Plan document. As of December 31, 2024, there were no delinquent notes receivable from participants.

Participants had outstanding loans of \$96,081 and \$65,830 as of December 31, 2024 and 2023, respectively, maturing at various dates through 2029.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (see Note 3). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants (see Note 4 for discussion of fair value measurements).

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Concentration of Credit Risk

Financial instruments, which potentially expose the Plan to concentrations of credit risks, as defined by GAAP, consist primarily of investments and contributions receivable. The Plan invests in mutual funds securities, which, inherent in the fair market value determination, include the risk factor of credit worthiness for each individual debt security.

NOTE 3. INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

Nationwide Trust Company, FSB, a division of Nationwide Bank, the custodian, (Nationwide) held the Plan's investments as of December 31, 2024 and 2023. The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Nationwide has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the information reflected on the schedule of Form 5500 - Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.

Allocations among the underlying investments are participant directed. The accounts are credited with earnings on the underlying investments (principally mutual funds) and charged for Plan withdrawals and administrative expenses.

During the year ended December 31, 2024, the Plan's underlying mutual fund investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$206,686. This was reported as net appreciation in fair value of investments in the statement of changes in net assets available for benefits.

NOTE 4. FAIR VALUE MEASUREMENTS

GAAP provides a framework for measuring fair value, expands disclosures about fair value measurements, and establishes a fair value hierarchy which prioritizes the inputs used in measuring fair value summarized as follows:

Level 1: Inputs using the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methods used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5. FULLY BENEFIT-RESPONSIVE INSURANCE CONTRACT

The Plan has a traditional fully benefit-responsive fixed income insurance contract, which was reported at a contract value, which approximated fair market value, of \$178,169 and \$128,837 as of December 31, 2024 and 2023, respectively. Contract value is the aggregation of contributions, plus interest, less withdrawals, if any. Deposits are guaranteed in both principal and interest by Nationwide Life Insurance Company. This contract has quarterly interest rate guarantees. The contract crediting rate is reset quarterly; for 2024, the Fixed Select rates were 2.27% (first quarter), 2.15% (second quarter), 2.03% (third quarter), and 1.91% (fourth quarter); for 2023, the Fixed Select rates were 2.17% (first quarter), 2.27%, (second quarter), 2.27% (third quarter), and 2.27% (fourth quarter).

NOTE 6. RELATED PARTIES

TransPro Holdings Group, Inc. as the Plan sponsor and the participating employers: Carolina Freightways, TransPro Logistics, TransPro Properties, TransPro Management, and TransPro Equipment, are considered to be related parties. They absorb virtually all of the Plan's administrative expenses.

NOTE 7. RISKS AND UNCERTAINTIES

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in these risks and uncertainties in the near term would materially affect participant account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE 8. TAX STATUS

The Plan is exempt from Federal income taxes under Internal Revenue Code (IRC) and, therefore, no provision for Federal income taxes has been made. In addition, the Plan is required to operate in conformity with the IRC to maintain the tax-exempt status. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Management believes no such positions have been taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management believes that the Plan is no longer subject to such audits for tax periods prior to 2021.

NOTE 9. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments may include shares of investments managed by Nationwide, which is also the Plan administrator and has fiduciary responsibility. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants.

Additionally, the Plan pays Nationwide for contract administration fees. These fees paid during the year for accounting and other services rendered by Nationwide were based on customary and reasonable rates for such services.

NOTE 10. PROHIBITED TRANSACTIONS

The Department of Labor's (DOL) regulation 29 CFR 2510.3-102 requires that participant contributions be remitted to the Plan on the earliest date on which they can reasonably be segregated from the Company's general assets. Failure to remit participant contributions to the Plan in a timely manner results in a prohibited transaction, which must be separately reported to the DOL and may result in penalties to the Plan sponsor.

During 2024, due to issues Nationwide had during a system conversion, a portion of the deferrals associated with 43 payroll files totaling \$197,688 were not remitted timely to the Plan. During 2024, the Plan sponsor and Nationwide remitted to the Plan the corrections to the participant contributions, including interest. These are shown as corrected in the Schedule of Delinquent Participant Contributions in addition to \$14,573 in self-corrections to 2023 remittances for a total of \$212,261.
