Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the ACLU Defined Contribution Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meet the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

1. Plan Description

General

The following description of the ACLU Defined Contribution Plan (the Plan) provides general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

The Plan was adopted effective April 1, 2009 as a defined contribution 401(k) salary reduction plan covering certain employees of the national organizations of the American Civil Liberties Union, Inc. (the ACLU) (the Plan Administrator or Employer or the Plan Sponsor), the American Civil Liberties Union Foundation, Inc. and affiliated entities (collectively, the Organization) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was subsequently restated on February 18, 2022 and January 1, 2023.

The Organization engages Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (the Trustee) to hold and invest Plan assets and execute Plan transactions based on certain elections made by participants.

Eligibility

Employees who are 21 years of age or older are eligible to participate in the Plan, unless the employee is a leased employee, resident of Puerto Rico, student intern, contracted employee for special projects, or is covered under any other profit-sharing or eligible pension plan to which the Organization contributes. Employees are automatically enrolled in the Plan once meeting the eligibility requirements.

Participant Contributions

Each participant of the Plan can elect to contribute a percentage, up to 100%, of their pre-tax compensation, as defined, up to the stated Internal Revenue Code (IRC) limitations of \$23,000 and \$22,500 for 2024 and 2023, respectively. In addition, participating employees who are 50 years of age or older in any calendar year may elect to make catch-up contributions to the Plan up to the annual Internal Revenue Service (IRS) limits of \$7,500 and \$6,500 for 2024 and 2023, respectively. Participants may contribute amounts representing rollovers from other qualified defined benefit or contribution plans.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Automatic enrollment deferral contributions are increased by 1% each year subsequent to enrollment up to 10%.

Employer Contributions

The Plan Sponsor makes a mandatory contribution to each participant equal to 2% of their eligible compensation. In addition, the Plan Sponsor makes a matching employer contribution. During 2024, the Plan Sponsor contributed 100% of the first 1% of the employee contributions plus 50% of employee contributions up to and not to exceed 6% of the eligible compensation, as defined in the

Plan document, that a participant contributed to the Plan. Employer contributions are subject to certain IRS limitations.

Participants' Accounts

Each participant's account is credited or charged with the participant and employer's contributions, the earnings or losses thereon and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled upon termination of employment is equal to the vested benefit in the participant's account.

Vesting

Participants are 100% vested in their voluntary contributions to the Plan plus the actual earnings thereon at all times. Participants fully vest in any employer contributions after one year of service.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$105,000 and \$87,000, respectively. Forfeited balances of terminated participants' nonvested accounts are used to reduce future employer contributions. During 2024, employer contributions were reduced by approximately \$390,000 from forfeited nonvested accounts. No forfeitures were used to pay administrative expenses for 2024.

Notes Receivable from Participants

Notes receivable from participants represent loans which allow participants to borrow from their fund accounts, subject to approval by the Plan Administrator. The maximum amount that may be borrowed is the lesser of 50% of the participant's vested account balance or \$50,000 (subject to certain limitations set forth in the Plan agreement). The minimum amount that may be borrowed is \$1,000. The loans are secured by the vested balance in the participant's account. Interest rates range from 5.25% to 10.50% as of December 31, 2024 and 2023, and only two loans may be outstanding at a time. The interest rate is fixed for the term of the loan based on prevailing market rates at the inception of the loan. The notes are repaid ratably through payroll deductions over a period of five years or less, unless used to purchase a principal residence up to five years. These loans are subject to certain restrictions as defined by the Plan document and applicable restrictions under the IRC.

Payment of Benefits

Upon retirement, death, or disability, participants may, in accordance with the Plan provisions, elect to receive their participating interest: (a) in a lump sum or (b) in monthly installments over a period not to exceed the joint life expectancy of the participant and spouse. Withdrawals under financial hardship circumstances are also permitted.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan Sponsor's management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the ACLU. Expenses that are paid by the ACLU are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Contributions Receivable

Participant contributions and any related employer contributions are recognized in the period during which the Organization makes the respective payroll deduction from the participant's compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document. During the years ended December 31, 2024 and 2023, delinquent loans distributed to participants totaled \$113,009 and \$84,990, respectively.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, related to investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustee, a qualified institution.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820 provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

An asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques that are used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds - These assets are valued at fair value based on the quoted price of the fund at year-end.

Pooled Separate Accounts - Pooled separate accounts are valued at the net asset value (NAV) of the units held. The NAV is based on the fair value of the underlying investments held by the PSA less its liabilities. The pooled separate accounts invest in domestic and foreign stocks, bonds and mutual funds. The fair values of the majority of these stocks, bonds, and mutual funds are publicly quoted and are used in determining the NAV of the pooled separate accounts, which are not publicly quoted. The NAV is used as a practical expedient to estimate fair value.

Collective Investment Trust Funds (CITs) - Collective investment trusts are valued at the NAV of units held. The NAV, as provided by the trustee of the CITs, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the CIT less its liabilities. These funds are structured as collective investment trusts and invest in a collective trust fund as well as a variety of separate accounts and mutual funds. Each fund is invested based on a predetermined asset allocation of equities and fixed income instruments that

matches a participants expected retirement date. The fair value of all these investments is used in determining the NAV of the collective investment trust, which is not publicly quoted.

Stable Value Fund - This asset is valued at NAV per share of the investment, which is based on the fair value of the underlying investments less its liabilities as reported by the fund. This investment represents investments in common collective trusts. The common collective trusts are primarily in pools of investment contracts that are issued by insurance companies and commercial banks, contracts that are backed by high-quality bonds, bond trusts and bond mutual funds, and short-term investment funds.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investments measured using NAV per share, or its equivalent, are in funds that are direct filing entities.

6. Related Parties and Party-in-Interest Transactions

Certain of the Plan's investments include interests that are managed by the Trustee. Participant loan and distribution processing fees are paid to the Trustee by participants. The Trustee, as defined by the Plan, qualifies as a permitted party-in-interest as defined by ERISA. Notes receivable from participants also qualify as exempt party-in-interest transactions as defined by ERISA.

7. Tax Status

The Plan has adopted a nonstandardized form of a prototype plan sponsored by Principal Life Insurance Company. The prototype plan has received an opinion letter from the IRS as to the prototype plan's qualified status. The prototype plan opinion letter, dated June 30, 2020, has been relied upon by the Plan. The Plan Administrator believes that the Plan, as amended, is designed and is being operated in compliance with the applicable provisions of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect amounts reported in the financial statements and participant account balances.

9. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

11. Delinquent Participant Contributions

During the Plan year ended December 31, 2024, employee withholdings in the amount of \$1,099,739 were not remitted within the appropriate time period by the Plan Sponsor. During the Plan year ended December 31, 2023 and prior, employee withholdings in the amount of \$5,266,653 were not remitted within the appropriate time period by the Plan Sponsor. These transactions constitute prohibited transactions, as defined by ERISA. \$3,340,271 of the total uncorrected balance for 2024 through 2011, will be corrected, with the remittance of lost earnings paid. The Plan Sponsor will take the appropriate steps to correct the remaining amounts owed.

12. Subsequent Events

Subsequent events were evaluated by the Plan's management through October 15, 2025, the date the financial statements were available to be issued. The Plan was amended effective January 1, 2025 to include the addition of a Roth option, with an option for participants to transfer existing holdings into the Roth option. Additionally, vesting in employer contributions was changed from after one year of service to immediately 100% vested. There were no other subsequent events requiring adjustment to the financial statements or disclosures.
