### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Rudd Group Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

### **Notes to the Financial Statements**

#### **1. Description of Plan**

The following description of the Rudd Group Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the Plan administrator.

**General** - The Plan is a multiple employer defined contribution plan as defined under Section 413(c) of the Internal Revenue Code, administered by LRICO Services, LLC (the Company) for the benefit of its employees and the employees of its affiliates (the Employers). The following are the Plan's participating Employers:

- Standard Beverage Corporation
- Restaurant 209, LLC
- Maverick Beverage Company, LLC (formerly Palomar Beverage Company, LLC)
- Rudd Foundation
- Cities West Media, LLC (formerly Cities West Publishing, Inc.)
- Maverick Beverage Company Arizona, LLC (formerly Quench Wines & Spirits, LLC)
- Maverick Beverage Company Texas, LLC (formerly Victory Wine & Spirits, LLC)
- Maverick Beverage Company Florida, LLC (formerly FWS Distributors, LLC)
- Maverick Beverage Company Minnesota, LLC (formerly Maverick MN, LLC)
- Maverick Beverage Company Colorado, LLC (formerly Maverick Wine Company of Colorado, LLC) and
- Rudd Wines, Inc.

The Plan is administered by the Company's Retirement Plan Committee (the Committee), which is a committee of the Management of the Company. The Committee is responsible for oversight of the Plan. The Plan's Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. Matrix Trust Company is the directed trustee of all of the assets of the Plan and also serves as Plan custodian.

**Plan amendments** - Effective January 1, 2024, the Plan was amended to clarify the employer discretionary matching formula for each related and participating employer shall be determined at the sole discretion of each participating employer.

The Plan was amended, effective April 1, 2024 to require a \$500 minimum amount for in-service distributions based on hardship.

#### 1. Description of Plan (continued)

The Plan was formally amended, effective April 27, 2020, to implement the provisions of the Cares Act, currently applicable to the Plan.

During 2024, the following participating employer changed their corporate name and accordingly modified their respective participating agreement:

- Effective January 31, 2024, Cities West Media Inc. is now Cities West Media, LLC

**Contributions** - Employees are eligible to participate the first day of the month coinciding with or immediately following one hour of service and 60 days of service. The Plan permits eligible participants through a salary deferral election to make annual pretax, Roth or after-tax contributions up to 100% of eligible compensation, up to the maximum limits of the Internal Revenue Code (IRC). The Plan permits in-plan Roth transfers. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their pre-tax deferral rate set at 3% of eligible compensation and their contributions invested in a designated age-based balanced fund until changed by the participant. The employer matching contributions are discretionary. There were two employer match contribution formulas used in 2024. One formula elected to contribute 100% of the first 3% and 50% of the next 3% of base eligible compensation (up to a 4.5% discretionary employer match if participants contribute up to 6%). The second formula elected to contribute 50% of the first 3% of base eligible compensation (up to a 1.5% discretionary employer match if participants contribute up to 3%). Participants must meet a service requirement of 60 days in order to receive the discretionary employer match. Additional employer match amounts may be contributed at the option of the respective employers. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Additional discretionary amounts may be contributed by the Company at the option of the Administrative Committee. For the years ended December 31, 2024 and 2023, there were no discretionary contributions to the Plan.

**Participant investment account options** - Participants direct the investment of all contributions into various investment options offered by the Plan and may change their investment options at any time, subject to the terms of the funding vehicles. The Plan currently offers 27 mutual funds, a collective investment trust and a self-directed brokerage account as investment options for participants.

**Participant accounts** - Each participant's account is credited with the participant's contributions, Company matching contributions, allocations of the Company's discretionary contributions and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants' contributions and amounts rolled over or transferred into the Plan plus actual earnings are 100% vested immediately. Employer discretionary matching contributions are subject to the following vesting schedule:

**Notes receivable from participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. A participant can have one loan currently outstanding from the Plan and the term of the note cannot exceed 5 years, unless the loan qualified as a primary residence loan, which is allowed a term of no more than 15 years. The loans are secured by the balance in the participant's account and bear interest at the rate of 1% over the current New York Prime rate as published in the Wall Street Journal. The interest rate shall remain constant for the term of the loan. Principal and interest are paid ratably through payroll deductions.

**Payment of benefits** - Upon termination of service due to any reason, a participant (or beneficiary) may elect to receive an amount up to the value of the vested interest in his or her account as a lump sum cash distribution; a direct rollover distribution to an eligible retirement plan specified by the participant (or beneficiary) or designated by the Plan administrator; a combination of a cash distribution and a rollover; or ad-hoc distributions to satisfy RMD requirements. Upon termination, a participant with a vested account balance less than \$1,000 will automatically receive a lump sum cash distribution. In the event a distributable amount is greater than \$1,000, but less than \$5,000, if the participant is under age 62 and does not elect to have such distribution paid directly to an eligible retirement plan in a direct rollover or to receive the distribution, then the Plan administrator will deposit the distribution in a direct rollover to an IRA designated by the Plan administrator. Benefits may also be withdrawn for certain qualifying hardship circumstances if certain criteria are met. Other in-service distributions are available to participants who have reached age 59.5.

**Forfeited accounts** - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$56,132 and \$33,657 respectively. These accounts are to be used to pay certain plan expenses and to reduce future employer matching contributions. For the years ended December 31, 2024 and 2023, employer contributions were reduced by \$505,504 and \$307,586, respectively, from forfeited nonvested accounts. Also, for the years ended December 31, 2024 and 2023, certain Plan expenses were reduced by \$64 and \$11,087, respectively, from forfeited nonvested accounts.

**2. Summary of Accounting Policies**

**Basis of accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

**Use of estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**2. Summary of Accounting Policies (continued)**

**Investment valuation and income recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Unit values** - Individual participant accounts for the common collective trust funds are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the funds but do have an interest therein represented by units valued daily. The funds earn dividends and interest which are automatically reinvested in additional units. Generally, contributions to and withdrawals from the fund are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the participants' accounts are charged or credited with the number of units properly attributable to each participant.

**Notes receivable from participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Excess contributions refundable** - Amounts refundable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding addition to benefit payments paid to participants. See discussion in Note 8.

**Payment of benefits** - Benefits are recorded when paid. There were no benefits requested before year end that were not paid.

**Administrative expenses** - Certain administrative services and expenses of maintaining the Plan are provided by and paid directly by the Company and are excluded from these financial statements. Fees specific to participant transactions that are charged against the individual participant's account balance and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments. Investment advisory fees are charged to participant accounts as applicable and also included in administrative expenses along with other recordkeeping and administrative expenses.

**Subsequent events** - The Plan has evaluated subsequent events through the date of this report, which is the date the financial were available to be issued. Significant items were noted during this evaluation that would require disclosure in the financial statements or accompanying footnotes, except as noted below.

Effective January 1, 2025, Maverick Beverage Company Illinois, LLC became a participating employer in the Plan.

**3. Information Certified by Trustee**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix Trust Company, the current Trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule, as of and for the years ended December 31, 2024 and 2023, are complete and accurate with respect to investments:

- Investments, at fair value
- Notes receivable from participants
- Net appreciation (depreciation) in fair value of investments
- Interest and dividends
- Interest income on notes receivable from participants

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**4. Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value on a recurring basis. There have been no significant changes in the techniques used during the years ended December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1).

*Collective investment trust:* This investment option is a stable value fund which is valued at the NAV of the units of the individual collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimating fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The Plan's collective trust investments may be redeemed on a daily basis.

Were the Plan to initiate a full redemption of the collective investment trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. See Note 5.

*Self-directed brokerage accounts:* Investments held by the Plan primarily consist of global equities, treasuries, commodities and treasury securities that are held in a liquid Exchange Traded Fund ("ETF") structure. ETFs held by the Plan are registered with the SEC and listed for trading and trade throughout the day on stock exchanges are priced and transacted at their NAV. The ETFs held within a self-directed brokerage account are deemed to be actively traded (Level 1).

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Reliance Trust Company Stable Value Fund - Metlife** - The Reliance Trust Company Stable Value Fund (the "Fund") is a collective investment trust and considered to be a stable value fund that is an open-end commingled pool dedicated exclusively to the management of assets of defined contribution plans. The Fund does not invest directly in fully benefit-responsive contracts; rather, it invests in underlying assets (fixed income securities or bond funds and insurance contracts) and enters into a "wrapper" contract issued by a third party.

The Fund is valued at the NAV of the units of the individual collective trust. The NAV is calculated daily and net investment income and realized and unrealized gains on investments are not distributed but rather reinvested and reflected in the NAV of the fund. The fund is valued at fair value and then adjusted by the issuer to contract value. Contract value represents contributions made to the fund, plus earnings, less participant withdrawals. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value however, certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) participant withdrawals based on advice or direction, (2) changes to the Plan which establish investment options or investment objectives so as to constitute or create a competing fund, (3) Plan administrator establishes a new eligible plan or amends an existing eligible plan, and such plan covers participants in the participating Plan and offers a competing fund, or (4) participating Plan makes a withdrawal for any reason other than participant-directed withdrawals.

The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring. Units of the fund are issued and redeemed at the current NAV.

#### **6. Related-Party and Party In Interest Transactions**

Fees incurred by the Plan for investment management and advisory services, provided by Matrix Trust Company, are included in the net appreciation (depreciation) in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. The Plan made direct payments to Milliman, Inc., Matrix Trust Company, UBS Financial Services, Inc. and to the Plan's third party auditor (in 2023) of \$174,590 and \$185,474 for the years ended December 31, 2024 and 2023 respectively, for recordkeeping, administrative, advisory, and auditing services, which were not covered by revenue sharing and are included in administrative expenses. The Company pays directly any other fees related to the Plan's operations not paid out of forfeitures.

#### **7. Plan Termination**

Although it has not expressed any intent to do so, the Employers have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their employer contributions.

**8. Excess Contributions Refundable**

For the years ended December 31, 2024 and 2023, payments of \$31,128 and \$8,114, respectively, were made subsequent to the Plan year end to certain active participants to return to them excess deferral contributions as required to satisfy the relevant nondiscrimination provisions of the Plan. At December 31, 2024 and 2023, \$31,128 and \$8,114 respectively, have been included in the Plan's statements of net assets available for benefits as excess contributions refundable.

**10. Tax Status**

The Company adopted a defined contribution pre-approved plan offered by Milliman, Inc.. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Opinion Letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**11. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
