DECEMBER 31, 2024

1. DESCRIPTION OF THE PLAN

The following description of the Bruegmann USA Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Bruegmann USA, Inc. (the “Sponsor”). The Plan became effective on January 1, 2024, and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”) and the Internal Revenue Code (the “IRC”).

Contributions

Employees eligible to participate in the Plan (“participants”) may contribute, on a pre-tax and/or after-tax basis, a percentage of their compensation, as defined by the Plan, under a salary deferral arrangement, subject to IRC limitations. The Plan also allows participant rollover contributions, which represent distributions from other qualified plans.

The Sponsor makes safe harbor matching contributions on behalf of each participant in an amount equal to 3% of the participant’s compensation, as defined. The Sponsor, at its sole discretion, may also make additional matching contributions and/or nonelective contributions to the Plan annually on behalf of participants. Nonelective contributions are allocated amongst participants based upon the ratio that the participant’s compensation for the Plan year bears to the total compensation for the Plan year of all participants. No discretionary matching or nonelective contributions were made during the year ended December 31, 2024.

Investment options

The Plan’s investment assets are held by Voya Retirement Insurance and Annuity Company (the “Custodian”), the custodian of the Plan’s investment assets. Upon enrollment in the Plan, participants may direct all contributions, in any whole percentage increment, to any of the available investment funds. Participants may change their allocation among the various investment options at any time.

Participant accounts

Each participant’s account is credited with (a) the participant’s contributions, (b) the Sponsor’s contributions on behalf of the participant, and (c) the earnings and losses of the participant’s investments and is charged with any expenses incurred as a result of transactions initiated by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions and Sponsor safe harbor matching contributions, plus actual earnings thereon. Vesting in the Sponsor’s discretionary matching and nonelective contributions and actual earnings thereon is based on years of qualifying service, as follows:

#### Forfeitures

Forfeitures of nonvested balances are used to pay administrative expenses or to reduce future Sponsor contributions. During the year ended December 31, 2024, no amounts were forfeited and no amounts were used to pay administrative expenses or reduce Sponsor contributions. There were no accumulated forfeitures at December 31, 2024.

#### Payment of benefits

Upon termination of service, or for reasons of death, disability, or retirement, a participant may elect to receive either a lump-sum or partial withdrawal of his or her account or elect to have his or her account balance transferred to an Individual Retirement Account ("IRA") or to another qualified employer plan. In the event that a participant terminates employment with the Sponsor and has a vested account balance of \$1,000 or less, the participant will receive an automatic distribution of those funds. A participant whose account balance exceeds \$1,000 but does not exceed \$5,000 will have their balance automatically rolled over into an IRA outside of the Plan assets as soon as administratively feasible following termination. Active employees may withdraw from their accounts upon attainment of age 59½ or for reasons of financial hardship as defined by IRC regulations.

#### Administrative expenses

Administrative fees associated with certain participant-directed transactions are paid by the Plan. These fees are charged to the accounts of the participants who initiate the transactions.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of accounting

The accompanying financial statements are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### Payment of benefits

Benefits are recorded when paid.

#### Use of estimates in financial statement presentation

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements. Dividends are recorded on the ex-dividend date. Net appreciation / depreciation includes dividends and unrealized and realized gains and losses on investments bought and sold as well as held during the year.

#### Expenses

Certain expenses incurred maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Investment-related expenses are included in net appreciation / depreciation of fair value of investments.

## 3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN (UNAUDITED)

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's (the "DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by the Custodian, except for comparing such information to the related information included in the Plan's financial statements and supplemental schedule.

The following information included in the accompanying financial statements and supplemental schedule was prepared and certified to be complete and accurate by the Custodian as of and for the year ended December 31, 2024:

#### 4. INVESTMENT CONTRACT WITH CUSTODIAN

The Plan has an investment contract with the Custodian, who maintains the contributions in a guaranteed account. The account is credited with earnings on the underlying investments and charged for Plan withdrawals.

The contract value of the Plan's investment in this contract represents contributions made under the contract, plus accrued interest, less Plan withdrawals. Transfers by participants from the guaranteed account to other funds at contract value are generally permitted at contract value. For a period of 90 days following a partial withdrawal of funds from the guaranteed account by a participant, additional withdrawals or transfers from the guaranteed account at contract value are not allowed. Since the Plan's ability to transact with the issuer at contract value may be limited by participant-directed transactions, the contract is not considered to be fully benefit-responsive. The contract value of this investment was \$15,683 at December 31, 2024.

Certain non-participant directed events could also limit the ability of the Plan to transact with the issuer at contract value. Such events include the following: (a) termination of the Plan, (b) merger of the Plan into another plan, or (c) premature termination of the contract by the Sponsor. The Sponsor does not believe that such events are probable of occurring.

The specified contract interest crediting rate is adjusted annually at the beginning of each year and is guaranteed to be at least 1.00%.

#### 5. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value:

- Pooled separate accounts: Valued at the unit value of shares held by the Plan at year-end, as determined by the Custodian based on the net asset value (“NAV”) of the underlying mutual funds. The NAV, as reported by the Custodian, is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.
- Collective trusts: Valued at the NAV of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.
- Guaranteed account: Valued at the net present value of the related cash flows of the underlying investments based on current yields of similar instruments with comparable durations.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Sponsor believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 6. RELATED PARTY TRANSACTIONS

The Sponsor pays certain costs on behalf of the Plan for third party administration, insurance, and audit fees. The Sponsor also provides recordkeeping and administrative services to the Plan at no cost.

Investments held by the Plan are managed by the Custodian. Accordingly, these transactions qualify as party-in-interest transactions under ERISA.

## 7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

## 8. INCOME TAX STATUS

The Plan utilizes a volume submitter prototype plan document sponsored by Nova 401(k) Associates, Inc., who received a letter from the Internal Revenue Service (the "IRS"), dated June 30, 2020, in which the IRS opined that the prototype plan is acceptable under the applicable sections of the IRC.

The Plan has not obtained a determination from the IRS on its adoption of the volume submitter prototype plan. In accordance with Revenue Procedure 2002-6, the Sponsor has chosen to rely on the opinion letter of the prototype plan. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Sponsor believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress.

## 10. PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants would become 100% vested in their accounts.

## 11. SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan was amended to implement an automatic deferral provision under an Eligible Automatic Contribution Arrangement (“EACA”). All participants who have not made an affirmative election at any time will be automatically enrolled at a deferral rate of 10% of compensation for each payroll period. Participants may request a withdrawal of automatic deferrals within 90 days of the date of their first automatic contribution.

The Sponsor has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.
