1. Description of Plan

The following description of Maury Microwave Corporation Profit Sharing and Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a qualified, defined-contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established on April 1, 1973, by Maury Microwave Corporation, the Plan Sponsor (the “Employer”). The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC) and similar state tax laws.

All employees who have attained age 18 and completed 30 days of service are eligible for participation in the Plan. Enrollment can occur on the first day of the next calendar month after meeting the service requirement.

The assets of the Plan were transferred from Fidelity Management Trust Company to ADP Retirement Trust Services on January 2, 2025.

Effective January 1, 2025, Wireless Telecom Group, Inc. 401(k) Profit Sharing Plan was merged into this Plan.

Contributions

Participants are automatically enrolled based on the Plan’s default elective deferral of 5% of the participants’ pretax eligible compensation, which increases annually by 1%, not to exceed 10%, unless the participant elects a different percentage, or they affirmatively elect not to participate in the Plan. Participants may elect to contribute, on a pretax basis, up to 100% of their eligible compensation, in an amount not in excess of the maximum allowed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions. Participants may also make contributions to the Plan on an after-tax basis, as Roth deferrals, as defined in the Plan agreement and subject to the limitations under the IRC, as listed above. Participants may also roll over amounts representing distributions from other qualified benefit or contribution plans.

Effective January 1, 2023, the Plan was amended to be a safe harbor 401(k) plan. The Employer contributes a Safe Harbor Non-Elective contribution that does not exceed 3% of compensation to all eligible participants. All Employer contributions are invested in the same manner that the participant directs his or her participant withheld amounts.

The Employer’s profit sharing contributions are discretionary. Participants who are employed on the last day of the Plan year, are age 18 and have one month of service and have completed at least 1,000 hours of service during the Plan year are eligible to receive profit sharing contributions. The Employer did not make any profit sharing contributions during the year ended December 31, 2024.

Contributions (continued)

Effective January 1, 2025, the Plan was amended and restated to remove its safe harbor status. As a result, the Plan is no longer a safe harbor plan.

Participation and Vesting

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions, rollovers from qualified plans of the participant's previous employers, allocation of the Employer's contributions, and allocations of the Plan's earnings and administrative expenses. Each participant's account is credited with the participant's contribution and the Employer's matching contribution. Plan earnings and expenses are allocated based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Effective January 1, 2023, participants are immediately vested in their contributions and Employer safe harbor contributions, plus actual earnings thereon. Participants that merged in from the dBm retirement plan on January 1, 2023 with discretionary non-elective contributions were vested 100% upon Plan merger.

For Plan years before January 1, 2023, employee contributions, rollovers, and actual earnings on all such contributions are fully vested at all times. Thereafter, vesting of Employer matching contributions, discretionary profit sharing contributions, and actual earnings thereon are based upon the participant's continuous years of service with the Employer as follows:

Participation and Vesting (continued)

For Plan years after January 1, 2025, employee contributions, rollovers, and actual earnings on all such contributions are fully vested at all times. Vesting of Employer matching contributions and profit sharing contributions, and actual earnings thereon are based upon the participant's continuous years of service with the Employer as follows:

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance reduced by the highest outstanding note balance in the prior twelve-month period. The notes are secured by the balance in the participant's account and bear interest at a rate that a bank or other professional lender would charge for a note in a similar circumstance. Note terms range from one to five years, or longer for the purchase of a primary residence. Principal and interest are paid ratably through weekly payroll deductions. A participant can only have one outstanding note at any time. Defaulted participant notes are reclassified as distributions based upon the terms of the Plan document.

Interest rates for all outstanding notes at December 31, 2024 ranged from 5.25% to 10.50%.

Benefits

All participants may withdraw amounts from their accounts up to their entire interest if they attain the age of 59-1/2 or qualify for financial hardship. On termination of service due to death, disability or retirement, a participant with an account balance greater than \$5,000 may elect to receive a lump-sum cash payment equal to the value of the participant's interest. If the participant's vested interest is greater than \$1,000 but less than \$5,000, the participant will receive a rollover into an individual retirement account determined by the Plan Administrator. If the participant's vested balance is less than or equal to \$1,000, the account will be distributed in a lump-sum distribution.

The Plan allows hardship withdrawals in accordance with IRS regulations. Among other things, the withdrawal must be necessary in light of immediate and heavy financial needs of the participant and is limited to certain purposes.

Forfeitures

Participant's accounts are forfeited if the Employer contribution portion has not been fully vested at the time of withdrawal. These amounts may be utilized to reduce Employer contributions and/or pay administrative expenses. As of December 31, 2024, and 2023, there were \$9,548 and \$6,452 of forfeitures available, respectively. During the year ended December 31, 2024, \$12,443 of forfeited funds were used to the Plan administrative expenses.

Expenses

The Employer pays all administrative expenses of the Plan with the exception of a management fee paid to Fidelity Investments, note fees and maintenance fees for inactive participants. Expenses that are paid by the Employer are excluded from these financial statements.

Plan Termination

Although it has not expressed such intent, the Employer, by action of its Board of Directors, reserves the right, at any time, to amend or terminate the Plan. Upon termination of the Plan, further contributions to the Plan shall cease and all participants who are affected by such termination shall become 100% vested. Net assets available for plan benefits would be distributed to the participants based on each participant's interest in the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America ("US GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of net assets available for Plan benefits and changes therein, and disclosure of contingent net assets available for Plan benefits at the date of the financial statements. Accordingly, actual results could differ from those estimates.

Notes Receivable from Participants

Notes from participants are measured at their unpaid principal balance plus any accrued unpaid interest. Interest income is recognized when earned. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document. As of December 31, 2024 and 2023, there were no delinquent participant notes that have been classified as benefits paid directly to participants on the statement of changes in net assets available for plan benefits. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefit payments to participants are recorded when paid. Corrective distributions generally represent the distribution of certain assets to employees in order for the Plan to comply with nondiscrimination rules.

Fair Value Measurements

The Plan follows US GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Investment Valuation and Income Recognition

The following are descriptions of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023.

Registered investment companies:

Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transfer at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable value fund:

The Goldman Sachs Stable Value Fund, held in a collective trust fund, invests in conventional and synthetic guaranteed investment contracts (GICs) issued by life insurance companies, banks and other financial institutions with excess cash invested in cash equivalents. The objective of the stable value fund is to provide preservation of capital and relatively stable returns regardless of the volatility of the financial markets. The investments are valued using NAV as a practical expedient to estimate fair value where NAV is based on the value of the underlying investment assets owned by the fund, minus its liabilities. This practical expedient is not used when it is determined to be probable that the account will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There are currently no redemption restrictions or unfunded commitments on these investments.

Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Dividends are recorded on the ex-dividend date.

3. Tax Status

Effective August 2, 2021, the Plan adopted a non-standardized pre-approved plan sponsored by FMR, LLC. The pre-approved plan has received an opinion letter from the IRS as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. Although the Plan has been amended since receiving the letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is no longer subject to examinations by the applicable taxing jurisdictions for periods prior to December 31, 2021.

4. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the Trustee of the Plan and a qualified institution.

Fidelity Management Trust Company is the trustee as defined by the Plan, and therefore, these transactions qualify as exempt "party-in-interest" transactions permitted by the United States Department of Labor (DOL) Rules and Regulations. Notes from participants and the related interest income of \$14,624 are also considered related-party transactions.

8. Prohibited Transactions

As required by ERISA Section 2510.3-102, the Employer is required to segregate participant contributions from its general assets and remit them to the Plan as soon as administratively feasible.

During the 2024 and 2023 Plan year, the Employer failed to remit to the Plan certain participant contributions totaling \$12,335 and \$633, respectively, within the period described by DOL regulations due to administrative timing. The DOL considers late deposits to be prohibited transactions. The Employer is in the process of calculating and remitting lost earnings.
