### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Hackett Group, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. #### Note 1. Description of Plan

The following description of The Hackett Group, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution profit sharing plan covering substantially all employees of The Hackett Group, Inc. (the Company) and its subsidiary, Jibe Consulting (Jibe), upon their hire date, who are at least 21 years of age. The 401(k) Plan Administration Committee is responsible for oversight of the Plan. The 401(k) Plan Administration Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Company's Board of Directors. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Participants may make pretax contributions of varying percentages from eligible compensation, as defined in the Plan document. Participants are also permitted to contribute Roth after-tax deferrals to the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers).

The Company may make discretionary matching contributions to the Plan on an annual basis, subject to certain limitations as described in the Plan document. In addition, the Company may also make discretionary profit sharing contributions on an annual basis. In order to be eligible to receive the Company's matching or profit sharing contributions, participants must have at least one year of service and must be employed on the last day of the plan year in which the Company had made either the matching or profit sharing contribution. For the year ended December 31, 2024, the Company made discretionary matching contributions of \$702,212, net of forfeitures, all of which were made in March 2025. Accordingly, the Plan has reflected such amounts as an employer contribution receivable in the accompanying statement of net assets available for plan benefits as of December 31, 2024. There were no profit sharing contributions for the year ended December 31, 2024.

Contributions are subject to certain Internal Revenue Code (IRC) limitations.

**Investment options:** Upon enrollment in the Plan, a participant may direct contributions to selected investments as made available and determined by the Plan Administrator, including a self-directed brokerage option, in 1% increments. Participants may change their investment options daily.

**Participant accounts:** Each participant's account is credited with the participant's contributions and the Company's matching contributions as well as allocations of any profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Payment of benefits:** The Plan permits withdrawals when a participant terminates employment, reaches retirement age, or becomes disabled or deceased. In-service withdrawals are also permitted for certain financial hardships or when a participant reaches age 59½. Benefits are payable in lump-sum payments with certain exceptions allowed.

**Vesting:** Participants are vested immediately in their contributions plus earnings thereon. Company discretionary matching and profit sharing contributions vest 100% upon the participant's death, disability, reaching age 65, termination of the Plan or otherwise according to the following schedule:

Less than 1 year	0%
1 year	30%
2 years	60%
3 or more years	100%

**Forfeitures:** Forfeitures are used to reduce future employer contributions or pay plan expenses. Forfeited nonvested accounts totaled \$175,199 and \$580 at December 31, 2024 and 2023, respectively. For 2024, the Plan used \$156,090 of forfeitures to reduce employer matching contributions.

**Notes receivable from participants:** Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. Loan terms range up to five years or over a reasonable period of time for the purchase of a participant's primary residence, as established by the Plan Administrator at the time of the loan. The loans are collateralized by the vested balance in the participant's account and bear interest at the prime interest rate. These rates range from 3.25% to 8.50% on loans outstanding at December 31, 2024, and the loans mature through December 2039. Principal and interest are paid ratably through regular payroll deductions.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Plan Administration Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Contributions:** Contributions from Plan participants and matching contributions from the employer are recorded in the year in which participant compensation is earned.

**Payment of benefits:** Benefits are recorded when paid.

**Expenses:** Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable that are charged directly to the participant's account and certain recordkeeping fees paid by the Plan. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent events:** The Plan has evaluated subsequent events (events occurring after December 31, 2024) through October 15, 2025, the date the financial statements were available to be issued.

State Street Bank and Trust Company has also certified to the completeness and accuracy of \$17,166,486 of net appreciation in fair value of investments, \$1,497,424 of interest and dividends and \$70,233 of interest income on notes receivable from participants related to the aforementioned assets for the year ended December 31, 2024.

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

**Registered investment companies (mutual funds):** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Self-directed brokerage accounts:** Accounts primarily consist of mutual funds, unit trusts and common stocks that are valued on the basis of readily determinable market prices.

**Common collective trusts:** Valued at the NAV of shares in each account held by the Plan at year-end. The NAV is not a public-quoted price in an active market. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

#### Note 5. Related-Party and Parties in Interest Transactions

State Street Bank and Trust Company is the trustee of the Plan; therefore, transactions with the trustee qualify as parties in interest transactions. The Company also paid certain administrative expenses of the Plan.

#### Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### Note 7. Tax Status

The Plan has adopted a preapproved Plan document that has received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the form of the preapproved Plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any significant uncertain tax positions that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
