

## NOTES TO FINANCIAL STATEMENTS December 31, 2024 and 2023

### NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Shift5 Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

#### (a) GENERAL

The Plan is a defined contribution 401(k) and profit sharing plan which covers all employees of Shift5, Inc. (the Company). Employees are eligible to participate in the Plan upon completion of 2 months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was initially effective on January 1, 2019 and was most recently amended effective February 1, 2025, to define excluded employees, automatic enrollment at 6%, include matching employer confirmations, permit loans, and to update trustee names.

#### (b) CONTRIBUTIONS

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan agreement, up to a maximum of \$23,000 in 2024. Participants who have attained age 50 by the Plan year-end may also make catch-up contributions of \$7,500 in 2024. The Company will make a safe harbor matching contribution of 100% of each participant's contribution up to 3% of the participant's qualified compensation. The Company's safe harbor matching contribution for the year ended December 31, 2024, was \$634,862.

In addition, for each Plan year, the Company may contribute and allocate to the account of each eligible employee a discretionary profit sharing amount to be determined from year to year. The Company did not make a profit sharing contribution for the year ended December 31, 2024.

Non-elective employer contributions may be permitted at the discretion of the Company only to those eligible participants who are non-highly compensated employees. Contributions will be made to meet either the ADP Test or the ACP Test. No such contributions were made for the year ended December 31, 2024.

#### (c) PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution, the Company's matching, profit sharing, safe harbor contributions and an allocation of Plan earnings. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's account balance.

### **NOTES TO FINANCIAL STATEMENTS** December 31, 2024 and 2023

#### **NOTE 1 - DESCRIPTION OF THE PLAN** (continued)

**(d) VESTING**

Participants are immediately vested in their elective contributions and employer safe harbor matching contributions plus actual earnings thereon. Vesting in employer profit-sharing contributions is 20% after completion of two years of continuous service and increases by 20% for each year thereafter. A participant is 100% vested after six years of continuous service.

**(e) NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow up to 50% of their vested account balance subject to a minimum amount of \$1,000 and a maximum of \$50,000. No more than two loans are to be outstanding at any one time. Notes receivable from participants bear interest at a rate which is comparable to commercial lending institutions. Interest rates on outstanding notes receivable from participants at December 31, 2024, ranged from 8% to 8.50%. Notes receivable from participants are secured by the participant's vested interest in the Plan. Principal and interest are paid through payroll deductions. General loans must be repaid within five years, and loans to acquire a personal residence must be repaid within ten years.

**(f) PAYMENT OF BENEFITS**

Upon termination of service, a participant may elect to receive a single lump-sum payment of the vested balance of his or her account or installment payments for a period not to exceed life expectancy. Benefits are recorded when paid. There are no benefit claims for participants separated from service that have not been paid as of December 31, 2024.

**(g) FORFEITURES**

Forfeitures of terminated participants' non-vested accounts are applied first to Plan administrative expenses and are then used to reduce employer contributions for the Plan year. Any remaining forfeitures will be allocated to qualifying contributing participants. As of December 31, 2024 and 2023, there were no available forfeitures.

**(h) ADMINISTRATIVE EXPENSES**

The Plan is charged with the administrative expenses incurred. Transaction charges are paid by the participants.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**(a) BASIS OF ACCOUNTING**

The financial statements of the Plan are prepared under the accrual method of accounting.

**(b) USE OF ESTIMATES**

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan's management to make estimates and assumptions. Those estimates and assumptions affect the reported amounts of assets and liabilities, and the reported revenues and expenses during the reporting period. The actual results could differ from those estimates.

**(c) RISKS AND UNCERTAINTIES**

The Plan utilizes various investment instruments, including mutual funds. Investment instruments, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment instruments, it is reasonably possible that changes in the values of investment instruments will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

**(d) INVESTMENT VALUATION AND INCOME RECOGNITION**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for disclosure of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**(e) NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

#### **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES** (continued)

##### **(f) SUBSEQUENT EVENTS**

The Plan has evaluated events and transactions occurring subsequent to the statement of net assets available for benefits date of December 31, 2024, for items that should potentially be recognized or disclosed in these financial statements. The evaluation was conducted through October 15, 2025, the date these financial statements were available to be issued. No such events or transactions were noted except for as otherwise disclosed in these financial statements.

#### **NOTE 3 - INVESTMENTS**

The Plan's funds are maintained by Ascensus Trust Company (Ascensus), the trustee of the Plan, as of December 31, 2024. The funds are credited with actual earnings on the underlying investments and charged for Plan withdrawals. The Plan's funds in the financial statements as of December 31, 2024 are the values as reported to the Plan by Ascensus.

The following information included in the accompanying financial statements and the supplementary schedule was obtained from the data that has been prepared and certified as complete and accurate by Ascensus:

- Investment accounts and notes receivable from participants as shown in the statement of net assets available for benefits as of December 31, 2024
- Net appreciation in fair value of investments, dividend income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Supplementary schedule of assets (held at end of the year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the statement of net assets available for benefits and statement of changes in net assets available for benefits and the supplementary schedule of assets (held at end of the year) as of December 31, 2024.

Upon enrollment in the Plan, participants may direct contributions to any of the investment options maintained by Ascensus. Participants may change their investment options at their discretion.

#### NOTE 4 - FAIR VALUE MEASUREMENTS

The Plan adopted the fair value accounting standard for those assets that are re-measured and reported at fair value at each reporting period. This standard establishes a single authoritative definition of fair value, sets out a framework for measuring fair value based on inputs used, and requires additional disclosures about fair value measurements. This standard applies to fair value measurements already required or permitted by existing standards.

The three levels of the fair value hierarchy under the standard are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024.

- **Mutual Funds:** Valued at the closing price reported on the active market on which the funds are traded.
- **Stable Value Fund:** Valued at the net asset value per share (NAV) of shares held by the Plan at year end. NAV is based on the underlying assets owned by the Fund, less its liabilities, and then divided by the number of shares outstanding. There are no significant redemption restrictions or unfunded commitments on these investments.

Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **NOTE 5 - TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the prototype adopted by the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with applicable requirements of the IRC, and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 6 - EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Certain investment instruments are managed by Vanguard. Vanguard is the recordkeeper, as defined by the Plan; therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

#### **NOTE 7 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100% vested and the assets will be allocated to each participant's account in the proportion that each account balance bears to the total of all account balances.
