Scope and Nature of the ERISA Section 103(a)(3)(C)

We have performed audits of the accompanying financial statements of McKissack Group, Inc. 401(k) the Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) "ERISA Section 103(a)(3)(C) Plan". Management has obtained certifications from a Qualified Institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

1. **DESCRIPTION OF THE PLAN**

The following description of the McKissack Group, Inc. (“Company”) 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information. The Plan was updated January 1, 2021.

General — The Plan is a voluntary defined contribution plan for eligible employees. It is subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA).

Eligibility and Participation — All employees not covered by a collective bargaining agreement or those considered as leased personnel and over 21 years of age are eligible to participate in the Plan at the first date of the calendar month.

Contributions — A participant may contribute up to 100% of their pre-tax salary as defined in the Plan. The Company has the discretionary ability to make a matching contribution for eligible participants based on their elective deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at one percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The participant may designate all or a portion of their 401(k) elective deferral contributions as Roth elective deferral contributions. The Company, in its sole discretion may make a matching contribution. Additional profit-sharing amounts for participants who completed at least 1,000 hours of service and employed by the Company on the last day of the year may be contributed at the option of the Company. For the year ended December 31, 2024, the Company did not make a profit-sharing contributions to Plan. Contributions are subject to certain IRS limitations.

Participant Accounts — Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options — Upon enrollment in the Plan, a participant may direct contributions to available investment options. Participants may change their investment options at any time as self-directed online or by contacting the Trustee.

Forfeited accounts — As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,539 and \$13,972, respectively. These accounts will be used to reduce future employer contributions.

Vesting — Participants are immediately vested in all participant contributions. Vesting in the Company contributions, if any, is based on years of services as follows:

1	20%
2	40%
3	60%
4	80%
5 or more	100%

However, if the Company must make matching contributions to satisfy nondiscrimination Plan provisions, participants will be 100% vested in those contributions. Upon retirement age, disability or death of a participant, the participant shall be deemed to be 100% vested in their entire account regardless of length of service. Forfeitures of non-vested account balances, if any, can be used to reduce the Company's contributions to the Plan.

Distributions and Withdrawals — Withdrawals may be made at retirement, attainment of age 59-1/2, disability, hardship, and separation of service or death. In the event of retirement, total and permanent disability or attainment of age 59-1/2, participants may make withdrawals either in a lump sum or in periodic payments over a period not to exceed life expectancy, as defined.

These withdrawals may begin at age 59-1/2. Withdrawals due to hardships are permitted subject to the Plan Administrator's approval. In the event of separation of service, a participant must withdraw from the Plan if their account is less than \$5,000. In the event your vested account is \$1,000 or less, upon separation, your vested account will be automatically be paid to the participant in a lump sum. Participant accounts may be "rolled over" by the employee into an IRA or similar plan. In the event of death, remaining balances in the participant's account will be paid to the participant's beneficiary.

2. **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting — The financial statements of the Plan are prepared on the accrual basis of accounting.

Excess Contributions Payable — The Plan is required to return contributions received during the Plan year in excess of the Internal Revenue Code Limits. There were no excess contributions payable as of December 31, 2024 and 2023.

Use of Estimates — The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition — Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisers and trustees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants — Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits — Benefits are recorded when paid.

Administrative Expenses — Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

3. **NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow up to 50% of their vested account subject to a minimum of \$1,000 and a maximum of \$50,000. The \$50,000 maximum amount will be reduced by the participant's highest outstanding loan balance in the previous 12 months. If you live in an area affected by a natural disaster, Federal relief laws may change available loan amounts. The interest rate is based on the rates available for similar loans from commercial lending institutions. As of December 31, 2024 and 2023, loans outstanding are due on various dates over the next 60 months. The maximum loan term for a principal residence is 10 years.

Repayment of all plan loans is made through payroll deductions. Loans are secured by the participant's account balance. No more than two loans will be allowed in any 12 consecutive month period, and no more than two loans may be outstanding at one time.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, “*Fair Value Measurements*”, are described as follows

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	<p>Inputs to the valuation methodology include:</p> <ul style="list-style-type: none"> • Quoted prices for similar assets or liabilities in active markets; • Quoted prices for identical assets or liabilities in inactive markets; • Inputs other than quoted prices are observable for the asset or liability; • Inputs that are derived principally from or corroborated by observable market data by correlation or other means. <p>If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.</p>

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the net asset value (NAV) of shares held by the plan at year-end.

Pooled separate accounts: Valued at the market value of the underlying assets plus income, less operating expenses on an accrual basis to arrive at a unit value, as determined by the Trustee. The underlying assets include mutual funds, bonds, short-term commercial paper, and publicly traded foreign and domestic stocks.

5. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible those changes in the values of investment securities and notes receivable will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for benefits.

6. INFORMATION CERTIFIED BY THE INVESTMENT TRUSTEE

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA – required supplemental schedule, including notes receivable and investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends as of the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (the Trustee of the Plan).

7. TAX STATUS

The Plan uses a prototype plan document sponsored by Principal Life Insurance Company. Principal Life Insurance Company received an opinion letter from the Internal Revenue Service (“IRS”), dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan’s management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan’s financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Principal Trust Company. Principal Trust Company is the Trustee, and therefore, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Principal Financial Group provides participant record keeping and certain administrative services to the Plan pursuant to a retirement plan services agreement between the Company and Principal Financial Group. Principal Financial Group receives revenue from pooled separate accounts and mutual fund service providers for services Principal Financial Group provides to the Plan. This revenue can be used to offset certain amounts owed to Principal Financial Group for its administrative services to the Plan.

9. PLAN TERMINATION

The Company has not expressed any intent to do so, but the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

10. ROLLOVERS

Participants may rollover part or all eligible distributions from eligible retirement plans. An aggregate of \$29,657 was rolled into the Plan during the year ended December 31, 2024, and is included in the rollovers in the statement of changes in net assets available for benefits.

11. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.
