Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTE 1. DESCRIPTION OF PLAN

The following description of the MMG Consolidated, Inc. (the Company) 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan's legal document for a more complete description of the Plan's provisions.

General

The Plan was established January 1, 1997 and is a defined contribution plan covering substantially all employees of Jaspers Food Management, Inc., and those of the following adopting employers: WV Restaurant Management, LLC, Monarch Management Group, Egg N' Joe Franchise Systems, LLC and Elmer's Restaurants, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Amendments and Restatements

On January 1, 2023, the plan adopted the June 30, 2020 version of the volume submitter plan provided by the plan's third party administrator, Pension Plan Specialists, PC.

Contributions

Participants may contribute up to 100 percent of their annual compensation to the Plan but not to exceed \$23,000 and \$22,500, for the years ended December 31, 2024 and 2023. Participants age 50 and over may also contribute an additional \$7,500 of catch-up contributions, per year, for years ended December 31, 2024 and 2023, respectively. The Plan also permits rollover contributions from other qualified plans, Sec. 403(b) and Sec. 457 plans, and certain IRA accounts. The Company may contribute a discretionary matching contribution to be determined by the Board of Directors each year. The employer matching contributions were \$123,380 and \$102,969, for the years ended December 31, 2024 and 2023, respectively.

Participants' Accounts

Each participant's account is credited with the participant's contribution, allocation of the employer's contribution and plan earnings, and is charged with an allocation of the plan's administrator expenses. Allocations are based on participant's earnings or account balances, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Participants may direct the investment of their account balances into various investment options offered by the plan.

Eligibility

When an employee has reached age 18 and has completed one year of service (1,000 hours) as defined in the Plan, they are eligible to make deferral contributions. Entry is on the first day of the plan year quarter coinciding with or next quarter following the date that the eligibility requirements have been met. Once initial eligibility is met, a participant is eligible to share in the Company contributions.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon, including rollover contributions. Vesting of employer contributions is based on service as follows:

1	20%
2	40%
3	60%
4	80%
5 or more	100%

A year of service is earned by the employee working at least 1,000 hours in that year.

Payment of Benefits

Upon termination of employment or termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account either in annuity payments, a lump-sum amount, or in equal installments over a fixed time period. If the participant's vested account balance is less than \$5,000, the participant's vest account balance may only be distributed in a single lump-sum payment. If the participant does not make timely distribution election, then the Plan will distribute the entire vested account balance in either a lump sum for balances of \$75 or less or an automatic distribution to an Individual Retirement Account (IRA) for balances more than \$75 but less than \$5,000.

Participants may elect to take a partial or total distribution when they reach age 59 ½ or at any time thereafter, even if they have not terminated employment with the Company.

In-Service Withdrawals

Hardship distributions are permitted from participants' vested accounts based on certain specific financial needs.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum of \$50,000 from their accounts for hardship reasons. Loans may not exceed 50 percent of the participant's vested account balance. Participants may only have one loan outstanding. Loans are secured by the vested balance in the participant's account and bear interest at a rate of 1% over the prime rate. Principal and interest is paid ratably through payroll deductions. Loan terms may not exceed five years for loan proceeds used to purchase a primary residence. As of December 31, 2024, rates of interest on outstanding loans are 9.00% to 9.50% with various maturities through 2034.

Forfeitures

Forfeitures of unvested benefits are available to pay Plan expenses or offset future employer contributions to the Plan. For the years ended December 31, 2024 and 2023, \$1,188 and \$9,060 were used to pay Plan expenses and \$296 and \$474 to offset employer contributions, respectively. The amounts of non-vested forfeitures held by the Plan were \$265 and \$280 as of December 31, 2024 and 2023, respectively

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts, and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are participant-directed investments. Investments in mutual funds are valued at fair value. Investments in stable value funds are valued at contract value.

The change in value of assets is recorded by the Plan as appreciation or depreciation in fair value of investments. Unrealized appreciation or depreciation of the investments is included in current operations and in net assets available for benefits. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Loans to participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. All loans are current and no valuation allowance is required for the years ended December 31, 2024 and 2023. Loans are fully secured by participant account balances and are treated as taxable distributions from the participant's account in the event of default, typically following termination of employment.

Administrative Expenses

As provided in the Plan agreement, administrative expenses of the Plan may be paid either by the Plan or the Company. Certain expenses of plan administration, including computer services, office supplies and payroll expenses of administration and clerical personnel are provided by the Company without charge to the Plan. Loan administration fee(s) to the Plan's third-party administrator for notes receivable from participants are withheld from the participants' loan proceeds. In addition, certain investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Payment of Benefits

Benefits are recorded when paid. Corrective distributions are accrued in the testing period to which they relate.

Subsequent Events

The Plan has evaluated all subsequent events through October 14, 2025, the date the financial were available to be issued.

NOTE 3. INFORMATION CERTIFIED BY TRUSTEE

The Plan administrator has elected the method of compliance permitted by Section 2520.203-8 of the Department of Labor Rules and Regulations for Reporting and Disclosures under ERISA. The Plan administrator has obtained a certification from The Standard Insurance Company, the trustee of the Plan, as of December 31, 2024 and for the year then ended that the following information provided to the Plan administrator by the Trustee is complete and accurate.

- Investments, at fair value
- Investments, at contract value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest and dividends
- Interest income on notes receivable from participants

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the year ended December 31, 2024, are reported in net increase in fair value of investments.

NOTE 4. FAIR VALUE MEASUREMENTS

The Plan uses fair value measurements to record certain assets and liabilities at fair value on a recurring basis, such as investments. The Plan uses the fair value hierarchy established in accounting literature that consists of three levels. These levels are based on the markets in which assets and liabilities are traded and the reliability of the assumptions used to determine fair value. These levels are:

Level 1: Prices determined using unadjusted, quoted prices in active markets for identical assets or liabilities.

Level 2: Prices determined using significant other observable inputs. The observable inputs valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Prices determined using significant unobservable inputs. In situations where quoted prices or observable inputs are unavailable (for example, when there is little or no market activity), unobservable inputs may be used. Unobservable inputs reflect the Plan's own assumptions about the factors that market participants would use in pricing the asset or liability and are based on the best information available in the circumstances.

Level 1 Investments at Fair Value

Mutual Funds: The fair value of mutual funds is based on quoted net asset values of shares as reported by the fund. The mutual funds held by the Plan are open-ended mutual funds registered with the U.S. Securities and Exchange Commission (SEC). The funds must publish their daily net asset value and transact at the prices. The mutual funds held by the Plan are considered to be actively traded.

Level 2 Investments at Fair Value

There are no plan assets requiring the use of Level 2 inputs for the periods presented.

Level 3 Investments at Fair Value

There are no plan assets requiring the use of Level 3 inputs for the periods presented.

NOTE 5. INVESTMENTS AT CONTRACT VALUE

Stable Value Fund: The Plan holds investments in Standard Stable Value Fund. These investments are fully benefit responsive and are reported at contract value. The value of these investments were \$60,399 and \$58,560 as of December 31, 2024 and 2023, respectively.

The Stable Value Fund is a fully benefit-responsive investment contract with The Standard Insurance Company and maintains the contributions in general accounts. Accounts are credited with contributions and interest earnings and charged for participant withdrawals and administrative expenses. The investment contracts issuer is contractually obligated to repay the principal and a special interest rate that is guaranteed to the Plan.

Because the investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to these investment contracts. The investment contracts are presented on the face of the statement of net assets available for benefits at contract value in arriving at net assets available for benefits. Contract value, as reported to the Plan by The Standard Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction under ERISA. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring.

NOTE 7. CONCENTRATIONS OF CREDIT RISK

The Plan had placed its investments with the American Funds family of funds, until February 28, 2024 when plan assets were transferred to The Standard. This institution has professionally managed funds whose investments consist of a numerous and diverse product mix. As part of the Plan's investment strategy, the trustees perform periodic evaluations of the relative credit standing and investment performance of financial institutions.

NOTE 8. TAX STATUS

The Plan uses a volume submitter document. The volume submitter obtained its latest opinion letter, dated June 30, 2022, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC).

NOTE 9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 10. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.
