## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of the Safe-Harbor 401(k) Profit Sharing Plan for Employees of Cayuga Home for Children dba Cayuga Centers, (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section—

- the amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion on the 2024 Financial Statements**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the 2024 Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agree to or are derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**NOTE 1 — DESCRIPTION OF PLAN**

The following description of the Safe-Harbor 401(k) Profit Sharing Plan for Employees of Cayuga Home for Children dba Cayuga Centers (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all non-union employees of the Cayuga Home for Children dba Cayuga Centers (the "Company") who are twenty-one years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Mutual of America Life Insurance Company is the insurance company, recordkeeper and Custodian of the Plan.

**Plan Provisions**

Management elected to apply certain provisions of the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act), a law in which, among others, extends the age for required minimum distributions to seventy-two. The optional features within the SECURE Act are currently being assessed but have not been implemented to date. Written amendments to the Plan to reflect these optional changes will be adopted at a later date in accordance with applicable law and Internal Revenue Service guidance.

**Contributions**

Participants that have met the minimum age requirement described above are immediately allowed to make elective salary deferral contributions up to 100% of annual compensation subject to certain limitations of the Internal Revenue Code. Participants are automatically enrolled in the Plan with an initial deferral rate of 1% in the first plan year, and 2% for the second year and subsequent years, unless the participant elects a different percentage or expressly elects not to participate in the Plan. Participants are also allowed to make rollover contributions to the Plan. Eligible participants, who attain the age of fifty before the end of the plan year, are eligible to make catch-up contributions.

The Plan has a Safe Harbor matching provision, which requires the Company to match contributions. The Safe Harbor match is calculated as 150% of the first 4% of covered compensation up to a maximum employer contribution equal to 6% of the participant's annual compensation.

The Company may also make an employer-based contribution, subject to the discretion of the Board of Directors. There were no employer-based contributions made for the years ended December 31, 2024, and 2023.

Participants become eligible for employer Safe Harbor matching and discretionary base contributions at the end of their first twelve months of employment, provided they complete at least 1,000 hours of service within that twelve-month period.

**Vesting**

Participants are always 100% vested in their elective salary deferral. Effective January 1, 2022, participants are always 100% vested in the Company's Safe Harbor matching contributions and employer base contributions plus actual earnings thereon. Prior to January 1, 2022, participants vested at a rate of 20% after two years of service and 20% each year thereafter with full vesting upon completion of six years of service for any employer contributions.

**Forfeited and Non-vested Accounts**

Prior to January 1, 2022, when a participant terminated, any amounts in the participant's account that the participant was not vested in were forfeited. Forfeitures of non-vested account balances can be used to pay administrative costs of the Plan or reduce employer contributions. The Company used \$6,328 and \$2,625 of available forfeitures to fund a portion of the employer Safe-Harbor matching contribution for the years ended December 31, 2024, and 2023, respectively. Available forfeited non-vested accounts were insignificant as of December 31, 2024, and 2023.

**Participant Accounts**

Each participant's account is credited with the employee contribution, employer contributions, the plan earnings and losses on all contributions, and administrative expenses. Allocations are based on account balances, according to specific terms provided by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account balance. Participants can access their account information via Mutual of America website, where they have the ability to change their elective deferrals and investment options as well as apply for participant notes receivable and request distributions.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts up to the lesser of a) \$50,000 reduced by the excess, if any, of the highest outstanding balance of loans from the Plan during the one-year period ending on the day before the loan is made or b) 50% of their vested account balance. The notes are secured by the balance in the participant's account. The maximum number of loans that a borrower may have outstanding under this Plan at any one time is 3. The interest rate charged for any loan shall be reasonable and commensurate with the current commercial rates charged on similar loans and are specified by the trustee at the time the loan is approved. Interest rates on outstanding loans range from 4.25% - 9.50% as of December 31, 2024. Principal and interest is repaid through automatic payroll deductions each pay period. The notes receivable and interest thereon shall be repaid over a period not to exceed five years unless the note is used to acquire a personal residence. The plan administrator will consider a note in default if any scheduled payment remains unpaid at the end of the cure period or there is an outstanding principal balance existing on a loan after the last scheduled repayment date. Any notes that are in default as defined by the plan document, are reported as either deemed distributions or benefit payments; see below.

**Deemed Distributions**

Deemed distributions represent the amount of unpaid principal on notes receivable from participants who are actively participating in the Plan and have not continued to make payments on their outstanding notes, as required under the plan document. There were no deemed distributions for the year ended December 31, 2024.

**Investment Options**

Upon enrollment in the Plan, a participant may direct their elective contributions to the Plan in various investment options. Participants may change their investment options daily through online access.

**Payment of Benefits**

Upon termination of service due to death, disability, retirement or other reasons, a participant or beneficiary may elect to receive the value of the vested interest in his or her account as a lump sum distribution or rollover contribution to another qualified plan. A participant of at least 59½ years of age may also be eligible to receive in-service distributions subject to the Plan's provisions.

**Hardship Withdrawals**

A participant may not withdraw any amounts allocated to their employer contributions and employee contributions accounts due to hardship.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all participants will become 100% vested in their accounts.

**NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The Plan maintains its accounting records and financial statements on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and overall market risk. Market risks include domestic and global events which could impact the value of investment securities, such as economic concerns, i.e., inflation and international conflicts, respectively. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

**Investment Valuation and Income Recognition**

A majority of the Plan's investments are pooled separate accounts held by Mutual of America Life Insurance Company, which are valued at the net asset value as a practical expedient as reported by the sponsor of the fund (see below) and the Plan also offers a fully benefit-responsive investment contract option, which is reported at contract value (see Note 4). All investment values have been certified by Mutual of America Life Insurance Company, the Custodian of the Plan (see Note 3). Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Pooled separate accounts invest primarily in domestic stocks, international stocks, and fixed securities, such as asset or mortgage-backed securities and corporate bonds, and in mutual funds that hold such investments, which are mainly publicly traded securities. Pooled separate accounts are valued at net asset value (NAV) per share, which serves as a practical expedient to estimate their fair value. The NAV of each pooled separate account is not publicly quoted in the active markets. Each pooled separate account can be redeemed at NAV as of the measurement date and can be redeemed on a daily basis. There were no unfunded commitments or redemption restrictions on these investments as of December 31, 2024. The investments measured at NAV per share used as a practical expedient are not required to be classified in the fair value hierarchy.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. Management individually reviews all notes receivable balances that exceed ninety days from the date of the most recent payment and based on the assessment of credit worthiness, estimates the portion, if any, of the balance that will not be collected. Currently, there is no valuation allowance recorded; however, management will record an allowance if and when potentially uncollectible participant notes receivable become material. If a participant defaults on a note receivable and distribution from the participant's account has been made during the plan year because the participant has left the Plan, the defaulted note receivable will be reported as benefits paid to participants on the statements of changes in net assets available for benefits and deducted from the receivable balance.

**Payment of Benefits**

Benefits are recorded when paid.

**Economic Dependency and Concentration of Credit Risk**

The majority of the Plan's net assets available for benefits are invested with Mutual of America as of December 31, 2024. Accordingly, the Plan is dependent upon the financial condition of Mutual of America.

**Administrative Costs**

Administrative costs, including legal and accounting costs, are the obligation of the Plan; however, the Company may pay or reimburse the Plan for such expenses. The Company did not reimburse the Plan for any expenses during the year ended December 31, 2024. Costs of maintaining participant accounts and managing the investments are paid directly out of plan assets (see Note 5).

**Subsequent Events**

Subsequent events were evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

**NOTE 3 — INFORMATION CERTIFIED BY THE CUSTODIAN**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024, and 2023, and net depreciation in fair value of investments and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company.

**NOTE 4 — FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan holds an investment in the Mutual of America Life Insurance Company Interest Accumulation Account, a fully benefit-responsive investment contract stated in accordance with the Financial Accounting Standards Board's authoritative guidance regarding accounting for fully benefit-responsive investment contracts held by certain investment companies, which states that contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Investments measured at contract value are not required to be classified in the fair value hierarchy. The interest rate credited to amounts in the Mutual of America Life Insurance Company Interest Accumulation Account is a current rate and is not dependent upon the length of time the assets are invested with Mutual of America Life Insurance Company. Such interest rates are reviewed on an annual basis for resetting. The benefit-responsive investment contract is designed to offer a fixed rate of return with no risk of loss of principal except as subject to charges upon withdrawal as described in the contract. The rate could be influenced by the performance of the underlying investments held by Mutual of America Life Insurance Company.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan); (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (iii) bankruptcy of the sponsor or other sponsor event (e.g., divestures or spin-offs of a subsidiary) that causes a significant withdrawal from the Plan; (iv) the failure of the trust to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA; or (v) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (i) an uncured violation of the Plan's investment guidelines; (ii) a breach of material obligation under the contract; (iii) a material misrepresentation; and (iv) a material amendment to the agreement without the consent of the issuer.

**NOTE 5 — PARTY-IN-INTEREST TRANSACTIONS**

The Plan's investments are managed by Mutual of America, the Custodian of the Plan. Fees paid for these services qualify as party-in-interest transactions and are included in the net appreciation in investments in the accompanying statement of changes in net assets available for benefits.

In addition, the Plan contracts with Mutual of America Investment Corp. to provide recordkeeping, third-party administrative and investment advisory services, which qualify as party-in-interest transactions. The fees paid by the Plan for these services amounted to \$20,594 for the year ended December 31, 2024.

**NOTE 6 — TAX STATUS OF PLAN**

Effective January 1, 2022, the Company adopted Mutual of America Life Insurance Company Pre-Approved Safe-Harbor 401(k) Profit-Sharing Plan Basic Plan Document No. 14 Adoption Agreement No. 001. The Internal Revenue Service has determined and informed the Company that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan’s trustees believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Accordingly, the Plan has been accounted for as a tax-exempt plan.

The Plan Administrator has reviewed the Plan’s operations for uncertain tax positions and believes there are no significant exposures. The Plan will include penalties and interest on income tax liabilities in administrative expenses if such amounts arise. The Plan did not incur any penalties and interest for the year ended December 31, 2024. The Plan is subject to examination by the IRS for the statutory period.
