We have performed an audit of the accompanying financial statements of Power Services Group 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). ### Note 1—Plan description

The following description of the Power Services Group 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

*General* – The Plan is a defined contribution plan covering all eligible employees (“participants”) of Power Services Group CR Intermediate, Inc. (the “Company” or “Plan Sponsor”) and Airco Power Services; Orbital Energy Services; Turbine Generator Maintenance; and Power Plant Services, Inc., which are participating employers in the Plan. Established February 1, 2014, the Plan was last amended and restated January 1, 2024. John Hancock Trust Company LLC (2024) and John Hancock Life Insurance Company (2023) are the “qualified institutions”, and the Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective January 3, 2024, balances from the previous defined contribution plan of Power Plant Services, Inc. (Power Plant Services, Inc. Profit Sharing 401(k) Plan) were transferred into the Plan.

*Eligibility* – Employees of the Company, excluding union employees, nonresident aliens, and residents of Puerto Rico, become eligible to defer compensation into the Plan and to participate in the Plan’s safe harbor contribution after they have completed 90 days of consecutive service. After satisfying the service requirement, employees may enter the Plan on the first day of the next Plan Year quarter.

*Contributions* – A participant may contribute a percentage of annual compensation, subject to certain limitations, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. For any participant that elects to automatically escalate their deferral percentage annually, and who did not make changes to their deferral election, the participant’s deferral of compensation will be automatically increased 1% of compensation each year until the participant’s deferral election reaches 15% of compensation.

The Company will make a safe harbor matching contribution equal to a percentage of each participant’s compensation. For the year ended December 31, 2024, the safe harbor matching contribution was 100% of participant deferral percentages up to 3% of eligible compensation plus 50% of participant deferrals between 3% and 5%, as defined by the Plan document. All contributions are subject to certain limitations, including Internal Revenue Services (“IRS”) limitations.

*Participant Accounts* – Each participant’s account is credited with the participant’s contributions, the Company safe harbor matching contributions, and Plan earnings or losses from that account’s investment activities and is charged with benefit payments and an allocation of administration expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting* – Participants are 100% vested in their entire account balance upon participation in the Plan.

*Investment Options* – Upon enrollment in the Plan, participants may direct all contributions into selected investment options as made available and determined by the Plan administrator. Participants have the option to transfer monies between funds and may change their investment options daily.

*Notes Receivable from Participants* – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance (excluding Roth contributions). Note terms shall not exceed five years unless the purpose of the note is to acquire a primary residence, in which case the note term shall not exceed 20 years. The notes are secured by the balance in the participant’s account and bear interest at rates that are commensurate with local prevailing rates. Principal and interest are paid ratably through payroll deductions or an ACH agreement.

### Note 1—Plan description (continued)

*Payment of Benefits* – Upon death, disability, retirement, or termination of service for any reason, a participant with \$5,000 or less in vested benefits will be automatically paid the value of the vested interest in their account as a lump sum distribution. A participant with more than \$5,000 in vested benefits must consent to receive a lump sum equal to the vested value of the participant's account. In addition, in-service withdrawals from a participant's account are permitted upon reaching age 59½ years of age or to the extent needed for financial hardship as defined by the Plan.

*Hardship Withdrawals* – The Plan allows participants to make hardship withdrawals to satisfy certain immediate and heavy financial needs. A participant may request an hardship withdrawal for certain qualifying expenses as defined by the Plan document and within what the IRS deems an immediate and financial need of the participant.

*Forfeitures* – Amounts forfeited from a participant's account shall be used first to pay administrative expenses and then may be used to reduce future Company safe harbor contributions. There was no forfeiture balance as of December 31, 2024 or 2023.

### Note 2—Summary of significant accounting policies

*Basis of Accounting* – The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

*Use of Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results could vary from the estimates that were used.

*Risks and Uncertainties* – The Plan provides for various investment options. Investments are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

*Notes Receivable from Participants* – Notes receivable from participants is measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan is reduced, and a benefit payment is recorded.

*Investment Valuation and Income Recognition* – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board of Trustees determines the Plan's valuation using information provided by the qualified institutions. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Unrealized gains and losses are recognized in the period in which they occur. Dividends are recognized in the period earned and realized gains or losses on securities are recorded in the period of sale. Net (depreciation) appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

*Payment of Benefits* – Benefit payments are recorded when paid.

*Administrative Expenses* – Administrative expenses of maintaining the Plan can be paid either by the Company or by the Plan. Expenses paid directly by the Company are excluded from these Plan financial statements.

The Plan Sponsor has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Trust Company LLC (2024) and John Hancock Life Insurance Company (2023), the qualified institutions, have certified to the completeness and accuracy of the following data included in the accompanying financial statements:

- Investments at fair value and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan’s independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

### Note 4—Fair value of financial investments

U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability and in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value. The standard describes three levels of inputs that may be used to measure fair value:

*Level 1* – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

*Level 2* – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

*Level 3* – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

**Note 4—Fair value of financial investments (continued)**

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used to measure the Plan's investments at fair value, including the general classification of such instruments pursuant to the valuation hierarchy:

*Mutual Funds* – These investments are public investment vehicles valued using net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

*Money Market Funds* – These investments are public investment vehicles valued at amortized cost with unit values determined on a daily basis. The underlying assets are generally comprised of short-term securities representing high-quality, liquid debt, and monetary assets. The valuation technique used is the market approach and the input is the unit value quoted to unitholders for investments and redemptions and are classified within Level 2 of the valuation hierarchy.

*Pooled Separate Accounts* – These assets are not available in an exchange or an active market; however, the fair value is determined based on NAV of the underlying mutual funds and other securities as traded in an exchange or active market. Securities held in the funds are generally priced using values obtained from independent pricing sources. Unit values are calculated each day. NAV is used as a practical expedient to estimate fair value and is shown outside the fair value hierarchy.

*Common Collective Trusts* – Investments in the common collective trusts are stated at estimated fair values, which have been determined based on the unit values of the funds. Each investment is valued at a daily calculated unit value, which is determined by the organization sponsoring such funds by dividing the funds' net assets at fair value by its units outstanding at each valuation date. The common collective trusts held by the Plan are further classified as stable value funds, which have indirect investments in synthetic and traditional guaranteed investment contracts. As the investments are indirect, there is no readily determinable fair value and the trust is valued at NAV practical expedient so it is shown outside the fair value hierarchy.

**Note 5—Related party and party-in-interest transactions**

Plan investments are managed by John Hancock Trust Company LLC (“John Hancock”), the investment advisor, as defined by the Plan. Therefore, transactions with John Hancock qualify as party-in-interest. Fees paid to John Hancock for investment management expenses were \$82,464 for the year ended December 31, 2024.

Certain administrative functions are performed by officers or employees of the Company and its subsidiaries for which no compensation was received from the Plan.

Notes receivable from participants are also considered party-in-interest transactions because they are transacted with Plan participants.

**Note 6—Plan termination**

Although the Company intends to maintain the Plan indefinitely, The Company may amend or terminate the Plan at any time in its sole discretion, subject to provisions of ERISA. If the Plan is terminated, all amounts credited to participants’ accounts will become 100% vested.

### **Note 7—Tax status**

The Plan adopted a pre-approved non-standardized profit sharing plan with a cash or deferred arrangement which received a favorable opinion letter from the IRS on June 30, 2020, which stated the Plan is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan has not received a determination letter specific to the Plan itself, and the Plan has been amended since receiving the opinion letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to business income tax.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 8—Prohibited transactions**

During 2024, participant salary deferral contributions and loan payments from participants to the Plan totaling \$619,525 were not remitted to the Plan in accordance with DOL’s rules regarding timely remittances on multiple occasions. Plan management calculated the lost earnings on these deferrals and plans to correct the late remittances through DOL’s voluntary Fiduciary Correction Program (“VFCP”) during 2025.

### **Note 9—Subsequent events**

In accordance with U.S. GAAP related to subsequent events, the Plan has evaluated all events subsequent to the statements of net assets available for benefits date of December 31, 2024 through October 15, 2025, the date these financial statements were available to be issued.
