Scope And Nature Of The ERISA Section 103(a)(3)(C)

The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

1. Description Of The Plan

The following description of the Crews Enterprises, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan, which has been adopted by Crews Enterprises, Inc. (the Company), became effective January 1, 2011 and consists of the following: (1) a defined contribution employer-matching plan covering eligible employees, (2) an Internal Revenue Service (IRS) Section 401(k) Plan, which is a salary deferral arrangement covering all employees who elect to participate after the completion of three months of employment and are age twenty-one or older, and (3) a discretionary profit sharing contribution plan for non-excluded (union) employees of the Company who meet defined allocation conditions as defined in the Plan Document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Effective January 15, 2022, the Plan was restated and added The Tavern at Rancho Park, LLC as an affiliated employer of the Company.

Contributions

Each year, participants may contribute up to the full amount of their annual pre-tax compensation up to the maximum amount allowed by law. Participants may also rollover amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company may make matching contributions equal to a discretionary percentage, to be determined by the Company, for non-excluded employees, as defined in the Plan Document. For the year ended December 31, 2024, the Company made matching contributions for non-excluded retail employees of 100% of the first 3% of deferred employee contributions, matching contributions for non-excluded restaurant employees of 25% of the first 6% of deferred employee contributions and matching contributions for all excluded (non-union) employees of 25% of the first 4% of deferred employee contributions.

Notes To Financial Statements (*Continued*)

In addition, the Company shall have the right to make an additional profit sharing contribution which shall be allocated to each eligible employee in the following steps: (1) in the same proportion that eligible employee's compensation plus their compensation in excess of the Social Security Taxable Wage Base (excess compensation) bears to the total compensation of all eligible participants. However, the maximum amount which can be allocated to an eligible employee in this first step is 5.7% of the eligible employee's compensation plus their excess compensation, (2) the remaining profit sharing contributions, if any, will be allocated to eligible employees in the same proportion that their compensation bears to the total compensation of all participants. These contributions, if any, are vested as defined in the vesting section of Note 1. For the year ended December 31, 2024, the Company decided not to make discretionary profit sharing contributions.

Participant Accounts

Each participant's account includes the participant's elective deferral, the Company's matching contribution, rollovers deposited from qualified participant accounts, profit sharing contributions, and an allocation of Plan earnings (losses). Allocations are proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan, as defined in the Plan Document. Participants direct the investment of their contributions into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their elective deferrals. Non-excluded employees are immediately vested in Company matching contributions plus actual earnings thereon. Vesting for the Company's matching contributions to excluded employees and in the Company's profit sharing contribution portion of their accounts is based on periods of service as follows:

The affected participants of the partial plan termination were determined to be 100 percent vested in their accounts notwithstanding their credited service.

Payment Of Benefits

Upon termination of employment for reasons other than death, disability or retirement, a participant is eligible to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or in installments. The Plan allows for in-service distributions if a participant reaches age 59-1/2. If a participant terminates for reasons other than normal retirement, disability or death, and the value of the participant's vested account balance is less than or equal to \$5,000, then a distribution is made in accordance with the provisions of the Plan providing for an automatic distribution to a participant without the participant's consent. All distributions of more than \$5,000 require participant consent.

Hardship Withdrawals

A participant may make withdrawals from his or her participant deferral contributions account in the event of undue financial hardship, which includes payments for education expenses, medical or burial expenses, the purchase of a home or delinquent mortgage payments, and for the repair of damage to the participant's principal residence as defined by the Plan Document.

Forfeitures

Participant forfeitures may be used to pay the Plan's administrative expenses. Forfeiture balances as of December 31, 2024 and 2023 were \$990 and \$77, respectively. Forfeitures used during 2024 were \$1,123 for administrative expenses.

Administrative Expenses

The Company pays a portion of administrative expenses incurred by the Plan. Other administrative expenses are paid by the Plan.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investments Valuation And Investment Income Recognition

The Plan's investments, other than the fully benefit-responsive investment contract, are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Investment contracts held by a defined contribution plan that are fully benefit-responsive are reported at contract value, rather than fair value, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's investment in the Minnesota Life Guaranteed Return Account is a fully benefit-responsive investment contract and is reported at contract value in the statement of net assets available for benefits.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation represents the difference between the aggregate fair value of investments at year end and the values at the beginning of the year and includes any realized gains and losses on investments bought and sold during the year.

Payment Of Benefits

Benefit payments are recorded when paid.

Subsequent Events

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

3. Certified Financial Information

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net change in fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Standard Insurance Company. This information has not been audited by the Plan's independent auditors.

4. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value of investments. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under standards are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Notes To Financial Statements (*Continued*)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

Pooled Separate Accounts (PSAs)

Valued at the net asset value (NAV) of units held by the Plan at year end. The NAV, as provided by Minnesota Life Insurance Company, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. All of the pooled separate accounts held by the Plan are redeemable daily, and all file an annual report on Form 5500 as a direct filing entity.

These investments are measured at fair value using the NAV per share (or its equivalent) as a practical expedient, and therefore have not been categorized in the fair value hierarchy.

The method described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes in the valuation methodology used at December 31, 2024 or 2023.

5. Income Tax Status

This Plan has adopted a volume submitter plan sponsored by Minnesota Life Insurance Company. Minnesota Life Insurance Company has received a favorable opinion letter from the IRS, dated June 30, 2020, which states that the volume submitter plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Notes To Financial Statements (*Continued*)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and terminate the Plan, in its entirety, at any time subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

7. Party In Interest Transactions

Plan investments are managed by Minnesota Life Insurance Company, the Custodian of the Plan. Therefore, these transactions qualify as party in interest transactions as defined by ERISA.

Administrative expenses paid by the Plan to Securian Financial Group, the third party administrator, were \$3,981 for the year ended December 31, 2024. These transactions qualify as party in interest transactions as defined by ERISA.

8. Risk And Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. It is at least reasonably possible, given the level of risk associated with investment securities that changes in the values of investment securities in the near term could materially affect a participant's account balance and the amounts reported in the statement of net assets available for benefits.

9. Investment Contract With Insurance Company

The Plan entered into a fully benefit-responsive investment contract with Minnesota Life Insurance Company (Minnesota Life). Minnesota Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Minnesota Life. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The contract is fully benefit-responsive, therefore contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the contract.

Minnesota Life Guaranteed Return Account investment choice seeks to provide a safe investment by establishing a rate, or rates, for monies invested in the general account. This rate, or rates, may change periodically. The general account assets are invested in the general assets of Minnesota Life and are predominately fixed income investments (bonds, mortgages, private placements) of high quality. All benefit payments prior to contract liquidation are made at book value (principal invested plus interest earned).
