We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

#### 1. Plan Description

The following description of Proplogix, LLC Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan's provisions.

- a) *General* – The Plan is a 401(k) defined contribution plan covering substantially all eligible employees of Proplogix, LLC ("Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan has a restatement date of September 4, 2023.
- b) *Eligibility* – The Plan substantially covers all employees of the Company who have completed 500 hours of service in a six month period and are age eighteen or older. The Plan excludes part time, temporary and seasonal employees scheduled less than 1,000 hours. Once an eligible employee has satisfied the eligibility requirements the employee immediately becomes a participant in the Plan.
- c) *Contributions* – Eligible participants are automatically enrolled in the Plan on a pre-tax basis at 2% of eligible compensation should a deferral election not be made. Each year participants may contribute to the Plan up to the maximum amount allowed by law, subject to certain limitation under the Internal Revenue Code ("IRC"). Contributions may be made pre-tax or post-tax (Roth). Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit plans or defined contribution plans (rollover contributions).

The Company may, at its sole discretion, make matching contributions for all eligible employees who have made contributions in the current year. For the year ended December 31, 2024, the Company contributed 100% of the first 1% of compensation contributed by participants. Company matching contributions were \$142,593 in 2024. The Company may also make discretionary profit sharing contributions. No discretionary profit sharing contributions were made during 2024.

Participants direct the investment of their contributions and the Company's contribution into various investment options offered by the Plan. Participants may change their investment options at any time via the telephone or website.

- d) *Participants Accounts* – Each participant's account is credited with the participant's contributions and allocation of (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Administrative expenses maybe charged based on account balances or charged equally to each participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- e) *Vesting* – Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is vested 100 percent after two years of credited service.
- f) *Notes receivable from Participants* – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at 1% above prime rate. Participants are allowed to have only one loan outstanding at any time. Principal and interest is paid ratably through payroll deductions.
- g) *Excess Contributions Payable* – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants on March 27, 2025.
- h) *Payment of Benefits* – In the case of retirement, death, disability or termination of employment, participants may elect to receive the vested accumulated value of their account in a lump sum distribution.

- i) *Forfeited accounts* – Forfeitures of nonvested balances may be used to reduce Company contributions or pay plan expenses. At December 31, 2024 and 2023, the Plan had \$51,315 and \$27,464, respectively of nonvested forfeited accounts from terminated participants. Forfeitures in the amount of \$450 were used to pay plan expenses during 2024

## 2. Summary of Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan to make estimates and assumptions that affect the reported amounts of net assets and changes therein. Actual results could differ from these estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain administrative costs of the Plan are paid directly by the Company.

### 3. Subsequent Events

The Plan has evaluated events and transactions occurring subsequent to December 31, 2024 through October 15, 2025, which is the date the financial statements were available to be issued.

#### 5. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trusts - These units of the common/collective trust accounts are stated at fair value as determined by the issuer of the account based on the fair value of the underlying investments. Individual participant accounts invested in the common/collective trust accounts are maintained on a unit value basis.

Stable Value Fund – Stable value option is a deposit liability of Transamerica with no underlying assets and are based on the general unallocated account of Transamerica and the risk of investment is based on Transamerica’s insurance ratings. Regardless of the activity of the Transamerica general fund, Transamerica pays the stated interest rate and backs the capital deposit where the “risk” is measured by the insurance credit rating. The stable value fund is considered fairly valued at contract value which is the equivalent of fair value and is included in level 2 of the fair value hierarchy.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value.

#### **6. Risks and Uncertainties**

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### **7. Related Party Transactions and Party-in-Interest Transactions**

The Plan's investments are held and managed by the Plan custodian, Reliance Trust Company, and therefore these transactions qualify as party-in-interest transactions.

#### **8. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Company contributions.

#### **9. Tax Status**

The Plan is a pre-approved defined contribution plan ("Pre-approved Plan") sponsored by Dyatech LLC ("Dyatech"). Dyatech obtained its latest opinion letter dated June 30, 2020, in which the IRS stated that the Pre-approved Plan as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, Plan management believes that the Plan is currently designed, and is currently being operated in compliance the applicable requirements of the IRC, and therefore, believes that the Plan is qualified, as the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.
