Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other matter – supplemental schedule required by ERISA

These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A - PLAN DESCRIPTION

The following brief description of the NorthWinds Technology Solutions Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan is a defined contribution plan established by NorthWinds Technology Solutions, LLC (the Company or Employer) on January 1, 2020, and is a spin-off of the Delta Dental of Wisconsin, Inc. (DDWI) Retirement Plan that was established on January 1, 1998. The Plan covers all employees of the Company, except for those who are governed by a collective bargaining agreement; part-time, temporary or seasonal employees who work less than 1,000 hours of service during the year; or those classified as leased employees or independent contractors. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Plan Transfers

Effective January 1, 2022, employees from Corvesta, Inc. (Corvesta) were transferred to the Company. On the effective date, those employees had their assets in the Corvesta, Inc. New Comparability Cash or Deferred Profit Sharing Plan transferred into the Plan. Total assets transferred from the former plan to the Plan were \$0 and \$472,710 for the years ended December 31, 2024 and 2023, respectively.

Eligibility

Any employee who is 18 years of age or older is eligible to participate in the Plan after the completion of one month of eligible service. In order to be eligible for the Company's discretionary profit-sharing contribution, the employee must be eligible to participate in the Plan and employed on the last day of the Plan year for which the contribution is being made, unless their termination during the year was due to death, disability or normal retirement.

Contributions

Participants may elect to make contributions to the Plan by deferring pre-tax and/or after-tax compensation, as defined in the Plan document, up to 75% of their eligible compensation, not to exceed the limits of the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from another qualified plan (rollovers).

Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions.

New employees are automatically enrolled in the Plan upon meeting the eligibility requirements at an employee deferral contribution pre-tax rate of 6% of eligible compensation, unless an alternative election is made by the employee.

The Plan provides for Company matching contributions equal to 100% of a participant's contribution up to 6% of the participant's eligible compensation. The Plan provides for additional discretionary catch-up Company matching contributions to ensure each participant's contributions as a percentage of eligible compensation are matched up to 6%.

The Plan also provides for Company discretionary profit-sharing contributions. The Company elected to make a discretionary profit-sharing contribution equal to 5% of participant eligible compensation for the Plan years ended December 31, 2024 and 2023. The 2024 discretionary profit-sharing contribution

amounted to \$1,273,138 and will be remitted to the Plan in 2025. The 2023 discretionary profit-sharing contribution amounted to \$1,168,798 and was remitted to the Plan in 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions, the Company's discretionary profit-sharing contributions, and an allocation of the Plan's earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or losses or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct the investment of all employee and Company contributions plus actual earnings thereon into various investment options offered by the Plan. Participants may change their investment options daily.

Vesting

Participants are always 100% vested in their contributions, the Company's matching contributions and actual earnings or losses thereon. Vesting in the Company's discretionary profit-sharing contributions is based on years of credited service, at 20% for each year of service until becoming fully vested upon completion of five years of service. Vesting service includes service with DDWI, Delta Dental of Illinois and Corvesta.

Forfeitures

Forfeitures are used to reduce future Company contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$13,946 and \$7,474, respectively. In 2024 and 2023, employer contributions were reduced by \$7,474 and \$42,397, respectively, from forfeited non-vested accounts.

Benefit Payments

A participant or beneficiary is entitled to receive, as benefits, the vested balance in their accounts in the form of a lump-sum payment, periodic installments, a joint and survivor annuity, or some other form of annuity. Benefits may also be paid directly to an eligible retirement plan as an eligible rollover distribution. In addition, hardship withdrawals are permitted in certain situations, as described in the Plan agreement. Participants may elect to defer commencement of distributions until they attain the applicable required minimum distribution age. Vested balances under \$5,000 are automatically distributed upon termination.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, whichever is less. Participants may only have one loan outstanding at any given time. Participants of Corvesta transferred their previously held loans and must repay their existing loans before obtaining new loans. The notes receivable are secured by the balance in the participant's account and bear interest at a rate commensurate with commercial lenders for loans made under similar circumstances determined by the Plan Administrator. The interest rate and the loan term are fixed at the inception of each loan based on the requirements in the Plan agreement, with loan terms not to exceed five years unless the loan is used for the purchase of a primary residence. Principal and interest are paid ratably through monthly payroll deductions.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Notes receivable from participants outstanding at December 31, 2024 and 2023 bear interest at rates ranging from 3.25% to 8.50%. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable from participants are reclassified as benefit payments based upon the terms of the Plan.

Payment of Benefits

Benefits paid to participants are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Plan, to the extent not paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE C - FAIR VALUE MEASUREMENTS

There is a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value and their classification in the valuation hierarchy as of December 31, 2024 and 2023:

Mutual Funds - Valued at the net asset value (NAV) of shares held by the Plan at year end, which is obtained on an active market.

Collective Trust Funds - Valued based on the fair value of the collective trusts' underlying investments. The NAV, as provided by Principal Trust Company (the Custodian), which is obtained on an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Total investment income and interest income on notes receivable from participants, as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023; and
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

NOTE E - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by the Custodian and, therefore, these transactions qualify as party-in-interest transactions.

Notes receivable from participants are considered party-in-interest transactions. Certain administrative expenses are paid directly by the Company. Both transactions are exempt from the prohibited transaction rules of ERISA.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts and distributions to participants will be made in accordance with the provisions of the Plan.

NOTE G - INCOME TAX STATUS

The Company is a participating employer in the Principal Trust Company Volume Submitter Prototype Plan approved by the Internal Revenue Service (IRS). The prototype plan obtained its latest approval letter on August 8, 2014, in which the IRS stated that the Plan, as then designed, was qualified under Section 401(a) of the IRC. The Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC in all material respects.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H - SUBSEQUENT EVENTS

The Plan evaluated its December 31, 2024 financial statements for subsequent events through October 15, 2025, the date the financial statements were available to be issued. The Plan is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
