As communicated in our engagement letter dated June 3, 2025, our responsibility, as described by professional standards, is to conduct our audit in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Therefore, as permitted by ERISA Section 103(a)(3)(C), the audit need not extend to any statements of information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”). For an ERISA Section 103(a)(3)(C) audit, the audit does not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States (“US GAAP”). Accordingly, the objective of the ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with US GAAP.

Our responsibility, as prescribed by professional standards, is to plan and perform our audit to obtain reasonable, rather than absolute, assurance about whether the financial statements are free of material misstatement. An audit of financial statements includes consideration of internal controls over financial reporting as a basis for designing audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan’s internal control over financial reporting. Accordingly, as part of our audit, we considered the system of internal control of the Plan solely for the purpose of determining our audit procedures and not to provide any assurance concerning such internal control.

However, we are not required to design procedures for the purpose of identifying other matters to communicate to you.

We have provided our comments regarding a significant deficiency in internal control noted during our audit in a separate letter to you dated October 15, 2025.

### **Planned Scope and Timing of the Audit**

We conducted our audit consistent with the planned scope and timing we previously communicated to you.

### **Compliance with All Ethics Requirements Regarding Independence**

The engagement team, others in our firm, as appropriate, and our firm have complied with all relevant ethical requirements regarding independence. We are not aware of any relationships that, in our professional judgment, may reasonably be thought to bear on our independence. In accordance with our engagement letter, we were engaged to perform non-attest services in assisting the Company with the preparation of the financial statements and supplementary schedule of delinquent participant contributions. Management assumes all responsibilities for the financial statement and supplemental schedule preparation services and any other non-attest services we provide; oversees the services by designating an individual with suitable skill, knowledge, or experience; and evaluates the adequacy and results of the service. Safeguards in place related to our financial statement and supplemental schedule preparation service includes a review by an independent second partner, who is not part of the engagement team. In addition, management has reviewed and approved the financial statements and supplemental schedule prepared.

### **Significant Risks Identified**

We have identified the following significant risks:

- Management override of controls
- Improper revenue recognition

### **Significant Risks Identified (continued)**

Significant risks identified are assessed risks of material misstatement that in our professional judgment, require special audit consideration. We did not identify any misstatements related to these identified risks.

### **Qualitative Aspects of the Plan's Significant Accounting Practices**

#### *Significant Accounting Policies*

Management has the responsibility to select and use appropriate accounting policies. A summary of the significant accounting policies adopted by the Plan is included in Note 2 to the financial statements. There have been no initial selection of accounting policies and no changes in significant accounting policies or their application during the year ended December 31, 2024. No matters have come to our attention that would require us, under professional standards, to inform you about (1) the methods used to account for significant unusual transactions and (2) the effect of significant accounting policies in controversial or emerging areas for which there is a lack of authoritative guidance or consensus.

#### *Significant Accounting Estimates and Related Disclosures*

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's current judgments. Those judgments are normally based on knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ markedly from management's current judgments.

The most sensitive accounting estimates affecting the financial statements are those that relate to the reported amounts of investments as of December 31, 2024, which were certified by a qualified institution.

Management's estimate of the fair values of the Plan's Level 2 investments are based on benchmark yields, reported trades, material event notices, new issue data, and other reference data including market research publications.

## **Qualitative Aspects of the Plan's Significant Accounting Practices (continued)**

### *Financial Statement Disclosures*

Certain financial statement disclosures involve significant judgment and are particularly sensitive because of their significance to financial statement users. The most sensitive disclosures affecting the Plan's financial statements relate to fair value estimates and the Plan's tax-exempt status.

During the year ended December 31, 2024, an operational error was discovered relating to certain employee deferral rates not being applied accurately. As of the date the financials were available to be issued, management had not completely quantified the impact of this operational error. Management expects to have corrective amounts determined and all corrections made during 2025 in order to preserve the Plan's tax-exempt status.

The financial statement disclosures are neutral, consistent, and clear.

### **Significant Unusual Transactions**

For purposes of this communication, professional standards require us to communicate to you significant unusual transactions identified during our audit. We noted no such transactions.

### **Identified or Suspected Fraud**

We did not identify any fraud nor did we obtain information that indicates fraud may have occurred.

### **Significant Difficulties Encountered During the Audit**

We encountered no significant difficulties in dealing with management relating to the performance of the audit.

In some cases, management may decide to consult with other accountants about auditing and accounting matters. To our knowledge, there were no consultations with other accountants regarding auditing and accounting matters.

Our responsibility also includes communicating to you any information which we believe is a material misstatement of fact. Nothing came to our attention that caused us to believe that such information, or its manner of presentation, is materially inconsistent with the information, or manner of its presentation, appearing in the financial statements.
