### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements G.A. Food Services of Pinellas County, Inc 401k Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of G.A. Food Services of Pinellas County, Inc, 401k Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. #### **Note A - Description of Plan**

The following description of the G.A. Food Services of Pinellas County, Inc. (“the Company”) 401(k) Profit Sharing Plan (“the Plan”) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan’s provisions.

##### *General*

The Plan is a defined contribution plan covering all full-time and part-time employees of the Company who have completed three months of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employees are eligible for elective salary deferrals and employer matching contributions the first day of the month following completion of three months of service. Employees are eligible for employer profit sharing contributions after twelve months of service. To be eligible for any such employer contributions, employees must also have completed at least 1,000 hours of service and be employed by the Company on the last day of the Plan year.

##### *Contributions*

Employee pre-tax and Roth contributions are permitted up to 100% of employee compensation or maximum dollar limit allowed by law, whichever is less. In addition, participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). Contributions are subject to certain limitations.

The Plan includes an auto-enrollment provision whereby all newly eligible employees and any currently eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a target date fund until changed by the participant. Additionally, their deferral rate will automatically increase by 1% annually in their third, fourth and fifth years of participation, with a maximum of 6%, unless they make an election to the contrary.

The Plan allows the Company to make discretionary matching contributions and additional discretionary profit sharing contributions. The Plan allows the Company to annually determine the matching percentage formula and allows the Company to fund the matching contributions when the participants become vested to that year’s discretionary matching contribution. The Company did not make any discretionary matching or discretionary profit sharing contributions for the year ended December 31, 2024.

##### *Participant Accounts*

Each participant's account is credited with the participant's contributions, the Company’s discretionary matching contribution, an allocation of the discretionary profit sharing contributions, and Plan earnings. Allocations of discretionary profit sharing are based upon eligible compensation, as defined. Other allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### *Investment Options*

The Plan is a “participant-directed account plan.” As such, it provides individual accounts for participants to select how the assets in their accounts are invested. The Plan currently offers a common/collective trust fund and numerous mutual funds as investment options for participants, each with different risk exposure and return potential.

##### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Only one loan may be outstanding at any given time. Loans are secured by the balance in the participant’s account and bear interest at the prime rate (as of the loan date) plus 1%. Repayment is required within five years through payroll deductions, or by check for prepayments only. At December 31, 2024 and 2023, the interest rate is 8.5% and 9.5%, respectively.

##### *Vesting*

Vesting provisions of the Plan apply to the employer matching contributions and profit sharing contributions. Employees are always 100% vested with respect to their contributions and related investment income. Employees are vested in the employer matching and profit sharing contributions with at the rate of 20% per year for each year of service following completion of one full year of participation, so that a participant is fully vested after six consecutive years of service. In the event of employee disability or death, the employer matching and profit sharing contributions are 100% vested.

##### *Payment of Benefits*

On termination of service, a participant may elect to receive either a single lump-sum payment in an amount equal to the value of the vested interest in his or her account, partial withdrawals, or installment payments over a period of time for required minimum distributions. Upon termination, if a participant’s vested account balance does not exceed \$5,000, his or her vested account balance may only be distributed in a lump-sum payment.

If a participant is terminated due to death, his or her beneficiary will receive the payment. If the participant is married, his or her spouse is automatically considered the beneficiary, unless the participant and his or her spouse name someone else as the beneficiary. If a participant is single, he or she may name anyone to be the beneficiary.

##### *Hardship Withdrawals*

A hardship withdrawal is one that is necessary in light of the immediate and heavy financial needs of the participant and cannot be met from other reasonably available resources. Participants that are current employees are permitted to make hardship withdrawals from the fully vested portion of their account balance.

**Note B - Summary of Significant Accounting Policies**

*Forfeitures*

Forfeitures of non-vested employer contributions and interest earnings thereon by terminated participants may be used as employer matching contributions or to pay Plan expenses for the Plan year in which forfeited. The Plan did not have any contributions forfeited during the year ended December 31, 2024.

*Basis of Accounting*

The accompanying financial statements are prepared on the accrual basis of accounting.

*Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

*Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

*Excess Contributions Payable*

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants during 2025. Since these amounts were not remitted prior to March 15, 2025, the Company will file a Form 5330 for 2024 and pay the applicable excise tax. The excise tax payments will be made from the Company's assets and not from the assets of the Plan.

*Payment Benefits*

Benefits are recorded when paid.

##### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

Certain administrative functions are performed by officers or employees of the Company. None of these officers or employees received compensation from the Plan in 2024.

#### **Note C – Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Newport Trust Company, LLC for the period January 1, 2024 through November 13, 2024 and Ascensus, LLC for the period November 14, 2024 through December 31, 2024 (the trustees of the Plan).

#### **Note D - Fair Value Measurements**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The following is a description of the valuation methodologies used by the Plan at December 31, 2024 and 2023:

*Mutual Funds:* The fair values of registered investment companies (e.g., mutual funds) are based on quoted market prices based on the net asset values of the shares held by the Plan at year-end.

*Common/Collective Trust Fund:* A stable value fund that is composed primarily of fully benefit-responsive investment contracts, that is valued at the net asset value of the units of the bank collective trust held at year-end. The net asset value is used as a practical expedient to estimate fair value. The practical expedient would not be used if it was determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. Participant transactions (purchase and sales) may occur daily. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

#### **Note E - Related-Party Transactions and Party-in-Interest Transactions**

Newport Trust Company, LLC (for the period January 1, 2024 through November 13, 2024) and Ascensus, LLC (for the period November 14, 2024 through December 31, 2024) are the trustees as defined by the Plan, therefore, fees paid to them qualify as party-in-interest transactions. Such fees paid by the Plan were approximately \$40,000 for the year ended December 31, 2024. The Plan Sponsor pays directly any other fees related to the Plan's operations.

#### **Note F - Tax Status**

The Internal Revenue Service (IRS) has determined and informed the trustees by a letter dated June 30, 2020 that their prototype plan (which is the plan utilized by the Company) and related trust is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the trustees and Plan administrator believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note G - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions. Payments will be made in the same manner as in participant termination.

#### **Note H - Concentrations, Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
