Note 1. Plan Description

The following brief description of ScribeAmerica, LLC 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan, which was established on January 1, 2014 and subsequently amended, is classified as a defined-contribution plan covering employees of ScribeAmerica, LLC (the “Company”), with at least 1 year of service, at least 1,000 hours of service during the Plan year, and who attained the age of 18. The primary purpose of the Plan is to provide retirement savings benefits to employees of the Company, which is the Plan Sponsor. The Plan’s funds were held by Mutual of America Life Insurance Company (the “Previous Plan Custodian”) as of December 31, 2023. During the year ended December 31, 2024, the Plan’s funds were transferred to Fidelity Management Trust Company (the “Current Plan Custodian”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may elect to defer up to 90% of their compensation, not to exceed Internal Revenue Service (“IRS”) limits, as defined in the Plan document. Participants may also contribute amounts representing distributions from other qualified plans. Participants may change their salary deferral percentage at the beginning of each pay period. There were no employer contributions during the year ended December 31, 2024.

Participant Investment Account Options

Participants direct the investment of their accounts into various investment options offered by the Plan. Investment account options available include registered investment companies, money market fund, and a collective investment trust fund.

Participant Accounts

Under the Plan, a separate account is maintained for each participant. Each participant’s account is credited with the participant’s contribution, and allocations of Plan earnings, and charged with an allocation of administrative expenses, if any. Participant contributions and employer matching contributions and discretionary contributions, if any, are allocated, at the participant’s election, to investment funds held at either the Previous Plan Custodian or Current Plan Custodian. Plan earnings are allocated based on the actual earnings of the respective participants’ investments. Participants may change their investment options at any time with certain exceptions.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balances by executing a note in accordance with the Plan’s provisions. The notes are collateralized by the balance in the participant’s account and bear interest at rates ranging from 9.00% to 9.50%, as determined by the Plan administrator, based on prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. Participants may only have one outstanding loan at any one time, and the loan must be generally repaid within five years from the date of the loan. Principal and interest are paid ratably through payroll deductions.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon.

Payment of Benefits

Upon the death, permanent disability, or retirement of participants, their entire account balances become fully vested. Distribution of benefits may be made in a lump-sum cash payment. Participants who terminate for reasons other than death, disability, or retirement are entitled only to their vested balances. As of December 31, 2024 and 2023, there were no amounts allocated to the accounts of individuals who have elected to withdraw from the Plan but have not been paid.

Note 2. Summary of Significant Accounting Policies

The following is a summary of significant accounting policies followed in the preparation of these financial statements, which have been prepared in accordance with accounting principles generally accepted in the United States of America.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Forfeitures

Forfeitures of terminated participants' nonvested accounts are used to reduce employer-matching contributions or to pay Plan administrative expenses. The unallocated balance of forfeitures approximated \$19,000 and \$13,000 as of December 31, 2024 and 2023, respectively. There were no significant forfeitures used during the year ended December 31, 2024.

Investment Valuation and Income Recognition

The Plan's investments as of December 31, 2024, are stated at fair value and are invested in registered investment company fund vehicles, collective investment trust funds, and a money market fund. Investments held in registered investment companies are valued at the daily closing price, as reported by the fund. The registered investment company funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The registered investment company funds held by the Plan are deemed to be actively traded and are considered Level 1 investments within the fair value hierarchy (see Note 4).

The Putnam Large Cap Value A Fund, CIT Large Cap Growth Fund III CL R1, Janus Henderson International Alpha Equity, Great Gray Trust FIAM Core Plus, Janus Henderson Enterprise Fund Class, and MFS Mid Cap Value Fund A (collectively, the "CIT Funds") are held in a collective investment trusts. The underlying investments in the CIT Funds are securities for which market quotations are readily available and are valued based on the last trade from the primary exchange. For listed securities for which no sales were reported, the closing bid price may be used. For all other securities, the Fund Trustee may use the indicator of fair value provided by an external pricing vendor in connection with determining the fair value of such security. The CIT Funds are considered a Level 2 investment within the fair value hierarchy (see Note 4).

The money market fund is valued at the reported market price.

The Plan's investments as of December 31, 2023 are held in pooled separate accounts and in an insurance company general account. Investments in the pooled separate accounts are reported at fair value. The pooled separate accounts are valued using a market valuation basis at the calculated net asset value ("NAV") of the funds. NAV is based upon the fair market value of the funds' underlying investments, less any unpaid expenses.

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts. Contract value was deemed to be the relevant measurement attribute for those contracts, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions and reinvested income, less any withdrawals, plus accrued interest. The Plan's investments in the insurance company general account were stated at contract value (see Note 5).

Purchases and sales of securities were recorded on a trade-date basis, and interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. The net appreciation in the fair value of the Plan's investments include the Plan's gains and losses on investments bought and sold, as well as the unrealized gains and losses on those investments that were held at the end of the year.

The valuation methods used by the Plan may have produced a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Further-more, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

Notes Receivable from Participants

Notes receivable from participants are recorded at their unpaid principal balance, plus accrued but unpaid interest.

Contributions

Contributions to the Plan are recorded in the period in which they become obligations of the Plan Sponsor.

Corrective Distributions

Corrective distributions may be required in the event that employee contributions exceed contribution limitations of the Internal Revenue Code ("IRC"). These amounts are recorded as a liability as of the Plan's year end and reflected on the statement of changes in net assets available for benefits as an offset to participants' contributions.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administration Expenses

During the year ended December 31, 2024, administrative and other costs associated with the Plan amounting to \$15,000 were paid directly by the Company. Plan administrative expenses of approximately \$14,000 were charged directly to the Plan. Certain other investment-related fees, commissions, and reporting expenses are included in net appreciation in fair value of investments.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, revenues, and expenses, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent Events

The Plan Sponsor has evaluated subsequent events for recognition and disclosure through October 15, 2025, which is the date the financial statements were available to be issued.

Note 3. Certification of Custodians

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Previous Plan Custodian and Current Plan Custodian has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value Measurements

The fair value of financial instruments is presented based upon a hierarchy of levels that prioritize the inputs of valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The three levels of the fair value hierarchy are described as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to the valuation methodology that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Note 5. Fully Benefit-Responsive Investment Contracts

Investments in the insurance company general account were held in the Mutual of America Interest Accumulation Account issued by the Previous Plan Custodian. This contract met the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value was the relevant measure for fully benefit-responsive investment contracts because this was the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represented contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The Mutual of America Interest Accumulation Account contracts held by the Plan as of December 31, 2023 were guaranteed investment contracts. The contract issuer was contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting interest rate was reset periodically by the issuer, subject to a minimum interest rate of 1%. The crediting interest rate during the year ended December 31, 2023 was approximately 1.60%.

Note 6. Exempt Party-in-Interest Transactions

Certain plan investments are funds managed by the Previous Plan Custodian and Current Plan Custodian as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid to the Previous Plan Custodian and Current Plan Custodian were approximately \$14,000 for the year ended December 31, 2024. The Company also absorbs significant costs related to various administrative and investment advisory services on behalf of the Plan.

Note 7. Risks and Uncertainties

The Plan's investments are not insured and are subject to credit and market risks. Financial information relating to those investments is included in these financial statements based on information provided by the Previous Plan Custodian and Current Plan Custodian.

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Income Tax Status

The original Plan is a prototype plan prepared and maintained by a third party. The prototype plan obtained its latest determination letter on November 5, 2018, in which the IRS stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and tax exempt.

Note 9. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and the Plan assets shall be distributed in proportion to participants' respective account balances as of the date of termination.
