## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Don Chapin 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Notes 3 and 4 to the financial statements, is complete and accurate.

**1. DESCRIPTION OF PLAN**

The following description of The Don Chapin Company, Inc. (Company), 401(k); Profit Sharing; Prevailing Wage Plan and Trust (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a single employer defined contribution, profit sharing, prevailing wage and salary reduction plan covering full-time employees of the Company, and Landset Engineers, Inc. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each participant who is not a member of a union, has completed six months of service, and is at least 21 years old, may elect to defer a portion of their compensation up to the Internal Revenue Code (IRC) Section 402(g) dollar limitation in effect for the year. Participants may also contribute amounts representing distributions from other qualified defined contribution plans to the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participants can make contributions up to the deferral limit of \$23,000 (or \$30,500 if age is 50 or older) for 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company makes safe harbor matching contributions equal to 100% of participant's salary deferrals that are not in excess of 4% of participant's compensation.

The Company makes contributions to participant accounts to satisfy prevailing wage laws.

Additional profit sharing amounts may be contributed at the option of the Company's board of directors. Participants in the Company's profit sharing contributions must have completed a year of service and at least 1,000 hours during the Plan year, be at least 21 years old and still be actively employed on the last day of the Plan year and must have joined the Plan on the next plan entry date after meeting these requirements.

Contributions are subject to certain limitations.

**Participant Accounts**

Each participant's account is credited with their contributions and the Company's matching contribution, the Company's profit sharing contribution, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid for by their individual account. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$58,616 and \$48,963, respectively. Forfeitures are first used to pay administrative expenses and any remaining forfeitures are used to reduce nonelective contributions or to reduce matching contributions. In 2024, there were no Plan fees that reduced forfeited nonvested accounts.

**Vesting**

Participants are immediately 100% vested in their elective salary deferral contributions, the Company's prevailing wage contributions, the Company's contribution matching and actual account earnings thereon. Vesting in the Company's discretionary profit-sharing contributions are based on years of continuous service. Vesting is determined under the following schedule:

**Payment of Benefits**

On termination of service due to death, disability or retirement, or other reasons, the participant will receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount. Payments are recorded when paid.

When an active participant reaches age 59 1/2 and continues to work for the Company, the participant is eligible to receive a partial or full distribution of their account. The Plan also allows distributions to active participants for financial hardships, if certain criteria are met.

**Notes Receivable from Participants**

Participants' may borrow from their account a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. These loans are secured by the vested balance in the participant's account. The Plan Administrator will determine a reasonable fixed rate of interest by reviewing the interest rates charged for similar types of loans by other lenders.

The maximum number of Plan loans that you may have outstanding at any one time is two (2).

Generally, the term of the loan may not exceed five years, unless the loan is used to purchase a principal residence. If this is the case, the Plan Administrator may permit a longer repayment term.

Principal and interest are paid ratably through weekly payroll deductions. Upon termination of employment, principal and interest are payable in full.

The financial statements of the Plan are prepared on the accrual basis of accounting.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation include the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. There were no excess contributions for the year ended December 31, 2024.

**Payments of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation and depreciation of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

**3. INVESTMENTS**

The December 31, 2024 and 2023, financial statements and supplemental schedules were taken directly from statements provided and certified as complete and accurate by Voya Institutional Trust Company, the trustee of the Plan:

**4. FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB (ASC) 820 are described as follows:

*Level 1 Fair Value Measurements* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2 Fair Value Measurements* – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3 Fair Value Measurements* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the valuation methodologies used during the years ended December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

*Registered investment companies (Mutual funds)* – Valued at the net asset value of shares held by the Plan at year end.

*Fixed annuities* – Valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

**5. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time. Upon termination, all amounts credited to participant accounts will be 100% vested. Benefits provided by the Plan are not insured by the Pension Benefit Guaranty Corporation (PBGC) under Title IV of the Employee Retirement Income Security Act of 1974 because the insurance provisions under ERISA are not applicable to this type of plan.

**6. TAX STATUS**

The Plan operates under provisions of a Voya Retirement Insurance and Annuity Company volume submitter plan document which received an opinion letter from the IRS dated June 30, 2020, which stated that the volume submitter plan, as then designed, was acceptable under applicable sections of the IRC for use by employers for the benefit of their employees. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

**7. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**8. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS**

At December 31, 2024 and 2023, the Plan held 0.16% of its assets at a money market account and in an annuity managed by the custodian of the Plan.

In 2024, there were two (2) instances of a late deposit out of sixty-three (63) payroll dates with employee 401(k) deferrals. The late deposit resulted from changes in payroll staff. The Company will make all corrections, calculate, and fund lost earning amounts by December 31, 2025. See the supplemental information, Schedule H, Line 4a – Schedule of Delinquent Participant Contributions.

During 2024, the Company inadvertently missed updating the payroll system for prevailing wage rates in effect, in part due to the timing of prior year corrections. These incorrect rates caused an underpayment to certain employees' retirement accounts, as the Company has elected to pay these as a fringe benefit. The Company will correct this error by funding the approximately \$3,000 underpayment to the Plan by December 31, 2025. This \$3,000 receivable is included in employer contributions in the Statement of Net Assets Available for Benefits, as well as in employer contributions in the Statement of Changes in Net Assets Available for Benefits.
