Basis for Opinion

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to the participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audits* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule included in the accompanying table of contents is presented for purposes of additional analysis and is not a required part of the financial statements, but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of the Plan

Rockwood Capital, LLC (the Company and Employer) established the Rockwood Capital 401(k) Retirement Plan (the Plan), effective January 1, 1993, to provide participants with a means to fund their retirement on a tax-deferred basis. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan under the related provisions of the Internal Revenue Code (the Code) and relevant state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan sponsor and Plan administrator. The Plan Committee, comprised of Company employees, is responsible for administration of the Plan. Empower Trust Company, LLC (Empower) serves as the Plan's trustee. Empower holds, invests, and reinvests Plan assets in the interest and direction of the participants and their beneficiaries. The Company has engaged California Retirement Plans, Inc. as recordkeeper. The Company has engaged Johnson & Dugan as an investment advisor to assist the Plan Committee in selecting investment options offered under the Plan and monitoring investment performance.

Eligible Participants:

Employees, as defined by the Plan agreement, may participate in the Plan immediately upon hire.

Contributions:

Participants may contribute up to 100% of their pre-tax or post-tax annual eligible compensation, as defined by the Plan agreement. Participants who have reached the age of 50 can elect to withhold additional catch-up contributions under the Code. Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

The Company may make discretionary matching and nonelective contributions at the discretion of the Company's Board of Directors. Participants become eligible for discretionary matching and nonelective contributions after completing one year of service. The Company made nonelective contributions of \$1,178,373 to the Plan in 2024.

Contributions are subject to certain limitations under the Code.

Notes to Financial Statements

1. Description of the Plan (continued)

In-Plan Roth Conversions:

The Plan allows participants who are active employees of the Company to convert any portion of their pre-tax contributions to Roth contributions. There were no pre-tax deferral contributions converted to Roth contributions in 2024.

Participant Accounts:

Participant accounts are credited with participant contributions and rollovers, an allocation of Company contributions, plus earnings (less any losses) thereon. Allocations are based on participant earnings or account balances, in accordance with the Plan agreement. The benefit to which participants are entitled is the benefit that can be provided from the participant vested accounts.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. Participants may authorize transfers among investment options at any time.

Participants can also choose to invest in and manage a broader range of investments through participant-managed Schwab self-directed brokerage accounts. Investment choices offered to participants in these self-directed brokerage accounts include most equity securities listed on major stock exchanges in the United States of America (U.S.), additional mutual funds, over-the counter equity securities, bonds, and other fixed-income securities.

Vesting:

Participants are immediately vested in their contributions, plus actual earnings (less any losses) thereon. Participants vest in Company contributions 25% after the first year of service and continue to vest 25% annually, becoming fully vested after four years of service. Participants also become fully vested in Company contributions upon death or disability.

Forfeitures:

The non-vested portion of terminated participant account balances would be forfeited upon distribution of the vested account balance. Forfeitures are retained in the Plan and used to pay Plan administrative expenses or reduce future Company contributions. At December 31, 2024, there was \$48,405 in the forfeiture account (\$820 at December 31, 2023). In 2024, no forfeitures were used to reduce Company nonelective contributions and \$730 were used to pay Plan expenses.

Notes to Financial Statements

1. Description of the Plan (continued)

Notes Receivable from Participants:

Participants may borrow up to one-half of their vested account balance, with a minimum of \$1,000 and an amount not to exceed \$50,000 for a period of five years, except for notes used to purchase a primary residence for which terms of up to fifteen years are permitted. Participants may have one note outstanding at any time. Participant notes are evidenced by a written note, secured by the vested balance in the participant account, and bear interest at one percent over the prime rate on the first business day of the month the note was originated. The interest rate on the note outstanding at December 31, 2024 is 9.50%. Repayment of principal and interest is made through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan agreement.

Notes receivable transactions with participants qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Payment of Benefits:

Upon termination of employment, participants may elect to receive an amount equal to the value of their vested account balances. Distributions will be paid as soon as administratively feasible and may be paid in a lump sum cash payment or rolled into another qualified retirement plan or individual retirement account, as elected by the participants, subject to certain stipulations as defined by the Plan agreement. Terminated participant accounts below \$7,000 may be either automatically distributed directly to participants or rolled into individual retirement accounts on behalf of the participants without participant approval. The Plan agreement also allows for certain in-service and hardship withdrawals of benefits. Benefits are recorded when paid.

Administrative Expenses:

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. These fees are charged directly against the fund's investment performance and, thus, are not separately disclosed in the financial statements. Certain account maintenance fees are charged to the Plan and allocated to participant accounts. All other administrative expenses related to the Plan are paid by the Company and are not reflected in the Plan's financial statements.

1. Description of the Plan (continued)

Risks and Uncertainties:

Participants may invest their account balances in a variety of investment options offered by the Plan. Investments are exposed to various market conditions, such as interest rate, market fluctuation, and credit risks. Due to the level of risk associated with certain investment options offered by the Plan, it is at least reasonably possible changes in risks in the near term could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan at any time, subject to the provisions of ERISA. In the event of a Plan termination, participants would become fully vested in their accounts and distributions would be made to participants as described in the Plan agreement.

2. Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the U.S. (GAAP).

Use of Estimates:

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

2. Summary of Significant Accounting Policies (continued)

Investments:

The Plan's investments include mutual funds, participant-directed brokerage accounts, and a common collective trust. These investments are accounted for as follows:

- **Mutual Funds:** These funds are valued at the net asset value of shares held by the Plan at year end, as quoted in active markets.
- **Participant-Directed Brokerage Accounts:** These participant-managed Schwab self-directed brokerage accounts, may consist of shares in various interest bearing cash and other cash equivalents, publicly traded securities, mutual funds, money market funds, over-the-counter equity securities, bonds, and other fixed-income securities valued based on quoted prices in active markets.
- **Common Collective Trust:** This is a fully benefit-responsive investment contract through The Standard Stable Asset Fund II (the Fund) offered by Standard Retirement Services (Standard). The Fund is valued at fair value using the NAV practical expedient for the Fund as reported by Standard. The NAV practical expedient is based on the fair value of the underlying assets owned by the Fund, minus its liabilities, and then divided by the number of units outstanding. The NAV practical expedient of the Fund is calculated based on a compilation of primarily observable market information. The NAV practical expedient would not be used if it is determined to be probable the Plan will sell the investment for an amount different from the reported NAV. If a full redemption of the trust is initiated, Standard reserves the right to temporarily delay withdrawal from the trust in order to ensure the securities liquidated will be carried out in an orderly business manner. The Plan has no unfunded commitments with the common collective trust.

Fair Value Measurement:

The Plan uses a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability at the measurement date. The three-level hierarchy prioritizes, within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with those instruments.

Fair Value Measurement: (continued)

The three-level hierarchy for fair value measurement is defined as follows:

- Level I: Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.
- Level II: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.
- Level III: Inputs to the valuation methodology, which are significant to the fair value measurement, are unobservable.

A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The Plan's mutual funds and participant-directed brokerage accounts are recorded at fair value and classified within Level I of the fair value hierarchy as of December 31, 2024 and 2023. The Fund is reported at NAV practical expedient and is excluded from the fair value hierarchy under GAAP.

Income Recognition:

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual method of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes gains and losses on the Plan's investments bought, sold, or held during the year.

3. Information Prepared and Certified by the Qualified Institution

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower, the qualified institution of the Plan, has certified to the completeness and accuracy of the:

- investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- net income on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

4. Income Tax Status

The Plan administrator has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable provisions of the Code. The Plan document has been amended and restated since receipt of the letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and related state statutes and is, therefore, qualified, and the trust that forms a part of the Plan is exempt from federal and state income taxes.

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

5. Subsequent Events

Subsequent events have been evaluated through October 15, 2025, which is the date the financial statements were approved by the Plan administrator and available to be issued.
