INDEPENDENT AUDITORS' REPORT

To the Participants and Management of the
American Family Care, Inc. Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of American Family Care, Inc. Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of American Family Care, Inc. Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

The following description of the American Family Care, Inc. Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more detailed description of the Plan's provisions.

General

The Plan is a defined contribution plan which covers substantially all employees of American Family Care, Inc. and its affiliated companies (the Company). Employees are eligible for Plan participation after six months of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Assets of the Plan are held by Ascensus Trust Company, the Plan custodian and trustee. The Plan is administered by the Company.

The Consolidated Appropriations Act of 2023 was signed into law on December 29, 2022, which includes the Setting Every Community Up for Retirement Enhancement Act ("SECURE Act") 2.0. SECURE Act 2.0 contains over 90 new provisions related to retirement, with varying effective dates through 2027. As these provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. There was no material impact on the Plan for the years ended December 31, 2024 and 2023.

Participant Accounts

The Plan provides for the maintenance of pre-tax and post-tax savings accounts for each participant. Participant contributions are credited to each participant's pre-tax and post-tax savings account upon remittance by the Plan Administrator each pay period. Earnings on the Plan's investment assets are credited to each account based upon the adjusted balances of each participant in the Plan. Distributions, withdrawals, and allocated expenses are subtracted from the account balances when paid.

Contributions

Participants may make deferred compensation contributions to the Plan by electing to reduce their gross pay in an amount or percentage up to the maximum contribution allowed by the Internal Revenue Code (the Code). Contributions may be made through regular payroll deductions. The Company makes matching contributions equal to 25% of the regular pre-tax and post-tax contributions made by the employee, not to exceed 2% of each participant's compensation. Matching Company contributions vest at the rate of 25% per year, after the second year of service.

Investments

Participants direct the investment of their contributions as well as employer matching and any discretionary contributions into various investment options offered by the Plan. As of December 31, 2024, the Plan offers forty-three mutual funds and one money market fund.

Payment of Benefits

Upon termination of service, participants receive a lump-sum payment in an amount equal to the aggregate vested value of their account, if the vested account is \$1,000 or less. The distribution may be taken in cash or may be deposited in another employer's retirement plan or in an Individual Retirement Account (IRA). If the participant's account balance is more than \$1,000, they may choose to receive a lump sum distribution immediately or defer receipt until a later date. In the case where a participant dies while still employed by the Company, the designated beneficiary will receive the total vested account balance in a lump sum payment. If the vested account balance is more than \$1,000 the beneficiary may choose to defer receipt of the vested balance until a later date. Participants may elect to withdraw all or part of their vested account balance resulting from savings contributions through hardship distribution (as defined by IRS regulations), attainment of the age of 62 or later, or through a qualified loan.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 and a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Such loans are repaid through payroll deductions over a period not exceeding 5 years unless the loan is for a primary residence. The interest rates on the loans outstanding at December 31, 2024 ranged from 5.25% to 10.5%.

Forfeited Accounts

The portion of a participant's account to which he or she is not entitled to upon termination is deemed a forfeiture. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$59,761 and \$148,633 respectively, and were available to offset employer contributions. Forfeitures in the amount of \$178,510 were used during the year.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

Investments are presented at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements. Purchases and sales of securities are reflected as of the trade date. Dividend income is recorded on the ex-dividend date. Interest income is recorded when earned. Loans to participants are valued at amortized balance plus accrued interest.

Realized and Unrealized Gains and Losses

The Plan presents in the statement of changes in net assets available for benefits the net appreciation or depreciation in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments. Realized gains or losses on investments represent the difference between the original cost and the related market price of the investments at the time of disposition. Prior to disposition, differences between the original cost and the estimated fair value of the investments at the end of a period represent unrealized appreciation or depreciation.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the values of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

3. ADMINISTRATIVE EXPENSES

The Company furnishes operating space, equipment, supplies and other services. Loan administration and maintenance fees, if any, are charged directly to the participants receiving the loans. Additionally, participants pay a portion of plan administration fees.

4. INCOME TAX STATUS

The Plan uses a plan document that is pre-approved by the Internal Revenue Service. The Plan Administrator believes the Plan is being operated in compliance with the document and applicable requirements of the Code. Therefore, the related trust is not subject to tax under present income tax laws.

The Plan has adopted accounting standards relating to uncertainty of income tax positions. As a result of this adoption, the Plan administrator assessed whether there were any uncertain tax positions that may give rise to income tax liabilities and determined that there were no such matters requiring recognition in the accompanying financial statements. The Plan files information returns under U.S. federal jurisdiction. With few exceptions, the Plan is no longer subject to U.S federal tax examinations for years before 2022.

5. INFORMATION CERTIFIED BY THE CUSTODIAN (UNAUDITED)

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company, the custodian of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investments, at fair value
- Net appreciation/depreciation in fair value of investments
- All components of income
- Schedule of Assets (Held at End of Year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

6. FAIR VALUE MEASUREMENTS

In accordance with ASC topic 820, *Fair Value Measurements and Disclosures*, a framework for measuring fair value was established. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The hierarchy consists of three broad levels, described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Money market fund – The carrying amounts for cash reflect the assets’ fair value which are determined based on quoted market prices.

Mutual funds - Valued at the closing price reported on the active market on which the individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan uses Creative Planning as the investment advisor and therefore, some investment advisory fees related to these transactions qualify as party-in-interest.

9. PROHIBITED TRANSACTIONS

As of December 31, 2024, employee deferrals and loan repayments totaling \$505,603 were withheld from certain payrolls in 2024, 2023, and 2022 and not remitted on a timely basis (as defined by the Department of Labor "DOL") by the Plan Sponsor. These transactions were prohibited according to the provisions of the DOL. The Plan Sponsor is in the process of remitting all such deferrals, loan repayments and lost earnings to the trustee. The Plan Sponsor has since implemented procedures to ensure timely remittance of employee deferrals and loan repayments to the trustee.

10. SUBSEQUENT EVENTS

The Plan administrator has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued and concluded that no events occurred during that period requiring recognition or disclosure.
