## REPORT OF INDEPENDENT AUDITORS

To the Retirement Committee  
Growth Orthopaedics 401(k) and Profit Sharing Plan  
Lexington, Kentucky

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Growth Orthopaedics 401(k) and Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

## Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### 1. DESCRIPTION OF THE PLAN

The following brief description of the Growth Orthopaedics 401(k) and Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

During the year ended December 31, 2023, the Plan changed its name from Bluegrass Orthopaedics 401(k) and Profit Sharing Plan to Growth Orthopaedics 401(k) and Profit Sharing Plan.

The Plan is a safe harbor defined contribution plan covering substantially all employees of Growth Orthopaedics Services MSO, LLC (the Company) and is subject to the Employee Retirement Income Security Act of 1974 (ERISA). The Plan covers all employees who are at least 21 years of age and meet certain service requirements. Employees are eligible to defer and participate in the Company's nonelective safe harbor contribution in the month following employment and satisfaction of the age requirement. Employees are eligible for Company profit sharing contributions after at least one year of consecutive service. Following the satisfaction of the eligibility requirements, a participant is enrolled semi-annually on the first day of the first month or the seventh month of the year.

#### Contributions

The Plan permits eligible employees through a salary reduction deferral election to make annual Roth and pre-tax contributions up to the current Internal Revenue Service deferral limits. Employee rollover contributions are also permitted. The Company makes a safe harbor nonelective contribution to all eligible participants equal to 3 percent of compensation. The Company may also make additional discretionary matching contributions up to 4 percent of participant's compensation and discretionary profit sharing contributions. The Company made safe harbor contributions of approximately \$592,000 in 2024. The Company made no profit sharing contributions in 2024.

#### Rollovers

A participant may contribute any rollover contribution to which the participant is entitled from another qualified trust. Such rollover contributions are deposited in the participant's account.

### Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contribution and plan earnings and charged with an allocation of investment and administrative expenses paid by the Plan. Allocations are based on participant account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants can direct funds in their account into several investment options and are allowed to change investment selections on a daily basis.

### Vesting

Participants are immediately vested in their contributions and all Company safe harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their account is based on years of continuous service, as follows:

### Forfeited Accounts

At December 31, 2024 and 2023, the forfeited non-vested accounts totaled \$70,544 and \$35,730, respectively. These accounts are to be used to reduce future Company contributions or pay the Plan's administrative expenses. During the year ended December 31, 2024, no forfeitures were used for safe harbor contributions or administrative expenses.

### Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of their vested account balance, whichever is less. The loan term may not exceed five years unless such loan is for the purpose of the participant's primary residence. The notes are secured by the balance in the participant's account, bear interest at fixed rates, and principal and interest are paid through payroll deductions. Loan origination fees and loan administrative fees are deducted from the participant's account and not paid by the Plan. The participant is limited to one active loan at any given time.

### Benefit Payments

Upon termination of service due to death, disability, or retirement, participants are entitled to receive a lump-sum payment equal to the value of the participant's account or periodic installment payments. The Plan also permits hardship withdrawals and in-service withdrawals subject to certain restrictions as defined in the plan document.

### Administrative and Investment Management Expenses

The Plan's recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan. All other expenses of the Plan are paid by the Company.

### Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their Company's contributions.

## **2. SUMMARY OF ACCOUNTING POLICIES**

### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the modified cash basis of accounting. As such, contributions are recorded when received rather than when earned, and administrative expenses when paid rather than when incurred. The modified cash basis differs from the cash basis in that investments are recorded at fair value and notes receivable from participants are recognized.

Although the modified cash basis of accounting represents a departure from accounting principles generally accepted in the United States of America, it is an allowable method of accounting for employee benefit plans under the reporting requirements of ERISA.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

### Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Purchases and sales of securities are recorded on a settlement date basis. Interest and dividends are recorded when received. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

### Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

### Payment of Benefits

Benefit payments are recorded when paid.

### Tax Status

The Plan is based on a volume submitter profit sharing plan which has received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020 that the Plan is designed in accordance with applicable sections of the IRS. Therefore, no provision for income taxes has been included in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, as of the date the financial statements were available to be issued, there were currently no audits for any tax periods in progress.

### Subsequent Events

The plan administrator has evaluated events and transactions occurring subsequent to the statement of net assets available for benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements are available to be issued, which is October 15, 2025.

### **3. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEES**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC and Empower Annuity Insurance Company of America (Empower), the trustees, have certified to the completeness and accuracy of all investments reflected in the accompanying statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, the schedule of assets (held at end of year) as of December 31, 2024, and the related investment activity reflected in the statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024.

### **4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

- Level 2: Inputs to the valuation methodology include quoted prices for similar assets in active markets; quoted prices for identical or similar assets in inactive markets; inputs other than quoted prices that are observable for the asset; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methods and assumptions used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds are held by the Plan and are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

### 5. FULLY BENEFIT-RESPONSIVE CONTRACT

The Plan holds a group annuity contract that meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because it is the amount received by the participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses.

The Guaranteed Interest Fund is a group variable annuity contract issued by Empower and is backed by the entire general account assets of Empower. All deposits in this investment are credited with the same interest rate, credited on a daily basis, and there is no set maturity. The effective credited interest rate is based on a formula established by the contract issuer but may not be less than zero percent and may adjust quarterly. Contract charges may reduce this return.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contract is dependent on Empower's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Although plan participants generally may withdraw assets from the Guaranteed Interest Fund without restrictions, a hold may apply on the Plan's assets in the group annuity contract. If the Plan wishes to remove the Guaranteed Interest Fund as an option from the Plan, then Empower may impose a hold for up to a 30-day period on the investment assets at the plan level. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: spin-offs, sales, mergers, and full or partial plan termination. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

### **6. PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering services to the Plan, the Company and certain others. Officers or employees of the Company perform certain administrative functions for the Plan. No such officer or employee receives compensation from the Plan. The Company serves as the Plan's sponsor. Some administrative expenses of the Plan are paid directly by the Company. Blue & Co., LLC is the Plan's independent auditors. Empower is the Plan's trustees and, therefore, the Plan's payment of trustee fees to them qualify as party-in-interest transactions. Empower also receives payment for recordkeeping services. The third-party administrator of the Plan, McGregor & Associates, Inc., and the financial advisor to the Plan, MCF Advisors, receive payment from the Company or the Plan depending on the service. Notes receivable from participants are also considered party-in-interest transactions.
