We have performed audits of the financial statements of Enza Zaden North America, Inc. Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the Enza Zaden North America, Inc. Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan that was established on May 1, 1996 by Enza Zaden North America, Inc. (the “Company” or “Employer”) to provide benefits to eligible employees, as defined in the Plan document. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (“IRC”), as amended, and the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Administration

The Company has appointed the Retirement Plan Committee to manage the operation and administration of the Plan. The Company has contracted with CBIZ Retirement Services to act as the third-party administrator to prepare the Form 5500 and compliance tests and also to act as the investment advisor and consultant. The Company has contracted with Voya Retirement Insurance and Annuity Company (“Voya”) to act as custodian of the Plan’s assets and record-keeper of the Plan.

Eligibility

Employees of the Company are eligible to participate in the Plan after completing three months of service. Collective bargaining employees, non-resident aliens and employees who are eligible to participate in the Enza Zaden Beher Holland Retirement Savings Plan are excluded from Plan participation.

Participant Accounts

Individual accounts are maintained for each of the Plan’s participants to reflect the participant’s contributions, Employer contributions, if any, rollovers from qualified plans, and allocations of the Plan’s earnings and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participant Contributions

Participants may elect to have the Company contribute their eligible pre-tax compensation and Roth deferral contributions to the Plan up to the amount allowable under the Plan document and current income tax regulations. Participants who have the Company contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable compensation. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions.

Participant Contributions (Continued)

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant's direction and the Plan's provisions.

The Plan provides for automatic enrollment initially at 6% of a participant's compensation, subject to an annual increase of 1% on January 1 up to a maximum of 10% of participant's compensation, which applies to all eligible employees who were hired after January 1, 2013 and who have not elected a different contribution amount. The automatic elections specified above are designated as pre-tax elective deferral contributions.

Employer Contributions

The Company makes safe harbor matching contributions equal to 100% of each participant's elective deferrals up to 6% of the participant's compensation to eligible employees. The safe harbor matching contribution is deposited every pay period. However, at the end of the Plan year, the Company will adjust the safe harbor matching contributions based on each participant's contributions and compensation for the entire Plan year. For the year ended December 31, 2024, the Company recorded a true-up contribution for the safe harbor matching of \$15,262, which is included in the Employer contribution receivable at December 31, 2024. The Plan also allows flexible discretionary matching and nonelective contributions to eligible employees as defined by the Plan document. For the year ended December 31, 2024, there were no discretionary nonelective contributions made.

Investment Options

Participants must direct their salary deferral contributions and Employer contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options any time throughout the year via the Internet website or by using the automated telephone system offered by the custodian.

Vesting

Participants are always 100% vested in all of their contributions and safe harbor matching contributions plus actual earnings thereon. Participants vest in discretionary Employer matching and nonelective contributions as follows:

Participants may borrow from their participant account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of the participant's vested account balance. A participant may only have one loan outstanding at a time. The maximum loan term is five years unless the loan qualifies as a home loan, in which case the loan term will be fifteen years. The loans are secured by the balance in the participant's account. Loan granted or renewed bear an interest rate equal to 1% above the U.S. Prime rate. The interest rate is fixed for the duration of the loan. Principal and interest is paid ratably over the term of the loan through payroll deductions. At termination of employment, any outstanding balance is due. At December 31, 2024, notes receivable from participants bear interest rates ranging from 5.0% to 9.50% and mature through 2029. At December 31, 2023, notes receivable from participants bore interest rates ranging from 5.0% to 9.50% and mature through 2028.

Payment of Benefits

Upon termination, death, disability, or upon the attainment of age 59 ½, a participant or participant's beneficiaries may elect to leave his/her account balance in the Plan, or receive the total benefits in a lump sum or installment payments in the amount equal to the value of each participant's interest in his/her account. The Plan allows for the automatic lump sum distribution of participant account balances under \$1,000. Additionally, the Plan allows for an automatic rollover provision for any balances between \$1,000 and \$5,000 into an Individual Retirement Account.

Financial Hardship Distributions

The Plan allows hardship withdrawals in accordance with Internal Revenue Service ("IRS") regulations. Among other things, the withdrawal must be necessary in light of immediate and heavy financial needs of the participant and is limited to certain purposes.

Forfeited Accounts

Forfeited non-vested accounts may be used to pay Plan expenses or reduce Employer contributions. At December 31, 2024 and 2023, the balances of forfeited nonvested accounts were \$3,161 and \$3,112, respectively. During the year ended December 31, 2024, no forfeitures were used to pay Plan expenses or reduce Employer contributions.

**NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for plan benefits and changes therein, and, when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value – See Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investment bought and sold, as well as, held during the year.

Management fees charged to the Plan for investments are based on assets invested and are deducted on a daily basis. Management fees are reflected as a reduction of investment returns for such investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. There were no delinquent notes receivable from participants as of December 31, 2024 and 2023. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES (Continued)**

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are directly paid by the Plan, unless otherwise paid by the Company or paid using forfeited non-vested accounts. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and other fees are charged directly to the participant's account and are included in administrative expenses.

Uncertain Tax Positions

U.S. GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS or the DOL. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or asset, or disclosure, in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 3 – CERTIFIED INFORMATION**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the United States Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya, the custodian of the Plan, has certified the completeness and accuracy of:

- Investments reflected in the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023;
- Net appreciation in fair value of investments and dividend and interest income, reflected in the accompanying statement of changes in net assets available for plan benefits for the year ended December 31, 2024;
- Investments reflected on the supplemental schedule: Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

**NOTE 4 – FAIR VALUE MEASUREMENT**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under the standard are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**NOTE 4 – FAIR VALUE MEASUREMENT (Continued)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered Investment Companies Held in Separate Accounts*

Valued at the NAV of units of the accounts. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The separate accounts have daily redemption frequency, no redemption period or restrictions, and no unfunded commitments.

**NOTE 5 – GUARANTEED INVESTMENT CONTRACT - VOYA FIXED ACCOUNT**

The Voya Fixed Account, a guaranteed investment contract, is determined to be fully benefit responsive and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transitions under the Plan.

Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contracts are included in the financial statements at contract value, as reported to the Plan by Voya. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract is a traditional investment contract. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the Issuer, but it may not be less than 1% depending on the contract. Such interest rates are reviewed on a monthly basis for resetting. The crediting interest rate was 1.6% and 1.6% as of December 31, 2024 and 2023, respectively.

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of contract.

The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreements without the consent of the issuer.

**NOTE 6 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments and note receivable from participants are managed by an affiliate of Voya Retirement Insurance and Annuity Company, the custodian, as defined by the Plan. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan, and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

**NOTE 7 – PLAN TERMINATION OR MODIFICATION**

Although it has not expressed any intent to do so, the Company, by action of its Board of Directors, has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, further contributions to the Plan shall cease and all participants who are affected by such termination shall become 100% vested. Net assets available for plan benefits would be distributed to the participants based on each participant's interest in the Plan.

**NOTE 8 – TAX STATUS**

The Plan has adopted a non-standardized form of a pre-approved plan. The pre-approved plan has received an opinion letter from the IRS as to the pre-approved plan's qualified status. The volume submitter plan opinion letter has been relied upon by this Plan. The Plan administrator believes the Plan is designed, and is being operated, in compliance with the applicable provisions of the IRC.

**NOTE 9 – RISKS AND UNCERTAINTIES**

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the risk associated with certain investments securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits, and the statement of changes in net assets available for plan benefits.
