## **Notes to Financial Statements**

### **Note 1. Plan Description**

The following description of the Robbins Geller Rudman & Dowd LLP 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

#### **General**

The Plan is a defined contribution plan established on May 1, 2004, by Robbins Geller Rudman & Dowd LLP (the "Partnership"), which allows participants to defer part of their compensation, and requires certain matching contributions to be made to the Plan by the Partnership. These benefits are available to all employees who meet specific eligibility requirements as to age and years of service.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

#### **Contributions**

Participants may contribute pretax compensation, as defined by the Plan, subject to maximums established by law. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Partnership makes annual matching contributions to the Plan equal to 25% of employee deferrals which does not exceed 4% of compensation, up to a maximum match of 1% of employee compensation, plus an additional discretionary amount determined annually. An employee becomes eligible for matching contributions and discretionary contributions on January 1 or July 1, whichever occurs first, immediately following one year of service.

The Partnership may also make a discretionary non-elective contribution which is determined by assigning eligible participants to a group, and the contribution is allocated to the participants based on a ratio that the compensation of the participant bears to the total compensation of the members of that group. A participant is eligible for this discretionary contribution if they are employed on the last day of the plan year in which the participant has completed 1,000 hours of service.

#### **Participants' Accounts**

Each participant's account is credited with the participant's contribution and allocations of: (a) the Partnership's contribution, and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances. The benefit to which a participant is entitled is provided from the participant's vested account. Participants may elect to have a self-directed brokerage account. Participants so electing are charged an annual administrative fee to offset the incremental cost of self-directed brokerage accounts.

### Vesting

Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Partnership's contribution portion of their account is based on years of continuous service according to the following schedule:

### Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 5.25% to 10.5% for both years ended December 31, 2024 and 2023, respectively, which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

Effective as of January 1, 2018, no loan amount for a new plan loan may exceed the lesser of (a) or (b) following, from all plans of the employer and any affiliated employer:

- (a) 25% of the sum of (1) a participant's vested account balance, plus (2) a participant's voluntary contributions, rollover contributions, or other transferred or segregated monies for which an account balance is maintained; both as reflected by the books and records of the Plan at the end of the most recent computation period for which an accounting has been completed.
- (b) \$50,000 reduced by the excess, if any, of the participant's highest outstanding balance of loans during the 1-year period ending the day before the loan was made, over the participant's outstanding balance of loans on the day the loan was made.

Also, effective as of January 1, 2018, a participant can have only one outstanding loan at any given time. Notwithstanding the preceding, for any loans entered into prior to January 1, 2018, the participant may continue to repay such loans in accordance with the terms of the original loan agreement, but may not apply for a new loan until all such loans are fully repaid.

### Payment of Benefits

An active participant may receive withdrawal benefits subject to various limitations.

Due to the changes made by the Setting Every Community Up for Retirement Act (the "SECURE" Act), the plan document was amended. Effective January 1, 2020, minimum benefit payment must be paid to a participant because the person has reached age 72 (age 70½ if the person reached age 70½ on or before December 31, 2019).

Due to the Coronavirus Aid, Relief, and Economic Security Act (the "CARES Act"), until December 31, 2020, eligible participants were able to request penalty-free distributions from their account of up to \$100,000 for qualifying Coronavirus-related reasons ("CARES Act Distribution").

A terminated participant with a vested balance of \$5,000 or less is paid a single sum.

A terminated participant with a vested balance exceeding \$5,000 has the option of a single sum, a monthly income with various time limitations, including a joint and survivor annuity and flexible income payments.

Unless the participant elects otherwise, benefits under the Plan shall commence no later than the sixtieth day after the latest of the close of the plan year in which:

- (a) The participant attained the earlier of age sixty-five (65) or normal retirement age; or
- (b) The participant terminates employment with the employer.

### **Forfeited Accounts**

Forfeitures are used to reduce future employer contributions or plan expenses. In 2024 and 2023, the participants' allocated shares of administrative expenses were reduced by \$49,447 and \$20,741 respectively, from forfeited nonvested accounts. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,012 and \$7,722, respectively.

## **Note 2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains (losses) on investments bought and sold, as well as held during the year.

### **Contributions**

Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

### Payment of Benefits

Benefits are recorded when paid.

### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

### Subsequent Events

The Plan has evaluated subsequent events and transactions through October 15, 2025, the date that the financial statements were available to be issued.

### Note 3. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds. Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trusts. Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Self-directed brokerage accounts. Accounts primarily consist of exchange-traded funds, mutual funds and common stocks that are valued on the basis of readily determinable market prices. Certain accounts consist of corporate bonds that are valued using pricing models maximizing the use of observable inputs for similar securities; this includes basing value on yields currently available on comparable securities of issuers with similar credit ratings.

The preceding valuation methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 4. Related Party Transactions and Party-in-Interest Transactions

Certain plan investments are shares of mutual funds managed by Fidelity Investments. Fidelity Investments is the custodian, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions.

### Note 5. Plan Termination

Although it has not expressed any intent to do so, the Partnership has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

### Note 6. Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 11, 2012, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, Plan management believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that some changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
