**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

**1) Plan Description**

The following brief description of the Plan de Retiro para Empleados de Sign Engineering, LLC (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

- A) General - The Plan was established on September 1, 2022 as a savings plan to provide benefits upon retirement, disability, or death to participating employees. The Plan has adopted the Popular Master Defined Contribution Retirement Plan Master Trust covering all employees of the entity as described below. Popular Master Trust is the Trustee for the Plan. The Plan qualifies under Section 1081 of the Puerto Rico Internal Revenue Code and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by Sign Engineering, LLC (“the Employer”). Other relevant information is as follows:

Plan year	:	December 31
Normal retirement	:	Attainment of age 65
Early retirement	:	Attainment of age 55
Eligibility	:	Employees of Sign Engineering, LLC who have completed three (3) months of service, based on the elapsed time method.
Plan entry dates	:	The first day of each month.

- B) Contributions - The Plan provides for contributions to be made by the employer and by participants, as follows:

- Participant contributions - Participants may make the following contributions to the Plan during the Plan year:
  - Pre-tax contributions – are limited to \$15,000, as provided by Law No. 1 of January 31, 2011.
  - After-tax contributions – may not exceed 10% of the aggregate compensation paid to the employee during all the years he or she has been a Plan Participant
  - Catch-up contributions – are available up to \$1,500 for any eligible employee who attains age fifty (50) by the end of the Plan Year and is making pre-tax contributions in the maximum amount allowed.

**1) Plan Description, Continued**

- Employer matching contributions - The Employer's contribution is discretionary and will be determined each year. For the year ended December 31, 2024, the matching contributions were equal to twenty-five percent (25%) of the first percent (1%) of contributions by the participants on their basic compensation.
  - Participant rollover contributions - Any eligible employee, whether a participant or not, may contribute its assets to the Plan if the contribution is a rollover transferred directly from another qualified plan.
- C) Participant accounts - Individual accounts are maintained for each Plan participant to reflect the participant's and Employer's contributions, as well as the participant's share of the Plan's income and any related expenses. Allocations are based on the participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may not withdraw funds from their accounts until they qualify for benefit payments under the Plan, except for specific circumstances included in the Plan Document.
- D) Investment options - Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds as investment options for participants.
- E) Notes receivable from participants - Participants may borrow from their accounts up to the lesser of \$50,000 or 50% of their vested account balances. The loans are secured by the balance of the participant's account and bear a reasonable rate of interest. This rate is set on December 31 of each year and remains constant throughout the life of the loan. The loan must be repaid over a period not to exceed five (5) years, except if the loan is for the acquisition of the principal residence of the participant. Principal and interest is paid ratably through monthly payroll deductions.
- F) Vesting - Participants are vested immediately in their contributions plus actual earnings thereon. A participant is gradually vested in the employer contributions throughout six (6) years of credited service.
- G) Forfeitures - Represent non-vested portions of contributions of the employer on the day of the participant's death or termination. Forfeited balances can be used to reduce plan related costs and expenses, reduce the amount the employer must contribute to the Plan, and allocate to the participants' accounts. The use will be determined by the employer on an annual basis. As of December 31, 2024, forfeited account amounted to \$85 and is part of the cash and cash equivalents.

- H) Payment of benefits - Upon termination of service due to death, disability, or retirement, a participant or their authorized representative may receive a lump-sum amount equal to the value of the participant's vested benefits. For termination of service for normal retirement age or early retirement, a participant can elect periodical payments. Periods can be monthly, quarterly, semiannual or annual installments of substantially equal amounts over a period of years not to exceed ten (10). Participants shall be allowed to apply for an early distribution of the vested benefits in case of terminating the employment before the retirement age.
- I) Plan Termination - Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**2) Summary of Significant Accounting Policies**

- A) Basis of accounting - The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (US GAAP) in compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosures under the ERISA.
- B) Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- C) Investment valuation and income recognition - The Plan's investments are stated at fair value. Quoted market prices are used to value investments. Mutual funds are valued at net asset value (NAV) of shares held by the Plan at year-end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.
- D) Notes receivable from participants - Are measured at their unpaid principal balance plus any accrued but unpaid interest. As of December 31, 2024, no loans to participants were outstanding.
- E) Excess contributions - Amounts of contributions from highly compensated employees in excess of the Actual Deferral Percentages requirements, plus earnings or losses on such excess, must be distributed to such participants.

2) **Summary of Significant Accounting Policies, Continued**

- F) Contributions - Are recorded following the accrual method of accounting.
- G) Benefits - Benefit payments to participants are recorded upon distribution.
- H) Administrative expenses - Are recorded when incurred and consist of trustee service fees and distribution fees. The trustee service fees are sponsored by the employer.
- I) Fair value measurements - The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The levels of fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**5) Administrative Expenses**

**6) Tax Status**

The Plan constitutes a qualified plan, exempt from income tax under the Puerto Rico Internal Revenue Code of 2011 (PRIRC), as amended. The Puerto Rico Treasury Department has determined and informed the employer in a letter dated January 18, 2023, that the Plan is designed in accordance with applicable sections of the PRIRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination of taxing authorities. The Plan Administrator evaluated the tax positions taken by the Plan and concluded that the Plan as of December 31, 2024, had maintained its tax-exempt status and had taken no uncertain tax positions that would require adjustment or disclosures to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements.
