NOTE A - DESCRIPTION OF PLAN

The following description of Pines of Sarasota Healthcare, LLC 401(k) Plan (formerly known as Pines of Sarasota 401(k) Plan) ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering the employees of Pines of Sarasota, Inc. who meet the Plan's age requirements and are not pooled temporary assistance employees. Effective August 30, 2024, the name of the employer was changed from Pines of Sarasota, Inc. to Pines of Sarasota Healthcare, LLC ("the Company") and as such the name of the Plan changed to Pines of Sarasota Healthcare, LLC 401(k) Plan. The Plan is a defined contribution plan under section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective August 30, 2024, the Plan was amended to reduce the minimum age requirement for eligibility from 21 to 18. Prior to this amendment, employees were eligible upon attaining age 21.

Contributions

Participants may elect to contribute, on a pre-tax basis or post-tax (Roth) basis, up to 85% of their Plan compensation, subject to the annual limitations imposed by the Internal Revenue Code (IRC). Participants who attain age 50 during the Plan year are eligible to make catch-up contributions. Participants may also make rollover contributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into the investment options offered under the Plan.

The Company may make matching contributions at the discretion of its Board of Directors, as provided in the Plan document. For the years ended December 31, 2024 and 2023, the Company made matching contributions equal to 50% of participant contributions up to 6% of eligible compensation. Participants direct the investment of employer matching contributions into the same investment options available for employee contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contribution portion of their accounts is based on years of service as follows:

If a participant dies or becomes disabled, the participant becomes 100% vested.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of 50% of their vested account balance or \$50,000. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Participants are required to make loan repayment arrangements directly with the third-party administrator.

Payment of Benefits

Participants, or their beneficiaries, may receive the vested portion of their Plan account through a distribution of benefits upon retirement, termination of employment, death, disability, or a qualifying withdrawal. Hardship distributions are permitted by the Plan. Effective August 30, 2024, the Plan was amended to allow in-service distributions to be made to a participant who has separated from service and attained age 59½. Benefit payments may be made in the form of a lump-sum distribution, equal installments, partial withdrawals, or a rollover contribution to another qualified plan. If a terminated participant's vested balance is less than \$1,000, the account balance is automatically distributed in the form of a lump sum. If a terminated participant's vested balance is greater than \$1,000 but less than \$5,000, the participant's balance will automatically be distributed in the form of a direct rollover to an individual retirement account.

Prefunded Contributions

Prefunded contributions are contributions received in advance for the subsequent plan year. Prefunded contributions at December 31, 2024 and 2023 were approximately \$15,076 and \$0, respectively. Prefunded contributions are not included in employer and participant contributions on the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

Excess Contributions Payable

Amounts payable to participants in excess of amounts allowed by the Internal Revenue Code are recorded as a liability with a corresponding reduction to contributions. At December 31, 2024 and 2023, the liability for excess contributions payable totaled \$12,087 and \$0, respectively.

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

Forfeited Accounts

Forfeitures arise from non-vested portions of employer contributions forfeited by participants upon termination of employment or from other adjustments, if any. In accordance with the Plan provisions, forfeitures may be used to pay administrative expenses or to reduce future employer contributions. At December 31, 2024, the forfeiture account balance was \$0. At December 31, 2023, the forfeiture account balance was \$1,589. During the years ended December 31, 2024 and 2023, forfeitures of \$9,120 and \$2,891, respectively, were used to fund employer contributions.

Date of Management's Review

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation

Investments are reported at fair value, except for the fully benefit-responsive guaranteed investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

Notes Receivable from Participants (Continued)

If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees for recordkeeping services, trustee services, third-party administration and investment advisory services are included in administrative expenses and allocated to participants based on a pro rata formula. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses.

NOTE C - CERTIFIED FINANCIAL INFORMATION

Certain information related to the investments in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate. The investments, at fair value, and the related investment income, including net appreciation in fair value of investments and dividend income, were certified by VALIC Trust Company Inc., a New Hampshire state-chartered trust company, as complete and accurate. The investment, at contract value, and the related interest income, were certified by The Variable Annuity Life Insurance Company (VALIC) as complete and accurate.

The following information included in the accompanying financial statements and supplemental schedule of assets (held at end of year) was obtained from data that has been prepared and certified to as complete and accurate by the trustees.

NOTE D - FAIR VALUE MEASUREMENTS

The *Fair Value Measurements* topic of the Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC)* establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds (and money market fund):* Valued at the daily closing price as reported by the fund. Mutual funds and the money market fund held by the Plan are open-ended and are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds and money market fund held by the Plan are deemed to be actively traded.

NOTE E - GUARANTEED INVESTMENT CONTRACT

The Plan has a fully benefit-responsive guaranteed investment contract with Variable Annuity Life Insurance Company (VALIC). VALIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

NOTE E - GUARANTEED INVESTMENT CONTRACT (CONTINUED)

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$583,401 and \$533,385, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%. Such interest rates are reset on an annual basis. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Plan investments are managed by VALIC Trust Company Inc. and The Variable Annuity Life Insurance Company (VALIC), which operate as part of Corebridge Financial. These entities serve as trustees and certifying institutions for the Plan. Corebridge Financial Retirement Services is the third-party administrator and recordkeeper for the Plan. Fees paid to Corebridge Financial (through VALIC and its affiliates) are included in administrative expenses and qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Notes receivable from participants and related interest income are also considered party-in-interest transactions, which are exempt from the prohibited transaction rules.

NOTE G - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

NOTE H - TAX STATUS

The Plan has adopted a non-standardized 401(k) profit sharing plan. The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE I - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE J - RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500
