Capital Accumulation Plan and Trust (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## **Note 1. Description of the Plan**

### ***General***

The following description of Trinity Consultants, Inc. Capital Accumulation Plan and Trust (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Trinity Consultants, Inc. (Company) for the benefit of eligible employees of the Company. All employees of the Company who have completed one month of service are eligible to participate on the first day of the subsequent month. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Fidelity Management Trust Company (Fidelity) is the trustee of the Plan.

### ***Contributions***

Eligible employees can contribute up to 80% of their eligible compensation as defined by the Plan and have the ability to designate their contributions as either a standard 401(k) or Roth 401(k) contribution. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Company may contribute a discretionary matching contribution to active participants employed by the Company as of the last day of the plan year. For the years ended December 31, 2024 and 2023, the Company elected to match 50% of employee contributions on the first 6% of each active participant's eligible compensation. Contributions are subject to certain limitations.

### ***Participant Investment Account Options***

Each participant has the option of directing their contributions into any of the separate investment accounts and may change the allocation daily.

The plan document also includes an automatic deferral feature, whereby a participant is treated as electing to defer 6% of eligible compensation unless the participant made an affirmative election otherwise. Investments are directed to Fidelity Retirement Money Market Portfolio unless redirected by the employee. Newly hired employees have 30 days to elect out of automatic enrollment.

### ***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's contribution, and plan earnings/losses and is charged with an allocation of related administrative expenses. Allocations are based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service.

***Payment of Benefits***

Upon termination of service due to death, disability, or retirement, a participant (or participant's beneficiary in the case of death) may elect to receive either a lump-sum distribution in the amount equal to the value of the participant's vested interest in their account or annual installments over varying periods. For termination of service for other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution or rollover vested contributions, without penalty, to a qualified individual retirement account (IRA) or another qualified plan. Additionally, employees may withdraw vested contributions if the employee incurs a financial hardship as defined by the plan document. Hardship distributions are subject to a 10% penalty tax if received before age 59½. Accounts of terminated or retired participants who have elected to separate from the Plan but whose funds have not yet been distributed are not material.

***Notes Receivable From Participants***

The plan document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant demonstrating a qualifying need. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined by the plan administrator.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts balance totaled approximately \$233,000 and \$290,000, respectively. These accounts will be used to reduce future employer contributions. Employer contributions were reduced by \$284,019 and \$195,624 from forfeited nonvested accounts for the years ended December 31, 2024 and 2023, respectively.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds, the money market fund, and brokerage link option are valued at the net asset value (NAV) of shares held by the Plan at year-end. The Plan's interest in the common collective trust is valued at fair value at the NAV per shares utilizing the practical expedient. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable From Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Certification of Plan Trustee**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable from participants as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

**Note 4. Disclosures About Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and significant to the fair value of the assets or liabilities

If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

**Note 5. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provided services to the Plan, an employer whose employees are covered by the Plan, and employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Company provides certain administrative services at no cost to the Plan. Certain plan investments are shares of mutual funds managed by Fidelity, the trustee as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments.

**Note 6. Plan Amendments**

Effective April 29, 2024, the Plan was amended to modify the definition of the eligible class of employees. The Plan expanded eligibility to include employees covered by a collective bargaining agreement who meet the Plan's age and service requirements. This change did not have a material effect on the Plan's financial statements.

In addition, effective August 1, 2024, Environmental Compliance & Safety, Inc., Soundview Consultants, and Westland were added as participating employers under the Plan. The amendment allows eligible employees of these entities to participate in the Plan. An aggregate of \$61,181 was rolled into the Plan during the year ended December 31, 2024 and is included in Transfer to Plan on the accompanying statements of changes in net assets available for benefits.

**Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**Note 8. Tax Status**

The Plan operates under a standardized adoption agreement in connection with a prototype 401(k) profit-sharing plan and trust document sponsored by FMR LLC. This prototype plan document has been filed with the

appropriate agency and has obtained a determination letter from the IRS stating that the prototype constitutes a qualified plan under section 401 of the Internal Revenue Code and that the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 10. Risks and Uncertainties**

The Plan provides for various investments options in investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amount reported in the accompanying statements of net assets available for benefits and statements of changes in net assets available for benefits.

**Note 11. Nonexempt Transactions**

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month

following the month in which the participant contributions are withheld by the employer. While the Company remitted all employee contributions to the Plan, contributions of \$57,804 were not remitted within the required time period for the year ended December 31, 2023.

**Note 12. Subsequent Events**

Effective February 15, 2025, Safety Partners, LLC was added as a participating employer, and service credit provisions were updated to include employees impacted by the acquisition of Jaffe Holden Acoustics, Inc. On April 10, 2025, the Plan was amended to allow participants to make voluntary, nondeductible, after-tax employee contributions up to 15% of compensation. Predecessor employer service was further expanded on July 17, 2025 to include Bridgewater Group, Inc. and Zanjero, Inc. for employees impacted by 2025 acquisitions and on October 13, 2025 to include Benchmark Risk Group LLC. Additionally, GeoSystems Analysis Inc. was added as a participating employer effective September 26, 2025, expanding the employer list. These amendments were primarily administrative in nature, expanding the list of participating and predecessor employers, updating service credit provisions for employees impacted by acquisitions, and clarifying after-tax contribution limits and vesting for certain acquired employees. No material changes to plan provisions, participant rights, or benefits resulted from these amendments.

Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.
